oil and gas industry. Mr Idris Olubola Musa was born on September 17, 1957 in Yagba East Local Government Area of Kogi State of Nigeria. He holds a Bachelor of Science, B.Sc. in Geography from the Prestigious University of Ibadan. He also holds two Masters Degrees in Business Administration, MBA as well as Urban and Regional Planning, M.URP from the University of Ilorin and University of Ibadan respectively, as well as several Professional Certifications and Memberships locally and internationally.

He has about 40 years experience in different capacities in both the private and public sectors. He started his career in 1980 as Executive Director, Operations and Accounts in Oluyori Bottling Industry Nigeria Ltd., Isanlu where he later moved to Virgven Nigeria Ltd., Ilorin as Executive Director, Management Consultancy

In 1996, he joined the public service as Environmental Scientist in the defunct Federal Environmental Protection Agency, FEPA and later to Federal Ministry of Environment where he was deployed in 2004 as one of the pioneer staff to head the Oil Spill Detection and Response,

OSDR Department of the then newly established National Oil Spill Detection and Response Agency, NOSDRA. He was promoted to the level of Director in 2008 in NOSDRA and Director Oil Field Assessment in 2011 following departmental restructuring in NOSDRA.

Mr. Musa retired from this position in NOSDRA in September, 2017. Being a vibrant and energetic personality, he was appointed as Head of Operations of the Hydrocarbon Pollution Remediation Project (HYPREP), Port Harcourt in the same year. He was appointed Director General/Chief Executive of the National Oil Spill Detection and Response Agency (NOSDRA) in March, 2019 by the President, Federal Republic of Nigeria, President Muhammadu Buhari (GCFR).

He served in several committees amongst which is the Committee that worked on the preparation of documents leading to the establishment of NOSDRA. Mr Musa has an uncommon wealth of experience in oil spill management.

He also worked on several projects and researches leading to several developmental achievements in Nigeria which are quite numerous to mention here. He has attended several international trainings, seminars and workshops. He represents Nigeria on the Ten-Man Board of Pollution Crime Working Group of the International Police, INTERPOL.

As DG, Mr Musa said "I will prioritise underground water pollution, and ensure timely, effective and appropriate response to oil spills".

National Oil Spill Detection and Response Agency, NOSDRA is an agency under the Federal Ministry of Environment. It was instituted by the National Assembly act of 2006 with the core mandate to oversee the implementation of the National Oil Spill Contingency Plan, NOSCP which also incorporate the National Oil Spill Contingency System, NOSCS for Nigeria.

Since its establishment, Agency has been ensuring compliance with environmental legislation in the Nigerian Petroleum Sector. The agency has focused on building conformance with environment legislation in the Nigerian petroleum sector from inception.

NOSDRA is the lead agency for other oil spill contingency plans in Nigeria, including the ports and industries.

Ebonyi Guber: Tribunal dismisses APGA's petition, seeking to sack Gov Nwifuru

Ebonyi Election The State Petition tribunal sitting in Abuja, on.Wednesday delivered judgement on Petition No EPT/ EB/GOV/01/2023 [BENARD ODO & APGA Vs INEC, FRANCIS OGBONNA NWIFURU & APC) in favour of Governor Francis Ogbonna Nwifuru of Ebonyi State.

The Tribunal held that the petition bordered on a pre-election matter over which it lacked jurisdiction to

It proceeded nevertheless to determine the petition on merit and dismissed the same for lacking in

The Tribunal also held that it is not within the contemplation of the Constitution that the failure of the 2nd Respondent to vacate his seat as Speaker of Ebonyi State House of Assembly after defecting from the PDP to the APC should operate as a bar to his contesting election on the APC platform for the governorship of Ebonyi State.

According to the tribunal, the petitioners failed to prove that the 2nd Respondent was at the time of the election not qualified to contest the Governorship Election, hence there is substantial material evidence before the Tribunal, which shows that the 2nd Respondent duly resigned his membership of the Peoples Democratic Party (PDP).

The summary of the Court ruling indicated that "The petitioners failed to approach the proper court to entertain the issue of membership of

a political party.

"Notwithstanding, the Tribunal has no power to entertain an issue which took place before the election. However, apart from an aspirant who participated in the primaries of the 3rd Respondent, no other person has the right to challenge the membership of the 2nd Respondent.
"No court has the power to

dabble or poke into the internal domestic affairs of a political party. (No PDP membership Register of Enyanwuigwe ward was tendered before the Tribunal to substantiate that the 2nd Respondent is a member

of PDP).

"The claim of the petitioners that the 2nd Respondent's APC Form is forgery holds no water as same was not supported by any evidence from the petitioners.

"Where a party forwarded name of a candidate to INEC it means that such a candidate is a fully-fledged member of such a political party. Exhibit R5 which is the votes and proceedings of Ebonyi State House of Assembly clearly disclosed the date the 2nd Respondent defected PDP to APC.

"It is not for the Tribunal to invoke section 109 of the 1999 constitution as amended against the 2nd Respondent, But that of the members of Ebonyi State House of Assembly.

Strengthen data collection mechanisms, education on migration, UMEG tells

Universal Migration Enlightenment Centre, UMEC, has said the Nigerian government should invest in strengthening data collection mechanisms and encourage research institutions to contribute towards a robust knowledge base on migration.

UMEC, in partnership with the Global Migration Research Institute, GMRI, USA gave this advice at one -day National Workshop on Migration issues

in Abuja on Tuesday.

Speaking at the workshop, the President of UMEC,Dr. Williams Ijoma said migration remains a pressing concern in Nigeria that requires intensified efforts to address it

While emphasising on the need for comprehensive data collection and analysis, Dr. Ijoma explained that, "Accurate and up-to-date data is essential to understand the patterns, causes, and consequences of migration. It will enable us

to develop evidence-based policies and programs that can effectively manage migration flows, protect vulnerable individuals, and allocate resources appropriately."

The President also stressed the need to prioritise implementation enforcement of existing policies.

"We ought to prioritize implementation and enforcement of existing policies and laws.

"While the Nigerian government has formulated several policies related to migration, their effectiveness relies heavily on their implementation. Concrete steps need to be taken to ensure that these policies are effectively enforced at all levels, leaving no room for gaps or weaknesses. This includes collaborating with relevant agencies to combat human trafficking and irregular migration while providing support and protection to victims," he said.

Air Force bombs IPOB hideouts in Anambra, Imo

Nigerian Air Force fighter jets under the air component of Operation Udo Ka II, have bombed the armouries and camps of the proscribed Indigenous People of Biafra (IPOB) in Anambra and neighbouring and Imo state.

The fighter jets according to a statement by NAF spokesman, Air Commodore Edward Gabkwet, carried out several airstrikes on the IPOB fighters hideouts in Mother Valley Orsumoghu in Nnewi South Local Government Area of Anambra State and at Aku Ihube in Okigwe LGA of Imo State.

Gabkwet noted in the statement that the air operations were conducted following credible intelligence report that the fighters had finalised plans to unleash mayhem on the residents and

other states in the region.

He, however, said that some of the bombed locations were fingered to be the armouries of the separatist movement.

Part of the statement reads, "Aircraft under the Air Component of Operation Udo Ka II, on Tuesday, September 26, 2023, carried out several strikes on IPOB/ESN locations at Mother Valley Orsumughu in Nnewi South Local Government Area of Anambra State and at Aku Ihube in Okigwe Local Government Area of Imo State. The strikes at both locations achieved their intended outcome and were deemed effective.

"Acting on credible intelligence that IPOB/ ESN terrorists had perfected plans to disrupt civic activities lined up in the coming days in Anambra State and other states in Southeast Nigeria from their concealed bunkers/hideouts at Mother Valley Orsumughu, air strikes were authorised in conjunction with ground troops and other security agencies on the location believed to also house some of their weapons and ammunitions. The strikes hit the target and were deemed successful following the ball of fire, fleeing terrorists at the location as well as feedback received. "

He said, "We called your attention to what we heard or information at our disposal just a few days ago, we received information that over 17,000 workers in the core civil service PAs, SAs and some Ministers did not carry out the online verification which was done by the office of the Head of Service of the Federation."

Election Tribunal sacks Ondo lawmaker

An Election Petitions Tribunal sitting in Akure the Ondo state capital has nullified the election of a member of the Ondo State House of Assembly representing Ileoluji/Okeigbo Constituency, Hon. Nelson Akinsuroju of the All Progressives Congress, APC. The Tribunal subsequently ordered

rerun election in six, out of the 27 polling units being challenged by the PDP candidate of the entire 191 polling units in the Constituency, declaring that the March 18 2023 Ile-Oluji/Okeigbo Constituency election inconclusive.

The Tribunal ruled on a petition filed by the People's Democratic Party, PDP, Candidate, Babatunde Fadare against the election of Akinsuroju, which has created a state of uncertainty in the camp of the sacked lawmaker.

The lawmaker was announced winner by INEC, after polling a total number of 10,207 votes, to beat the PDP candidate who polled 9,287 votes.

The petitioner urged the court to declare the election inconclusive and order INEC to conduct supplementary election in the 6 affected units where election was disrupted.

The petitioner also joined INEC and

APC as respondents in the petition.

The three-man panel led by the Chairman, Rose Soji, has ordered for a rerun in 6 affected polling units in Ile-Oluji/Okeigbo local government area of Ondo State.

Reacting, counsel to Akinsuroju, Remi Olatubora, SAN, represented by Barrister Olumide Ogidan alleged that the judgement was one sided as it was based on morality of the case and not competence of the results, saying the decision would be challenge at the appeal court.

retarding their development.

As condemnations continue to trail the decision of the Enugu state Governorship Election Tribuna to affirm the election of Mr. Peter Mbah as the duly elected governor of the state, Barrister Chukwudi Igwe has insisted that facts of the matter were ignored by the judges who handled the case.

In a statement issued on Wednesday titled "Review of the judgement in Edeoga Chijioke Jonathan Vs INEC & 2 others, Barrister Igwe said the judges were wrong in the area of competence of the subpoenaed witnesses.

He said the Tribunal was wrong in holding that the evidence of the PW 1, PW 2, PW3 & PW 30 were incompetent on the ground that they were testimonies of subpoenaed witnesses who did not file their witness statements on oath alongside the petition and that the Tribunal relied basically on Paragraph 4 (5) of the 1st Schedule to the Evidence Act and the case of Obi vs APC & 2 Ors in invalidating the testimonies of the said

According to him, the said paragraph 4 (5) provides, "The Election petition shall be accompanied by- a) a list of the witnesses that the petitioner intends to call in proof of the petition; b) written statement of oath of the witnesses and c) copies or list of every document to be relied on at the hearing of the petition".

"It is important to note that this Paragraph 4 (5) of the 1st Schedule to the Evidence Act is basically drawn from Order 3 Rule 3 (1) of the Civil Procedure Rules of the Federal High Court.

'It is instructive to note that the Electoral Act specifically provided in Paragraph 54 of the 1st Schedule to the Electoral Act thus, "Subject to the express provisions of this Act, the practice and procedure of the Tribunal or the court in relation to an election petition shall be as nearly as possible, similar to practice and procedure of the Federal High Court in the exercise of its civil jurisdiction, and the Civil Procedure Rules shall apply with such modifications as may be necessary to render them applicable having regard to the provisions of this Act, as if the petitioner and respondent were respectively the plaintiff and defendant in an ordinary civil action.

'Order 3 Rule 3 (1) of the Civil Procedure Rules of the Federal High Court and Paragraph 4 (5) of the 1st Schedule to the Evidence Act are in all fours to serve the same purpose. Paragraph 4 (5) of the 1st Schedule to the Evidence Act relied by the Tribunal did not contain the provision in Order 3 Rule 3 (2) of the Civil Procedure Rules of

the Federal High Court. The said proviso in Order 3 Rule 3 (2) of the Civil Procedure Rules of the Federal High Court reads, "Where a statement on oath of the witness requires a subpoena from the court, it need not be filed at the commencement of the suit.

'The Order 3 Rule 3 (2) of the Civil Procedure Rules of the Federal High Court identifies the impossibility of filing a statement on Oath of a subpoenaed witness as at the time of filing the suit. My lordships that handed us the Federal High Court Civil Procedure Rules, in their wisdom are also aware of the impossibility of directing that subpoena witnesses should file their statement on oath alongside the suit. See the case of Abba Kabir Yusuf vs APC 72 Ors-Appeal No CA/KN/GOV/ KAN/O5/2023 where the Court of Appeal held that it will be impossible for a party to file a written Statement on Oath of a subpoenaed witness as at the time of filing the petition. The said decision of the court gives credence to the wisdom in Order 3 Rule 3 (2) of the Civil Procedure Rules of the Federal High Court.

"It is my view that the witness statement of a subpoenaed witness filed after the suit has been filed, which facts are in line with the pleadings does not amount to amendment or invitation of new issues and therefore competent. The Tribunal, in the petition under review relied on the case of Obi &; Anor vs APC &; 2 Ors to nullify the evidence of the subpoenaed witnesses of the petitioners.

"It is instructive to note that the Presidential Petition Tribunal in Obi & Anor vs APC & 2 Ors nullified the testimony of the subpoenaed witnesses on the ground that the said witnesses were served the subpoena personally and that their reports were ready before the petition was filed hence they were members of the Labour Party who ought to have filed their statement on oath within time-See pages 80-97 of the said judgment.

The subpoenaed witnesses of the Petitioners in the case under review were witnesses which the petitioners cannot ordinarily summon to testify in court hence the need to file a subpoena after the filing

"No government official or a person working under an authority would reasonably be expected to appear in court to divulge sensitive information to the court without being compelled to do so by

The only effective way to compel a government official or private employee to give vital information to the court in order to meet the justice of a case is to have such official subpoenaed by the court and this can only be done when the suit has already been filed.

"A party who intends to call an unwilling person

that he has no control over to testify in court cannot be expected to forcefully drag him to court to file witness statement except with the order of the court through subpoena. The law does not command the impossibility.

'The Supreme Court case of Oke v Mimiko relied on by the Presidential Petition Tribunal in the case of Obi vs APC 7 Ors has nothing to do with subpoenaed witness statement on oath filed after the filing of the petition. The said case primarily dealt with the issue of filing motion for leave to file additional witness statement on oath out of time. The Supreme Court held in that case that such leave to file additional witness statement on oath out of time will delay the course of justice since the petition is expected to be concluded within 180 days.

"In the case under review, the Petitioners made it clear that they will call witnesses by subpoena. It did not take the Respondents by surprise and was not intended to waste the time of the court.

"It is therefore my opinion that the subpoenaed witnesses and their testimonies in the case under review are valid which the court should have acted upon", he said.

On the issue of qualification of the second respondent to contest for the election he said the Tribunal, in holding that the 2nd Respondent is not disqualified to contest the election relied on the issue that the issue of forgery was not proved hence the evidence of PW 1, PW 2, PW 3 and PW 20 who were subpoenaed witnesses were discountenanced.

'That NYSC Certificate of the 2nd Respondent was merely attached to Form EC 9 without making reference of same in the affidavit and also not submitted to aid of his qualification.

"It is my view that the forgery of the NYSC Certificate was proved by the said subpoenaed witnesses and who are, in my view competent

The forged NYSC Certificate of the 2nd Respondent was submitted to INEC in clear violation of section 182(1)(j) of the 1999 constitution hence the 2nd Respondent stands not qualified to contest the said election.

'The Tribunal was wrong when it held that section 177 and 182 of the constitution shall be read

"It is a fact that the case of the Petitioners is on the non-qualification of the 2nd Respondent, having submitted forged certificate to INEC.

"The Evidence Act in Section 134 (3) also makes it a separate ground to disqualify a candidate of an election on the ground of submission of forged certificate. The said section provides, "With respect to subsection (1) (a), a person is deemed to be

qualified for an elective office and his election shall not be questioned on grounds of qualification if, with respect to the particular election in question, he meets the applicable requirements of sections 65, 106, 131 or 177 of the constitution and he is not, as may be applicable, in breach of section 66, 107, 137 or 182 of the constitution.

"Flowing from the above section of the Electoral Act, it is obvious that the said section 182 of the constitution shall be treated separately from section 177 of said constitution.

"The Tribunal also held that NYSC Certificate is not a requirement for qualification under the section 177 and 318 of the constitution therefore the 2nd Respondent cannot be disqualified having gone above the threshold of academic qualification. The Tribunal held that the mandatory academic qualification is school certificate hence the 2nd Respondent did not submit the said certificate in issue to aid his qualification.

"It is my view that the 2nd Respondent submitted the said NYSC Certificate for INEC and the General Public to act on it. INEC is not a dumping ground where NYSC Certificates are dumped for pleasure. The provision of section 182 of the constitution is clear- Any person who submits a forged certificate shall be disqualified. It is in evidence that the 2nd Respondent submitted a forged certificate to INEC. It does not matter if the said certificate is school certificate or not.

'The Court of Appeal in the case of Isa Mohammed Wabu &; Anor vs Hon. Mohammed Garba Gololo in 2019 disqualified a candidate to an election on the ground of forgery of B. Sc Certificate, Masters Certificate and NYSC Certificate.

"The court did not consider that the said certificates do not fall within the qualification threshold in sections 177 and 318 of the constitution which is school certificate. The said B. Sc Certificate, Masters Certificate and NYSC Certificate upon which the Court of Appeal disqualified the candidate is not school certificate as defined in section 318 of the constitution.

"It is on our judicial record that the court of Appeal has before now disqualified a candidate on the ground of forgery of NYSC Certificate. See the

"It is my view that the 2nd Respondent stands disqualified for the said election under review", he

Speaking on the nullification of the election in affected polling unites where over voting occurred, Barrister Igwe said "it is my view that the court was in error when it discountenanced the evidence of the witnesses who testified on over voting in Nkanu East and Igbo Eze North LGA."

'The Tribunal, in discountenancing the evidence relied on the fact that the witnesses were not INEC Accredited Agents of the Petitioners hence did not sign the Result sheets.

"It is in evidence that the said witnesses were at the affected polling units during the election. It is also in evidence that they tendered BVAS Reports and Result sheets showing over voting. The Tribunal acted in error when it refused to act of the evidence on the reason that the said witnesses did not sign the result sheets.

"Section 137 of the Electoral Act provides, "It shall not be necessary for a party who alleges noncompliance with the provisions of this Act for the conduct of the elections to call oral evidence if originals or certified true copies manifestly disclose the non-compliance alleged".

"It is worthy of note that the Petitioners relied on the Results and the CTC of the BVAS Reports of competent witnesses who were eye witnesses to the

"There is no law in our legal jurisprudence that competently testify and tender documents as to what he saw on ground.

"You don't need to be appointed by INEC to act are at the discretion of the political party concerned.

"The entire judgment was founded in error of law and facts", he declared.

Over 2,000 to benefit from Afikpo medical doctors' free medical outreach

The Conference of Afikpo Medical and Dental Doctors (CAMD), Wednesday kicked off its 4-day medical outreach in Afikpo and disclosed its target to treat at least 2,000 patients for free during the programme.

The free medical outreach

held at the Mater Misericordiae Hospital, Afikpo Government Area of Ebonyi State was packaged by CAMD to provide health education, screening, consultation, and surgeries among other medical interventions.

The CAMD Chairman, Dr Uduma Victor Uduma, who

stated this in an interview with journalists, said, the body would provide a free eye surgical intervention, distribute over 500 reading glasses, and conduct some general surgeries including gynecological surgeries during the health outreach.

His words: "We bring this intervention to the Afikpo community, and looking at the crowd here, you can see that we have a lot of diseases that submerge this community. But with intervention like this, people will easily come for health treatment assistance. The most important objective of this health outreach is, to provide medical consultation, to at least

more than 2,000 persons. We want to provide free eye surgical intervention including cataract surgery.

"We want to see whether we can distribute more than 500 reading glasses which are already available with us here. And also do some general surgeries like the removal of lumps, and hernia fluid and other surgeries including gynecological surgeries.

Uduma further explained that the outreach was carried out by the CAMD members to impact their community positively; noting that in the course of preparation for the event, some persons and groups encouraged the organisation, financially,

morally and even spiritually.

"We have been running outreaches, but this is the first edition of the large-scale outreach, which was solely organised by the Conference of Afikpo Medical and Dental Doctors, and largely sponsored by the members with the sponsorship of other partners and illustrious sons of Afikpo, like Afikpo USA organisation. We have carried out a similar free medical outreach to Amasiri, Akpoha, Ozizza and other parts of Afikpo. Sometime, this year, we do glaucoma training, in collaboration with Dr Ginger Eke, and also do other forms of health interventions," he added.

Ganduje bombs Kwakwanso, says he'll remain serial loser in elections

National chairman of the All Progressives governing Congress, APC, Dr. Abdullahi Ganduje, Wednesday took a swipe at his political rival from Kano State and former presidential candidate of the New Nigeria Peoples Party, NNPP, Rabiu Kwankwaso saying he would remain a serial loser at presidential elections.

Receiving Jika with the entire NNPP structure in Bauchi state, Ganduje said: "When I got the news that you were coming to see me in my house

to discuss the way forward, I knew I was meeting a very formidable politician in the person of Senator Jika who is a household name in Bauchi

"He is returning to a party that is very progressive and focused when we look at where he was coming from. He is coming from a party that used to be a decent party and highly respected but was later hijacked and polluted by the kwankwasiya group

Legal expert, Professor Paul Ananaba, has cautioned against any hasty conclusion in condemning or accepting the Lagos State Election Petition Tribunal judgment which upheld the election of Governor Babajide Sanwo-

The legal luminary and an Adjunct Professor at the Adventist University of Africa Kenya School of Post Graduate said judgement of any kind is reached based on the available facts and evidences before the judges, however, noting that he hadn't seen the copy of the judgement to make a final submission on that.

"Cases are decided based on the evidence before the court but I think the window is now opened to Rhodes Vivour to go to the appellate court if he is not

satisfied. "Tribunals are either right or wrong in their judgements but I have not seen the Certified True Copy of the judgement so I cannot say categorically whether they are right or wrong.

"But it will be risky to jump into conclusion to say they are wrong or right because certain interpretations in law may not exactly be as they are in the layman's eyes so if the candidate of the Labour Party is not satisfied with the judgement, he should approach the court; it is fully within his right to do so," he

It would be recalled that the Lagos State Governorship Election Tribunal struck out the Labour Party and its candidate, Gbadebo Rhodes-Vivour, from the petition of his Peoples Democratic Party (PDP) counterpart, Olajide Adediran popularly knówn as Jandor, against the recent governorship election.

Jandor is challenging the return of Babajide SanwoOlu Obafemi Hamzat the March 18 governorship election in Lagos State.

Shortly after announcement of appearances by all lawyers and parties in the case at Monday's proceeding, chairman of the tribunal, Justice Arum Ashom, announced that the court would first deliver judgment in the case of the PDP & its candidate before giving its judgment in the petition of the governorship candidate of the Labour Party, Gbadebo Rhodes-Vivour.

Twitter's rebrand: Why 'x' could be the most powerful letter in English



As letters of the alphabet go, there is one that punches well above its weight. Out of a total of 308,000 entries in the Oxford English Dictionary, just 366 words begin with the letter "x", and very few of those make it into most people's vocabulary. Yet despite this aloofness – or perhaps because of it – x is perhaps the most powerful and alluring letter we have

X-Files, X-Factor, X-Men, Generation X, X-rays, X-rated, Planet X... the letter is embraced in popular culture and by brands as shorthand for something unknown, futuristic or provocative. Its shape can signify everything from love (the kisses we use to sign off our emails and texts), to absence, prohibition and even death (as with the skull and crossbone). It's impressive for a letter that Dr Samuel Johnson described in 1755's Dictionary of the English Language as: "a letter which though found in Saxon words, begins no word in the English language."

This week, the 24th letter of the alphabet was thrust into the spotlight once again, as Elon Musk announced an abrupt rebrand of Twitter – the social media company he bought in October 2022 for \$44bn. The site's iconic blue bird logo is no more, replaced by a black letter X, part of Musk's long-term plan to be a "platform that can deliver, well... everything."

Musk says he chose x because it "embod[ies] the imperfections in us all that make us unique". His fascination with it dates back over two decades, first evident in 1999 when he named his online banking service X.com, before it later evolved into PayPal. He bought the web domain back in 2017, claiming it had "great sentimental value." He named an early Tesla car Model X, and his space exploration programme SpaceX. In 2020, Musk had a son with the musician Grimes, and the couple named him X Æ A-12 Musk.

The tech industry seems to have a particular fondness for the letter. Besides

Musk's X, there's Microsoft's gaming console Xbox, Sony's Xperia smartphone, Apple's iPhone X and operating system OS X. In 2010, Google chose the letter for the name of its secret idea-testing laboratory, first known as Google X and now simply X – its self-described "moonshot factory" for technologies that it claims will "improve the lives of million, even billions, of people". There are reports that Meta – the Mark Zuckerberg-controlled parent company of Facebook, Instagram and Threads – has already trademarked an X logo for social media use, meaning there could be a trademark war ahead.

So why are the tech titans tussling it out for this one single letter, when there are 25 others they could draw on instead? Tony Thorne, Director of the Slang and New Language Archive at King's College, London, sees it as an attempt to appear enigmatic, by invoking various vague scientific terms like exponential, experiential and experimental. "X is the only letter of the alphabet to not feature in many everyday words, but to also appear in multiple mathematical and technical contexts which baffle and intrigue most of us techno-illiterates," he tells BBC Culture. There's the implication of something important, unknowable and exciting – a symbol of possibility. For Thorne, though, its overuse is beginning to backfire. "Now it's approaching a cliché."

Part of the power of x is that it isn't just a letter, it's a symbol: one that humans have been making for millennia. "It's such a primal designation act, x," says Drucker. "In the earliest sign systems that humans make, crosses and circles are so fundamental because they're so easy to make. We've got stones from France from 20,000 years ago that have crosses and circles on them." From the Middle Ages, those who were illiterate used X as a signature.

The letter X has had a somewhat muddled history, perhaps contributing to its malleable meanings. It originally

derives from a Phoenician letter called samekh, meaning fish, which was used to represent the sound "s". "The Greeks borrowed it, called it 'Chi', used it for the 'kh' sound and wrote it as a diagonal cross," explains Thorne. The Romans later adopted the x sound from the Chalcidian alphabet, a Western variant of the Greek alphabet, and combined it with the Chi (x) symbol and x as we know it today was born. It's also one of seven letters used in the Roman numerical system.

The letter's air of mystery came relatively late. "Part of the mystique of x comes from algebra, where it stands for the unknown that has to be solved," says Drucker. "That comes with the whole rational, mathematical enlightenment." In the 17th Century, Descartes designated the letters x, y and z to represent unknowns (with a, b and c as knowns). Out of these three letters, it is x that has emerged as the dominant symbol of mystery, conjuring the strange, the alien, the exotic.

When German physicist Wilhelm Röntgen discovered a new kind of radiation in 1895, he called it an X-ray because its nature was unknown. To have the X-factor is to possess some intangible star quality. In sci-fi, x comes to represent something otherworldly, extraterrestrial. This ambiguity isn't always positive. Think pieces on Generation X – those born between 1965 and 1980 – often described them as a lost, aimless generation.

The letter can also signify an absence or an erasure. The X in civil rights activist Malcolm X's name stood for his unknown African name, taken from his ancestors during slavery. The Straight Edge punk movement – who abstain from alcohol, tobacco and drugs – use X as their identifier. Yet, at other times x symbolises a presence – x marks the spot; the x used to mark our choice on a ballot paper. It is a letter full of contradictions.

It also has a whiff of sexual danger. John Singer Sargent's provocative painting Madame X, depicting an American woman known for her extra-marital affairs, scandalised late 19th-Century Paris. In 1951, the British Board of Film Censors introduced the X certificate to indicate a film was "extremely graphic." Though this originally referred to violence and bad language as well as sex, "X-rated" was co-opted by the porn industry and is now shorthand for sexually explicit material.

Its association with the extreme seems ant for Flon Musk who when he first

Its association with the extreme seems apt for Elon Musk who, when he first bought Twitter, asked staff to commit to an "extremely hardcore" working culture.

The letter x doesn't just have multiple meanings, but multiple pronunciations too – not ideal when you make it the centrepiece of your huge global brand. There's confusion on what it might be called in Japan, where the term X Japan is already trademarked by a rock band.

is already trademarked by a rock band. It's assumed Musk wants his X to be something akin to China's WeChat, an app where users can communicate, consume news, make purchases, pay bills and even order a taxi. For an app that will offer such disparate services, it perhaps makes sense to use a symbol with so many meanings.

many meanings.

But the rebrand has got off to a bumpy and confusing start. Police arrived midway through the removal of the twitter sign from the company's San Francisco headquarters, putting a halt to the "unauthorised work" and leaving just "er" hanging on the building. There is uncertainty about how we will talk about X, too. Will tweets now be Xs? The word "tweet" made it into the dictionary as a verb – what will the equivalent be?

"Because of its multiple potential, sometimes contradictory meanings, the X symbol at first sight will certainly strike many as mysterious, puzzling, perhaps intriguing, but should a brand be provoking uncertainty or confusion?" asks Thorne. The future of Musk's X project is yet to be seen – but harnessing the power of this most beguiling and shape-shifting of letters might prove too much, even for the world's richest man.





Brighton boss Roberto de Zerbi is on the radar of Real Madrid president Florentino Perez.

Real coach Carlo Ancelotti's contract runs to the end of the season and he is expected to leave - no matter how the season concludes - for the Brazil job.

Radio Marca says Real Madrid are focusing on Xabi Alonso, of Bayer Leverkusen, for next season.

But Cadena SER now states that while Alonso is a hot candidate, De Zerbi is also on Real Madrid's wish list.

The Italian coach has Brighton inside the top four and competing in the Europa League for the first time.

De Zerbi has a contract until the summer of 2026.

Russia to compete in European U17 Championships- UEFA

For the first time since its invasion of Ukraine 19 months ago, Russia will be allowed to compete in the European U17 championships.

UEFA banned any Russian teams from taking part in any European football competitions after Russia started its invasion of Ukraine in February

Additionally, it cancelled the sponsorship agreement with Russian energy firm Gazprom, and revoked the hosting rights for the 2022 Champions League final and 2023 Super Cup, which were scheduled to be held in Saint Petersburg and Kazan, respectively.

However, UEFA is making room for Russian male and female teams to reenter Under-17 events even if they have started already.

Additionally, it was said that neither team would be allowed to hoist their flag, sing their national anthem, and play European games in Russia.

In 2024, Cyprus is slated to host the finals of the forthcoming Under-17 male

European Championship. The women's equivalent will be held in Sweden in May of 2024. Based on the new development, Russian under-17 teams are likely to participate in those events.

The other Russian teams are still suspended, according to UEFA, which has reiterated its condemnation of Russia's invasion of Ukraine.

"Uefa's continuing suspension against Russian adult teams reflects its commitment to take a stand against violence and aggression. Uefa is determined that this position will continue until the war is over and peace restored," UEFA's president Aleksander Ceferin said.

"But by banning children from our competitions, we do not only fail to recognize and uphold a fundamental right for their holistic development but we directly discriminate against them.

"By providing opportunities to play and compete with their peers from all over Europe, we are investing in what we hope will be a brighter and more capable future generation and a better tomorrow."

Manufacturers lament N272bn unsold goods in Q1

CONSUMERS' low purchasing power occasioned by the surging inflation rate in Nigeria is making many products unaffordable as manufacturers' inventory of unsold finished goods rose by 45.4 per cent in one year, according to the Manufacturers Association of Nigeria (MAN).

Inventory of unsold products in the manufacturing sector rose to N272 billion in the first half of 2023 from N187.1 billion in the same period of last year, MAN's latest half-yearly review report released shows

"This indicates a substantial rise of N84.9 billion or 45.4 per cent over this timeframe. However, there was an N11.6 billion or 4.1 per cent decline when compared with the inventory value of N283.6 billion recorded in H2 2022," the report said.

However, the manufacturing sector factory output value increased to N4.10 trillion in the same period.

It stated that the manufacturing sector factory output value rose to N4.10 trillion from N3.99 trillion recorded in the corresponding half of 2022, indicating 2.8 per cent increase over the period. It also increased by 52.8 percent when compared with N2.68 trillion recorded in the preceding half.

The MAN report attributed the increase in inventory to a weakened purchasing power of the consumers, brought about by diminishing real household income resulting from the ongoing escalation of inflationary pressures, compounded by the scarcity of naira in Q1 and the aftermath of the subsidy removal.

When President Bola Tinubu announced the removal of the petrol subsidy on May 29, pump prices surged to as high as N617 per litre from N184, while the value of the naira has plunged following the floating of the currency.

The floating of the currency has increased the official rate from N463.38/\$ to N773.25/\$ as at Monday. The gap between the official and black market expanded to N227.

The high cost of dollars and the implementation of a 7.5 per cent value added tax on diesel imports have pushed its pump price to as high as N1,200 per litre.

According to MAN, the 2.8 percent increase in the monetary value (not real output) of manufacturing sector production over the period of one year when inflation is at 24.08 percent at the same period indicates a struggling sector.

"The manufacturing sector faced myriads of challenges in the first half of 2023. The residual effect of naira redesign and the removal of fuel subsidy towards the end of the period under review triggers inflationary pressure, cost of transportation,

cost of production and other macroeconomics imbalances, thereby worsening the purchasing power of the households.

"Key sectors like manufacturing and agriculture, which play a vital role in Nigeria's economy, suffer as higher fuel costs drive up expenses related to machinery, irrigation, and transportation.

These led to increase in the prices of food and other products, impacting both productivity and social stability. The uncertainty stemming from this policy change has undermined investor confidence, hampering both domestic and foreign investments that are crucial for economic growth and job creation," MAN pointed out.

Meanwhile, capacity utilisation in the manufacturing sector in the period under review, declined by 1.4 per cent year-on-year to 56.5 percent from 57.9 percent recorded in the corresponding half of 2022.

The director-general of MAN, Segun Ajayi-Kadir said that 2023 started with uncertainty in the economy as a result of Naira redesign policy of the Central Bank that led to naira crunch and the usual dormant economic activities prior to general

He noted that the re-infusion of the old currency notes which was initially moved out of circulation brought a promising outlook to the economy. Consequently, a short-lived uptick in economic activities, especially in the informal sector was experienced.

In restoring economy growth trajectory, Ajayi-Kadir stated that the government should engage in constructive dialogue with the stakeholders in the private sector; provide clear and consistent policies to provide certainty for businesses; conduct a comprehensive economic impact assessment of the fuel subsidy removal, exchange rate changes, and other policy measures; ensure effective implementation of the plans to support the manufacturing sector and MSMEs; infrastructure development; transparent and efficient implementation; regulatory reforms; among others.

He added that the government should prioritise forex intervention for raw materials and machinery for industries; improve forex allocation to the industrial sector; develop a roadmap for improved power supply, including off-grid solutions and private sector-driven independent power projects; resuscitate national refineries for local fuel production; review domestic gas pricing among

Last month, the country's inflation rate rose to an 18-year high of 25.80 percent from 24.08 percent in July, according to the National Bureau Statistics

Data from the latest Purchasing Managers' Index, by Stanbic IBTC Bank, shows that high inflationary pressures dropped business activities for the third straight month to 50.2 in August, the lowest in five months from 51.7 in July.

The latest aggregate Manufacturers CEO's Confidence Index (MCCI) of MAN also shows that manufacturers' confidence in the economy dropped to the lowest in nearly two years Q2.

The index declined for the third straight quarter to 52.7 points in Q2 from 54.1 points in the previous

The challenging macroeconomic issues impacted on the manufacturing sector as its growth rate slowed to the lowest in three years.

Data from the NBS shows that the real GDP growth of the sector stood at 2.2 percent in Q2, the lowest since Q2 2020.

The subsidy removal and exchange rate unification policy towards the end of the first half left the economy uncertain, causing a ripple effect that further eroded investors' confidence, according to manufacturers.

"As a result, businesses and foreign investors are increasingly wary of committing capital, thereby hindering economic growth and prospects for recovery," they said.

The MAN report also revealed that a total of 3,567 jobs were lost in H1, indicating 1,855 more job lost when compared with the 1,709 jobs lost in corresponding half of 2022 and 850 more jobs lost when compared with 2708 jobs lost in the last half

"The decline in the number of jobs created in the sector during the period further highlighted the unfriendly business environment resulting from the hasty policies and residual effect of the currency redesign policy that led to naira crunch," it said.

According to the association, capacity utilisation declined to 56.5 percent from 57.9 percent recorded in the corresponding half of 2022 and cost of funds for manufacturers rose to 24 percent from 22.0 percent in H2 last year.

The association recommends that the challenges in the manufacturing sector should be promptly and effectively addressed.

OPGAN to partner C'River for Africa's largest oil palm project

Palm Growers Oil Association of Nigeria, OPGAN has said it would collaborate with the Cross River State Government to create the largest sustainable small holder oil palm economy in Africa.

This is even as the state government in a deliberate and strategic move to fulfill and implement its agricultural vision, has accepted to adopt the proposal of OPGAN as an immediate initiative to boost agriculture in the state.

National President of OPGAN, Chief Joe Onyiuke who made this known at the flag off of a Town Hall event in Calabar yesterday said the partnership would create an Oil Palm revolution across the entire value chain and would involve the establishment and management of nurseries, plantations, logistics, processing/ milling, storage.

According to Onyiuke at the event which attracted national officers and coordinators from across the 18 Local Councils

of the state, the collaboration would also include refining, manufacturing, distribution and access to local and international markets to be jointly executed with the Nigerian Institute for Oil Palm Research (NIFOR)

"It is important to note that Nigeria is the world's fifth-largest Oil Palm producer but is a net importer of the commodity as it has huge local demand gulping about 500 million dollars annually according to the Central Bank of Nigeria (CBN).

"The Nigerian palm oil industry is very fragmented and dominated by numerous smallscale farmers, who account for 80 percent of local production and most of these farmers do not have access to improved seedlings/inputs and are not attuned to modern farming practices, meaning their yields and outputs are lower than it could otherwise be.

"Cross River State has always been a fertile environment for oil palm development and it is time for Cross River State to build coherent oil palm programs to regain its pre-eminent position as the number one oil palm state in the country.

"There are numerous activities in oil palm value chain and its socio-economic impact is so huge that we must harness the abundant human resources in the state especially women and youths to key into this oil palm revolution

"Together, these activities build and strengthen the component parts as well as the whole value chain which is an important aspect of the livelihood of the rural farmers and the state GDP thereby promoting community stability and reduction in rural urban migration." The President explained.

He lauded Otu's partnership with the association and NIFOR to establish nurseries across the state as a testimony of the Governor's deep understanding of the plight of oil palm farmers in the state adding that the move would trigger an oil palm model other that would be the envy of other states.

"This gesture of Governor Otu is a national duty that will see Nigeria gain back her lost position in the global index because Cross River state have the best ecological advantage than other states." Onyiuke said.

He told OPGAN members that the state has the capacity to fill the gap created by \$500M spent annually to import crude palm oil into the country and also be a net exporter.

"The surplus availability of fresh fruit bunches is the only thing that can put the state back on the national and global map. Investors and industries go where the base raw materials needed for their production are found in commercial quantity.

"We therefore cannot thank his excellency, Sen. Prince Bassey Otu enough for his deep love for his people. We in turn have been greatly encouraged and will not let him down as all possible risks of failure have been duly mitigated.

"NIFOR will set up a permanent base in Cross River State so we are together for the long haul.

The permanent presence of NIFOR in the state simply makes it easier for training/building the much needed local capacity that will ensure sustainability.

"The members shall be helped to cluster themselves into Cooperatives after profiling and mapping through the different departments of Extension and Mapping in NIFOR institute as they have enormous human resources to help us achieve the above.

"OPGAN members here will work hard to promote and protect the nurseries, their plantations in order to achieve the lofty objective of the present administration - grow quality certified oil palm and process same in the state for the shared prosperity of Cross Riverians." Onyiuke said.

It would be recalled that recent estimates indicated that local production of palm oil only accounted for 78% of local consumption while Nigeria consumed two million MT in 2021, leaving a deficit of 0.6 million MT.

Nigeria's forex market needs restructuring - Tinubu's aide

The Special Adviser to the President on Economic Affairs, Dr Tope Fasua, has called for a structural reform of Nigeria's foreign exchange market. Fasua made the call at a roundtable organised by the National Policy Advocacy Centre (NPAC) of the Abuja Chamber of Commerce and Industry (ACCI) in Abuja. The theme of the event was "Únification of Foreign Exchange and the Effect of Fuel Subsidy Removal on the Business Community. I believe we should reform the Bureau De Change (BDC) sector and make it stronger. You cannot manage over 5,000 BDCs selling money on the streets. If we can do the structural reforms in the BDCs sector and the banks and supervise them well, the CBN with our reserves can incentivise that sector, allowing people to get money much quicker. And you have to define the illegal market and by then we will be able to find stability," he said.

Fasua said that Nigeria spends over \$45 billion annually importing refined petroleum products, milk, chemicals and fish, among others. He said"I hear things like scarcity of forex. What is scarcity of forex, as if the world owes us any forex. The world does not owe us any forex. The forex you get is depending on the trade that you do. If you look at Nigeria's import and export profile, over 20 items that we import in Nigeria are in the billions of dollar range. Our biggest import, fuel and diesel take about \$25 billion to \$30 billion every year. We have things like cars, which is about four billion every year; sugar, fish, milk one billion each; wheat four billion; chemicals, three billion dollars; pharmaceuticals two billion dollars." Fasua listed crude oil and fertiliser as two things that Nigeria exports in the billion dollar range. "The first is petroleum and gas, you will see a figure like \$57 billion, but out of that only 30 per cent is ours, according to Nigeria Extractive Industries Transparency Initiative (NEITI).

"The international oil companies that have the technology that do production own most of that money," he said. The Director, Policy Advocacy Centre, ACCI, Mr Chidiebere Onwumere, said that foreign exchange unification held promises of increased transparency, improved access to forex and reduced market distortions. He, however, said that it raises questions about exchange rate stability, inflationary pressures and the cost of imports. "We must carefully consider how these factors will affect the competitiveness of our industries and the purchasing power of our citizens. Fuel subsidy removal, on the other hand, is expected to free up fiscal resources, reduce government spending, and potentially lead to increased investment in critical sectors. Yet, it also raises concerns about the immediate impact on transportation costs, inflation, and the welfare of our citizens, especially those in vulnerable communities," he said. Mr Oscar Onyema, Managing Director, Nigerian Exchange Group (NEG) PLC, said collaborative dialogue was essential in formulating policies that balance short-term challenges with long-term benefits. Highlighting the effects of both policies on the economy, Onyema said that immediate transition could disrupt businesses and the economy in several ways. Represented by Mrs Cordelia Ihedioha, Onyema said that businesses that were heavily reliant on imports may face short-term disruptions due to the sudden shift in exchange rates.

According to him, this could result in increased costs for imported raw materials, leading to potential price adjustments for end consumers. "To mitigate these disruptions, businesses may need to explore alternative sourcing strategies and adjust their pricing models," Onyema said Mr Dele Alimi, Director General, Institute of Directors of Nigeria appealed to the Federal Government to take total control of the mineral sector. He said "the mineral sector over the years has been poorly handled by previous governments as host communities have been left impoverished by illegal mining activities." Alimi described the subsidy removal and unification of the foreign exchange as bold steps by the Federal Government, saying that it was a necessity for economic revival. He urged more emphasis should be placed on efficiency of governance than cost of governance. Dr Chijiokr Ekechukwu, Vice President of ACCI, urged the Federal Government to fix the refineries and dvocated alternative sources of energy for cars to cushion the effect of the petrol subsidy removal. According to him, 60 per cent of cars in the United States run on electricity, adding, "that is where we should be headed for."

CBN Gov, Cardoso to discontinue Emefiele's policies

The newly appointed governor of the Central Bank of Nigeria (CBN), Olayemi Cardoso, has explained reasons he will abandon some of the policies implemented by his predecessor, Godwin Emefiele.

Cardoso during his screening and confirmation as the CBN governor yesterday in the national assembly said he will focus solely on monetary policy to strengthen the naira.

He also disclosed that since money supply is behind the rising inflation in the country, he would have no option then to abandon some of the policies.

The deputy governors screened and confirmed are: Emem Usoro, Abdullahi Dattijo, Bala Bello and Philip Ikeazor.

While answering questions from the lawmakers, Cardoso said the apex bank is faced with numerous challenges which the team had identified and would address them.

"We have identified issues of corporate governance, diminished institutional autonomy, discontinuity of orthodox policies and foreign currency issues.

"Addressing inflation and price stability is the function of the CBN. We will address the issue of foreign exchange unification. If there is a need for interest rate alignment, we will do it for economic growth."

To manage the economic policy, Cardoso said size matters, adding that the CBN team had identified macroeconomic indices and will facilitate new ways to attain \$1trillion GDP in eight years.

On inflation, Cardoso said each will be tackled based on their causes.

"If the inflation is on food, we should ramp up production of food. If inflation is on energy, we know the challenges of energy. If you are importing, automatically you are importing inflation," Cardoso said.

On the issue of money supply, Cardoso said the way money has gone up in Nigeria, "that, itself, is behind inflation. It is the problem. It is a big problem, but going forward, we will do everything possible to ensure that deficit financing does not bring problems to us."

He went on: "These are the assurances I can give you coming from outside because we will maintain a good working relationship to block the excesses we had in the past.

"I believe that the CBN under us will have no choice but to embrace a culture of compliance," Cardoso said, adding that they will abide by the CBN

"We will not wait for oversight before we interact with the lawmakers. We will have zero tolerance to abuse of processes. We recognize the fact that

we need to work closely with these chambers at the National Assembly to ensure compliance."

According to him, deficit financing and undue money glut are responsible for 50 per cent of the inflation.

He told the Senate that there is a need to stabilise the naira to settle Nigeria's outstanding debts, stating that the country is only spending money in printing currency rather than bringing in revenues.

According to him, the immediate thing to look out for is to address operational issues, which are the unsettled obligations of the CBN wealth of N4 billion or N7 billion.

He opined that Nigeria will not make progress if it is not able to handle that side of foreign exchange rate.

Cardoso said the issue of foreign exchange rate is worrisome, adding that Nigeria must have a stable exchange rate.

Also speaking, a deputy governor, Philip Ikeazor, said the present CBN is going to strengthen governance and focus on monetary policies and not fiscal policies.

He said the country must decide to support the physical majors of the CBN and ensure that exportation thrive.

"We will think outside the box, tackle inflation and the free flow of naira," he

Umahi slams Nigeria's procurement process

Minister of Works Engr David Nweze Umahi has characterized the procurement procedures in Nigeria as a significant obstacle to President Bola Ahmed Tinubu's noble goals.

Otti reaffirms commitment to enhance healthcare delivery in Abia

Gov. Alex Otti of Abia reaffirmed commitment to enhance the people's health through conscious and deliberate improvement of access to quality and affordable healthcare in the state.

Otti made the remark on Wednesday in Umuahia, when he formally reopened the renovated and rehabilitated Abia State General Hospital, Amachara, near Umuahia.

He expressed the readiness his administration to fully restore the state-owned primary, secondary and tertiary healthcare institutions in the state to function optimally.

The governor said that his commitment was informed by the need to ensure that the citizenry had access to quality healthcare in their various communities in a way that nobody would have to travel outside Abia for medical concerns.

He said that the government was focused on reducing the burden of diseases in the state "through the provision of resources for the implementation strategies appropriate multi-disciplinary intervention to improve population health".

Otti described rehabilitation the OT hospital as a strategic move by the government to restore the confidence of the people in public health institutions.

He said, achievement of improved healthcare delivery in Abia is significant to the overall development agenda of this administration, which is primarily aimed at improving the welfare of the people."

He promised that "under my watch, the health of the citizens will come first and be considered a higher priority".

Otti said that the government had instituted a mechanism that would ensure that an effective maintenance culture got enthroned in the health sector, especially in the management of health facilities.

He also said that plans were underway to set up a holistic mechanism for sanitising drug distribution in the state.

"We are rolling out strategic initiatives to control fake and substandard drugs and guarantee that drugs come into the state from a reliable source, known for standard and effective products," Otti said.

He said that would government the prioritise welfare of health personnel by ensuring that their salaries and legitimate entitlements would be paid as and when due. and called for improved customer-relationship between health workers and patients.

He said that the government and the leadership of health had engaged unions in discussions on how to come up with better incentives for hardworking health workers.

"We believe it will not only reduce the 'Japa Syndrome', but attract healthcare professionals, who are currently abroad," he said.

Otti urged various communities in the state to take ownership of any government facilities in their locality to prevent vandalism.

He warned that anyone

caught vandalising government property would be made to feel the full weight of the law.

In an address, Commissioner for Health, Dr Ngozi Okoronkwo, said that the rehabilitation of the hospital was an indication that the reforms in the health sector would produce a better healthcare system in Abia.

"The first time I visited this hospital, I was in tears because of how dilapidated the hospital was and the doctors were on strike.

"I began to imagine all that patients that visit the hospital have to go through healthcare to access services.

"Today the story has changed as the present administration rehabilitated the hospital and equipped it with stateof-the art equipment for the provision of quality healthcare services.

"We are just getting started with our plans for

the health sector and as we roll out our plans, before the end of the first year of this administration you will see a truly transformed health sector," Okoronkwo further said.

Earlier, the Medical Director of the hospital, Dr Francis Agu, commended the government for the massive reforms that had so far been executed in the health sector.

Agu said that the reforms had yielded a significant improvement in the delivery of healthcare services in the

HPW A/Court delivered 7, 295 judgments, 3,665 rulings in motions in one year

The President of Court of Appeal, Justice Monica Dongben-Mensem, had on Monday disclosed that the court delivered a total of 7,295 judgments and rulings on 3,665 motions in the 2022/2023 legal year alone

Dongben-Justice the Mensen made disclosure commencement of the 2023/2024 new legal year held at the Headquarters of the Court.

She recalled that a total of 98 panels were constituted to hear election petitions across the country to handle a total of 1,209 petitions that were filed against the 2023 general elections.

Among the petitions, she said five were filed the Presidential Election Petition Court and have been concluded while some of the 147 filed at the Senatorial election tribunal have been delivered 417 petitions from the House of Representatives election are also being attended to.

She also said at total of 557 petitions associated with the State houses of Assembly, and 83 Gubernatorial Elections petitions are being disposed off adding that 28 States participated the Governorship elections while petitions their judicial functions. were filed in 24 states.

ECOWAS Court Fixes Dec 7 For Decision On Four Guineans' For Supplementary Judgment

The ECOWAS Court has fixed December 7, 2023 to give its decision on an application brought by four Guineans for rectification of omission in the Court's judgment ECW/CCJ/JUD/06/19 delivered on February 26, 2019.

Justice Edward Amoako Asante, judge rapporteur, scheduled the case for judgment after the hearing of September 25, 2023 during which Mr Drame Alpha Yaya, lawyer to the four Guineans who brought their government before the Court for right violations, made submission.

However, the Guinean government that had earlier filed its defence, was not represented at the

sitting. Mr Drame Alpha Yaya filed an application ECW/CCJ/APP/19/19/ OMIS on April 30, 2019 asking the Court to rectify certain omissions in its judgment particularly, the Court's silence on



the consequences of the inaction of the government administrative office register their political party which led to their inability to participate in local elections held on February 4, 2018.

Mr Drame relied on Article 25 of the International Covenant on Civil and Political Rights (ICCPR) in his argument that the rights to participate in affairs, directly public or through freely chosen representatives, to vote and to be elected in genuine periodic elections

guaranteeing the free expression of the will of the electors, and equal access to public service in their country were violated with serious consequences.

In addition, Mr Drame asked the Court to note that the four Guineans involved in the case had filed separate initiating applications before the Court, prior to the consolidation of all four cases by a Court Order ECW/CCJ/RUL/02/18which also granted their request for expedited hearing, adding that the judgment of the Court did not specify if the award for reparation was individually or collective among the four Applicants.

Нe said that the ambiguity in the award reparation contributed to the delay in the enforcement of the

judgment.

the judgment delivered on February 26, 2019, the Court held the Guinean government liable for violating the four Guineans' to freedom to form a political party, freedom of association and their right to equal treatment and ordered the government take necessary measures to ensure their rights were respected.

The Court also awarded total sum of 100 million CFA francs as damages for the violations and the prejudice suffered and dismissed the claims of the Guinean government.

government The represented Joachim Gbilimou, had filed a counter application asking the Court to dismiss the case on the grounds that it was filed outside the 30-day period for application for supplementary judgment as stated in the Rules of the Court, and order the Applicants to pay jointly and severally 100,000,000 CFA francs for the illfounded application.

Other judges on the panel were Justices Gberibe Ouattara and Sengu M. Koroma.

In a similar case with number ECW/ suit CCJ/APP/19/19/INT, involving the same parties, the four Guineans are asking the Court for an interpretation of its ECW/CCJ/ judgment JUD/06/19 delivered on February 26, 2019.

The Court adjourned the case to November 23, 2023 for its Decision on the application.

Court Jails Internet Fraudster

Justice Maureen Adaobi Onyetenu of the Federal High Court sitting in Uyo, Akwa Ibom State, has jailed an internet fraudster, Prince Mbang Uba, on a two count charge of criminal impersonation and obtaining by false pretences to the tune of Three Hundred United State Dollars (\$300).

One of the charges read: "That you, Prince Mbang Uba (aka Sophia Johnson) in 2023 in Nigeria within the jurisdiction of this Honorable Court with intent to obtain property and gain advantage for yourself, fraudulently presented yourself as Sophia Johnson on social media platform (Facebook) and obtained the the court to convict and sum of Three Hundred United sentence Uba accordingly.

States Dollars (\$300) only, from one Bernie Smith and thereby committed an offence contrary to Section 22 (2) (b) (i) & (ii) of the Cyber Crime (Prohibition, Prevention etc) Act 2015 and punishable under Section 22 (b) (iv) of the same Act".

Containing economic impact of business email compromise

Cyber crime and the adverse effects on global business and society are on the increase and experts have been expressing concerns to that effect. In this report, FRIDAY OBANDE reflects professional views on the situation.

yber-related attacks have become increasingly imminent, and the severity and frequency of such incidents have grown significantly resulting in severe damage to our global economy with no end. The estimated cost of cyber-attacks on the global economy in 2021 was about 6 trillion USD which is estimated to be the GDP of the world's largest economy and a new high of about 10.5 trillion USD annually by 2025 is predicted.

While the economy faces several cybersecurity threats, a more expensive, lethal, dangerous and widespread type of phishing attack has grown silently but rapidly, drawing less attention to its catastrophic impact and coeting businesses billions of and costing businesses billions of dollars every year.

Mr. Benedict Joseph Oluwaseun is an information security and digital forensic expert who is passionate about cyber crime and the adverse effects on the society. He noted that Business Email Compromise (BEC) also referred to as the "Nigerian 419" scam is a specific and sophisticated spear phishing attack that focuses on legitimate businesses and persons to defraud them.

Researching the email accounts of cooperate or public key employees or executives involved with financial transactions (such as wire payment transfers) in organisations are either compromised through key loggers, spoofed or phished to carry out fraudulent payments resulting in billions of dollars in losses globally. He said a report by GreatHorn revealed that spoofed email accounts or websites were the most experienced.

or websites were the most experienced form of a BEC attack as 71% of organisations acknowledged they had seen one over the past year. This is followed by spear phishing (69%) and malware (24%).

Rosenthal (2022) listed 14 reputable organisations that have been victims of BEC and also estimated that an average of \$5.2 million was recorded as a loss per breach. For this reason, the FBI has named BEC a "\$26 billion scam," and the threat is increasing. BEC scams in 2020 alone recorded over \$1.8 billion compared to other cybercrimes.

'Some of the companies affected by BEC and their financial losses are Facebook and Google (\$121m BEC scam), Ubiquiti (\$46.7m vendor fraud), Toyota 2019 (\$37 million BEC attack), Obinwanne Okeke (\$11 million in losses), Scouler Co. (\$17.2m acquisition scam), Government of Puerto Rico (\$2.6 million transfer). Cift cord scame (\$2.6 million transfer), Gift card scams Just to mention a few.

In 2022, business email compromise was unquestionably a successful tactic for fraudsters. According to the most recent Internet Crime Report from the FBI's Internet Crime Complaint Centre (IC3), businesses lost more than \$2.7 billion as a result of these scams last year. That represents a \$300 million increase from 2021. Additionally, these losses exceeded those brought on by ransomware by almost 80 times.

BEC scams actually accounted for a staggering 27% of all financial losses associated with cybercrime in 2022, according to the FBI's IC3. Additionally, from \$120,000 in 2021 to \$124,000 in 2022, the average cost of each incident rose.

In 2022, there were fewer complaints made to the FBI's IC3 (800,944 vs. 847,376). However, the total amount lost increased from \$6.9 billion to more than \$10.2 billion. Reports of



complaints and losses due to cybercrime over the previous five years.

He also stressed that the surge in BEC attacks can be attributed to the new working culture practised during the COVID-19 pandemic, where individuals and organisations had to conduct daily business virtually.

Oluwaseun further quoted Joseph Carson, Chief Security Scientist, and Advisory CISO at Delinea, who said, "In the situation where employees are required to work remotely, it becomes more challenging to verify with a colleague whether the request is legitimate, most especially in cases when the request looks urgent, people mostly fall for such scams."

He also expressed concerns and challenges in proving BEC attacks were not human errors since criminals are highly skilled in hiding their tracks.

Sharing a similar opinion, he said, Andy Gill, Senior Security Consultant at LARES Consulting stated, "The record presented by the FBI Public Service Announcement doesn't come as a surprise. Also, claiming that the numbers may have been low since many BEC incidents may have been unreported and were swept under the

His recommendation and suggestion was that: The weakest and strongest line of defence for any organisation is its employees, with the increase in BEC attacks on a global scale and the evolving techniques and attacks by cyber criminals, organisations need to train their employees to become human firewalls, so as to identify and mitigate critical indicators of an attack before it is too late.

Elaborating more, he stated that some other basic steps employees can take to safeguard against attacks were: Zero Trust – irrespective of the familiarity between the sender and yourself, always verify every request to ascertain its legitimacy.

Believe in yourself and take your time – Never be in a rush; if you notice any discrepancies in the request, then flag it. Check and recheck account information and other details for accuracy. Maintain company guidelines and procedures. If you feel you have been compromised or fallen victim, report the breach immediately (to your management, bank, and local authorities) and follow up for resolution and reversal of the fraudulent transaction.

For organisations, he advised that as the reality of a remote working environment becomes a new normal, businesses, need to implement and improve on their present security architecture, procedures, and protocols to protect the asset from spear phishing or other forms of attacks.

"Once there is a disruption in the security protocols, employees will

require guidance on verifying the credibility of financial requests or transactions. Some recommendations for protecting your employees from falling victim to BEC attacks are: Use multiple independent signatures for high-value transactions.
Enable/add Sender Policy

Enable/add Sender Policy Framework, SPF, Domain Keys Identified Mail, DKIM, Domain-based Message Authentication Reporting and Conformance, DMARC, to block spoofing messages. Allow only authorised servers to send emails, and tell it what to do with the emails that have not cleared authentication.

Implement strong account authentication (MFA) and password account reset – to prevent unauthorized password resets and account logins. Only work with established vendor accounts to streamline transaction verification. Train employees to identify and prevent BEC attacks – this can be achieved by using simulations to give employees hands-on experience in

identifying cyber-attacks.

Develop an air-tight payment plan that will assist employees in identifying legitimate or illegitimate requests, such as mandating call verifications for individual transactions. On monitoring, he informed that regularly, all financial accounts for irregularities should verify all emails by enabling alerts for suspicious activity.

Cybersecurity is indeed a global risk; therefore, it requires a more collaborative and coordinated approach to address threats such as BEC, ransomware, data breach, denial-ofservice attack, and phishing attacks. Global Risks to cybersecurity, privacy, data protection, and online safety need more attention.

Through intensive employee training, robust verification protocols, and email authentication, organisations can reduce and equip their employees with the skills required to identify and prevent attacks such as BEC.

Kennedy-Ohanenye stated that "the Mobile Court will be in collaboration with the Attorney General of the Federation, the Minister of Justice, the Nigerian Governor's Forum, Security Agencies, Civil Society Organisation, CSO's to have innovative ways to enforce Violence Against Persons Prohibition, VAPP, Act, 2015 and other laws to curb the menace of Sexual and Gender-Based Violence as well

as Female Genital Mutilation, SGBV, GBV, FGM/C."

She stated that the idea of having the mobile court was to ensure quick dispensation of justice for the survival of the voiceless in line with Mr President's renewed hope agenda, saying that they will work to allow the poor to breathe and not suffocate.

The Minister said that those who were still practising Female Genital Mutilation, FGM, would also be tried in the mobile courts so as to bring to an end this old traditional

In her words, "The Mobile Court will be created for Gender-Based Violence and Child molestation, the victims will report to the Ministry and the Ministry will go to the Mobile Court for Justice."

Meanwhile, the Ministry in collaboration with the Ministry of Trade and Investment has opted to "encourage Women Groups to form Cooperatives registered with the Ministry so

that the Ministry can empower them with different production machines to boost Nigeria's economy, livelihood of Women and nation building.'

The Ministry has opted to encourage all women groups to form cooperatives and register with the Ministry so that the Ministry can empower them with different production machines to boost Nigeria's economy, livelihood of women and for nation development, she said.

She added that the Ministry has decided to make life easier for rural women by providing them with Charcoal burners and bio-gas stoves which were cost-effective as the Gas Cylinder that was being distributed to rural women was no longer sustainable by the Ministry, also the Ministry was now concerned about who refills the gas cylinder for these women when it gets finished.

The Ministry noted within 100 days, it will set up Sewing houses to produce local fabrics which will be exported to other countries.

The Women Minister also said that the sanitary towels the Ministry usually gives to students will now be transformed into a setting up "Sanitary Pad Production Centre" as the old method can no longer be sustainable.

She also said that the Ministry's creche and other underutilised properties will get back to their feet for proper functioning within her 100 days in office.

Meanwhile, Kennedy-Ohanenye in a parley with Nigerian student leaders across the country at the Ministry's Headquarters in Abuja, concerning case of sexual harassment in the University of Calabar, called on DSS to investigate the matter. Butchers Association warned against buying, selling animals suspected to dead of anthrax disease

Butchers Association of The Nigeria has be warned against buying, slaughtering, or selling animals suspected to have died of the deadly anthrax disease.

In a brief lecture in Oyo, State Epidemiologist, Semiu Akibu, said the state had to be on alert because cases of anthrax had been reported in States like Niger, Plateau, Kogi, and Lagos.

He said anthrax, being a bacterial disease and airborne, could pose threats to pig, sheep, goat, cow, and other animal health, adding that symptoms of the disease include weakness, fever, difficulty breathing, and blood oozing.

The chairman of the association, Mr Olagoke, also warned at a sensitisation programme of the state government against the spread of the disease in the state.

The sensitisation was held for stakeholders in the Oke-Ogun axis of the state and attended by officials of the state ministry of agriculture, cattle breeders under the aegis of Miyetti Allah Cattle Breeders Association of Nigeria (MACBAN), butchers, traders, veterinary doctors, and health officers, among others, was held at the MACBAN Secretariat, Kara Market, Iseyin.

Speaking, Olagoke said the association had warned its members not to be tempted to buy such dead animals from cattle dealers, irrespective of the cost.

He added that the association was well aware of the health implications of the spread of the anthrax disease and hence continued to sensitise members.

In his remarks, a deputy director in charge of the Control Post and Cattle Market in the state, Dr Liadi Adeniran, said that, to date, there had been no record of the disease in the state and called on residents to join the effort to prevent the disease outbreak by reporting suspected cases of anthrax and other animal diseases in their domain.

In his contribution, Oyo State Animal Disease Surveillance Agent, Irepo, Dr. Tunde Adetola, assured cattle rearers of the readiness of the state government to make available vaccines for the prevention of anthrax both for humans and animals.

World leaders commit to new targets to end Tuberculosis

World leaders at the United Nations General Assembly's High-Level Meeting on Tuberculosis have approved a Political Declaration with ambitious new targets for the next five years to advance the global efforts towards ending the TB epidemic.

The targets include reaching 90% of people with TB prevention and care services, using a WHO-recommended rapid test as the first method of diagnosing TB; providing social benefit packages to all people with TB; licensing at least one new TB vaccine; and closing funding gaps for TB implementation and research by 2027.

Speaking, WHO Director-Dr Tedros General, Adhanom Ghebreyesus, our ancestors have suffered and died with tuberculosis, without knowing what it was, what caused it, or how to stop it, saying today, we have knowledge and tools they could only have dreamed of.

He said, the political **Tedros** declaration countries approved, and the targets they have set, are a commitment to use those tools, and develop new ones, to write the final chapter in the story of TB.

Taking stock of progress towards targets set in 2018 for a five-year period, WHO reported that while global efforts to combat TB have saved over 75 million lives since the year 2000, they fell short of reaching the targets, mainly due to severe disruptions to TB services caused by the COVID-19 pandemic and ongoing conflicts.

According to him, only 34 million people of the intended 40 million people with TB were reached with treatment between 2018 and 2022. For TB preventive treatment, the situation was even more grim, with only 15.5 million of the 30 million people targeted to be reached with preventive treatment accessing it.

He informed that Funding for TB services in low- and middle-income countries fell from US\$ 6.4 billion in 2018 to US\$ 5.8 billion in in 2022, representing a 50% financing gap in implementing the required TB programmes.



Annual funding for TB research ranged from US\$ 0.9 billion to US\$ 1.0 billion between 2018 and 2022, which is just half of

the target set in 2018.

"This has placed an even heavier burden those affected, especially the most vulnerable. Today, TB remains one of the world's top infectious killers: annually more than 10 million people fall sick, and over 1 million lose their lives to this preventable and curable disease. Drug-resistant TB continues to be a major contributor antimicrobial resistance with close to half a million people drugdeveloping resistant TB every year.

"Uniting around the TB response by world leaders, for a second time, provides an opportunity to accelerate action and strengthen health systems capable of not only addressing the TB epidemic, but also protecting the broader health and well-being communities, strengthening pandemic

preparedness building on lessons learnt during the COVID-19 pandemic," said Dr Tereza Kasaeva, Director of the WHO Global TB Programme.
"Averting TB-related financial hardship and preventing the development of the disease in vulnerable groups will help diminish inequities within and between countries, contributing to the achievement of the Sustainable Development Goals."

TB incidence and deaths have risen between 2020 and 2021 but coordinated efforts by countries, WHO and partners are resulting in a recovery of essential services, he said.

WHO Director-General, Dr Tedros Adhanom Ghebreyesus, therefore officially launched the TB vaccine accelerator council to facilitate the development, licensing and use of new TB vaccines.

The Council, supported by the WHO secretariat, will be led by a ministerial board, consisting of nine members who will serve on a rotating basis, for a term of two years. The Council will also have subsidiary bodies to support its interaction and engagement with different sectors and stakeholders broadly, including the private sector, scientists, philanthropy, and civil society.

BCG is currently the only licensed TB vaccine. While it provides moderate efficacy in preventing severe forms of TB in infants and young children, it does not adequately protect adolescents and adults, who account for the majority (>90%) of TB transmission globally.

The Council aims to identify innovative sustainable nnancing market solutions and partnerships across public, private, and philanthropic sectors. It will leverage platforms like the African Union, Association of Southeast Asian Nations (ASEAN), BRICS countries (Brazil, Russian Federation, India, China and South Africa), G20, G7 and others to strengthen commitment and actions for novel TB vaccine development and

access.

Few Nigerian statesmen have in the country's history received the amount of adulation and accolades as ace journalist, Alhaji Lateef Kayode Jakande, who governed Lagos State, country's economic nerve centre from 1979 to 1983. Often known simply by his initials LKJ, this former Nigerian Minister of Works, unlike many other politicians whose life works are eulogised only posthumously, has become the veritable centre point of good governance and quintessence of public service. In his honour, the Nigerian Guild of Editors (NGE) commenced the maiden Annual Lecture Series on August 7, 2023.

LKJ's family and parental roots were traced to

LKJ's family and parental roots were traced to the town of Omu-Aran in present day Kwara State of Nigeria. Omu-Aran is the home of many great Nigerians including the first Kwara State Military Governor, Colonel David Bamigboye, as well as greatly acclaimed cleric, Bishop David Oyedipo of Living Faith Church, top diplomat, Ambassador Oluwole Idowu among others. Like many sons of the town, his parents moved to Lagos at the dawn of the century prior to his birth on July 29, 1929. He started his educational pursuit in various schools in Lagos and later at Bunham Memorial Methodist School, Port-Harcourt, 1934-1943, Kings College, Lagos, 1943 and Ilesha Grammar School in 1945 where he obtained his higher certificate. LKJ began his career in the world of writing during his higher secondary studies at Ilesha Grammar School where he was editing the school's magazine titled "Quarterly Mirror". Thereafter, he continued improving himself in the newsroom in various media houses including running a publication known as "Daily Service".

running a publication known as "Daily Service".

In his media work, he became greatly fascinated by the larger than life profile and politics of Chief Obafemi Awolowo who founded the Action Group, a political party in 1951. By 1953, Jakande joined the "Nigerian Tribune Newspaper" which was established in 1949 by Chief Awolowo and became the visible mouth piece of the sage's political structure and ideology. Gradually, he rose to become the Editor-in-Chief of this major national newspaper in 1956. It later became a life-long career of nearly 22 years of dutiful service to his mentor, Chief Awolowo during his high and low tides in politics. What upped his journalistic image was the fact that The Tribune newspapers under LKJ's stewardship became popular for its very objective and fearless reportage. Despite the fact that for much of the time his political principal was in the opposition, he earned for the paper and for himself respect on the quality of his editorials. Till date, against the backdrop of the foundation which he laid, The Tribune is not only Nigeria's oldest private newspaper in existence but has fledged on as the leading newsprint of preference in some sections of Nigeria

During his brief exit from the Tribune, he established a printing outfit, which came up with a new product, "The Lagos News". He also served at a time as the first President of Newspaper Proprietors Association of Nigeria (NPAN) and the Guild of Editors. LKJ was also credited a one of the brains behind the strengthening of Nigeria Union of Journalists (NUJ) and the establishment of Nigerian Institute of Journalism (NIJ) now at Ogba in Ikeja, Lagos State

During the build-up stage to Nigeria's return to civilian rule in 1979, a process that started in 1976 and subsequent formation of political movements that graduated into political parties, Jakande, who preferred the rather diminutive sobriquet of "Baba Kekere" which literally means a "little father" in deference to his boss, "Baba" (Chief Awolowo), threw

his net into the political waters. As expected, he teamed up with his boss, Chief Awolowo and his new political outfit, Unity Party of Nigeria (UPN). In the ensuing electoral process, LKJ won the UPN Governorship ticket for Lagos State, a platform through which he won Lagos Gubernatorial election in 1979 having defeated one of the country's political juggernauts and pioneer lawyers at the time, Chief Adeniran Ogunsanya of the Nigerian Peoples Party (NPP) among others. A more spectacular score was his defeat of one of the "sons of the soil," Prince Ladega Adeniji-Adele of the National Party of Nigeria (NPN), a descendant of the leading royal houses of Lagos. This was a big fit, underscoring not just the political influence of Chief Awolowo in that part of the country but called great attention to the candour of LKJ who did not have a great amount of formal tertiary education.

Soon after his assumption in office, Alhaji Jakande moved to prove his mettle which remains unmatched in all of Nigeria's history. His government pursued several policies particularly in areas such as free and affordable education, massive public housing and urban renewal. He introduced free and compulsory education both at the primary and secondary levels, for all the teeming population of Lagos irrespective of origin. Unfazed by a storm of bile and nay-saying from political opponents who groused and jeered over what they taunted as falling standards of public education, he built new schools and reconstructed existing ones using the cheapest technology. All relevant pedagogical materials were made available for free or at very affordable prices. By the time he left office in 1983, a total number of 22,000 classrooms had been added to the school system. He also increased the number of primary and secondary schools from 605 to 812 and 105 to over 223 respectively.

With respect to tertiary education, he established Lagos State College of Education and the Lagos State University (LASU) in 1983. With a population of about 34,000 students today, LASU has grown to be amongst the main universities in Nigeria. Aside from that, LASU has become a leading centre for research and innovation and was at several times amongst the 10 best in Nigeria's over 200 universities.

In the area of Mass Housing, Jakande built about 30,000 units of houses around the Lagos State within a

span of four years. He also flagged off the construction of the Onikan Stadium, now one of the country's main recreational landmarks. In his own constituency, that is the world of mass media, Governor Jakande started both the Lagos State Radio and Lagos Television in 1980 and both media outfits are still making very remarkable impact in electronic broadcasting in Nigeria.

Another area of great impact which he created was in public transportation. He opened up the entire state, especially Lagos metropolis, to affordable transport connectivity. This included marine transport services, taking advantage of the state's riverine environment. Foreseeing the imminent population explosion in Lagos, which had maintained a steady growth rate of about 6.3% and heading into a megacity status, he started a "metro line" mass transport project. Although the city was the nation's capital at the time, he did not wait for federal authorities, but went ahead to embark on this massive project. Sadly, since his exit from office, some 40 years ago, the metro line was largely abandoned and the city continues to groan under the burden of great transport congestions.

Like most politicians of his time, from whom power was seized by the military, intermittently in Nigeria, in this case on December 31, 1983, he went back to private life for 10 years but was recalled to serve as Federal Minister of Works (1993-1995). This was under the tenure of military Head of State, Gen. Sani Abacha who ruled Nigeria from 1993-1998. Similar to other "progressive" politicians of his ilk, his acceptance to serve, which came under great pressure, became a blight on his later political career, as he lost much of his radical lustre and vitality. This notwithstanding, as a master builder, he brought his Midas touch to the national capital in overseeing the iconic Gwarimpa and Lugbe Federal Housing Projects, both in Abuja. These two gigantic public housing schemes are regarded as amongst the biggest of their type in Africa.

He was not successful in his second foray into

He was not successful in his second foray into politics during the return of Nigeria to democratic rule in 1999, perhaps due to his erstwhile close relationship with Abacha. However, he later became a senior member of All Nigerian Peoples Party (ANPP). As the political processes kept evolving, he helped to form and became first Chairman of the Action Party of Nigeria (APN) in 2006. The political party did not however, make much impact in the political arena despite its contributions in politics and governance in the Second Republic.

The life of this great Nigerian will be a perpetual reminder to all that "greatness lies not in ruling the people but in being the cause of greatness in their life". As the servant-leader that he was, simplicity and humility were his mantra. Hence, throughout his tenure as a Governor of Nigeria's largest and most sophisticated state, he lived in his personal house in a middle class municipality and drove down in his modest personal car. Hence even though LKJ is now counted as late and condemned to history, the impact of his life's works continue to speak for him. He has corroborated American writer, James Dean's metaphor of bridging the gap between life and death perpetually. So even in death, he still speaks with a clear voice to Nigeria and would, perhaps always do so.



NPFL bars coaches without CAF licence from topflight



Nigeria Premier Football League board has directed all coaches in the top-flight to obtain the Confederation of Africa Football,CAF, B Licence.

NPFLChiefOperatingOfficer, Davidson Owumi, announced that the requirement is part of the league's bid to improve the quality of technical performance of the clubs.

He said the measure is coming into force to trigger the coaches to acquire training that will improve what they offer to players.

"One of the areas of the league we seek to improve in the new season is the area of technical performance of our teams through the players, and this can only be achieved by having competent managers on the bench.

"For this season, we will only allow Head Coaches with a minimum qualification of the CAF B Licence to sit on the bench. This may be reviewed upward next season.

"The idea is to encourage our coaches to improve themselves through higher certifications by participating in reputable courses."

The 2023/24 NPFL season will kick off on Saturday, September 30 nationwide.
