



# Nigerians struggle as high drug prices fuel health crisis

● Out-of-pocket payments on the increase ● Patient care threatened Rising costs force resort to herbal remedies, traditional healers • Worry over unpredictable effectiveness of traditional medicine

AGOS — For patients in Nigeria, the outrageous cost of life-saving drugs is a daily burden. Several people are now forced to take a risk with their health by extending or missing doses, settling for less potent substitutes, resorting to selfmedication or traditional healers, or stopped medication entirely.

For those battling chronic ailments such as diabetes, high blood pressure or cancer, the affordability crisis has pushed essential medications and treatment out of reach for many Nigerians, and strained the public healthcare system.

Experts are worried that a significant number of

patients who are not taking their medications as prescribed, stand to develop complications and incur even more expensive interventions later.

Some patients, who spoke with *Vanguard* bemoaned the negative effects that rising drug costs are having on their well-being, financial situation, and survival.

Ngozi Uchenna, a petty trader, was concerned about her 10-year-old daughter's persistent cough. Αt the neighbourhood health centre in Ikeia, Lagos, she was visibly worried at the high cost of the prescribed cough mixture. "I cannot afford the drugs, so I'm taking my child back home." she stated.

James Akor, who had been coping with sporadic coughs and chest pains,

said he resorted to taking herbal mixtures because the hospital treatment bills were outrageous.

"One of the drugs the doctor said I shoud buy costs N120,000 and I will  $\bar{}$  need to buy it two or three times every month. Another drug is about N55,000. Where will I get the money? I don't have it," he lamented.

### I can't afford N1.2m for one drug'

Dayo A. who was diagnosed with prostate cancer in 2023, has not purchased any of the drugs prescribed for him.

He lamented: "The cancer was detected midstage, I am only on palliative treatment. One of the drugs prescribed for me was Lupron Depot. The doctor said I should take it

"I am self-employed and not on health insurance, so I could not afford it. I was placed on another drug, Zoladex, but one vial costs about N750,000, which was also unaffordable for me."

For Olu F., a father of three, who noted that paying his hospital bills is a nightmare, said: "I'm a civil servant with a heart problem. Actually, I'm on a basic health insurance plan, but it does not cover the full cost of treatment for my condition, so I'm paying out of pocket.



the naira devaluation, price adjustments by drug manufacturers, government regulations, taxes, availability and demand for specific medications are factors driving price increases.

Towards the attainment of United Nations Sustainable Development Goal, SDG3, and Universal Health Coverage, UHC, the Federal Government assented to the 2014 National Health Bill aimed at providing increased access to basic health care the vulnerable population.

But even this has failed because many Nigerians still pay out of pocket for medical expenses, expenses, pushing more families into experiencing burgeoning health expenditures.

With hospital care gradually becoming financially out of reach, Nigerians are turning to cheaper but largely untested options such as home remedies, herbal medicines, among others.

But experts are worried by this development. The consensus was that out of pocket expenditures will prevail until the gaps in financing essential health care services, particularly preventive health services, is addressed.

Worry over

### traditional, herbal medicine

A general practitioner at a General Hospital in Lagos, Dr Femi Akintunde, cautioned that though traditional medicine practices and herbal treatments are prevalent and offer familiarity and cultural relevance, their effectiveness can vary significantly.

"When treatment costs become too high, people are forced to seek affordable and untested alternatives. Although traditional medicine practices and herbal treatments are widely used in Nigeria, their effectiveness can be unpredictable," Akintunde warned.

Further he said: "While going to the pharmacy is okay for consultations for minor ailments and overthe-counter medications, relying on them for serious conditions can be risky due to limitations in diagnosis.

"Though public clinics offer affordable care, they may face resource limitations and longer wait times. The bottom line is that the inability to access proper diagnosis and treatment from qualified professionals can worsen health outcomes.'

# KIDNAP: Families of Lebanese nationals rebuff police intervention

**F**<sup>AMILIES</sup>, community and close associates of the four Lebanese nationals kidnapped Friday by suspected militants in the riverine areas of Lagos State, have reportedly rebuffed police intervention, saying they are in a better position to achieve results without endangering the lives of the victims.

This came as controversy trailed their kidnap by armed men suspected to be militants from the riverine areas of the

While reports said the Managing Director of Fouani Company, a representative of LG and Hisense products was one of the victims; another source said it was one of his top managers and others that were

They were said to have been abducted while travelling by boat from Apapa to Victoria Island when they ran into ambush near Falomo Bridge.

Late yesterday, it was learned that the unknown gunmen were demanding for a whooping S1.5 million as ransom while negotiations were said to be on between the families of the victims and their abductors.

A source close to the friends of the victims hinted that they may be released any moment from now especially "by nightfall going by the progress and understanding so far recorded with the kidnappers.

However, Vanguard gathered that police detectives in the state are not leaving any stone unturned in rescuing the victims safely and had since set all machineries in motion towards achieving results.

According to sources, police detectives have commenced intensive combing of all waterways in the state including known islands that the kidnappers might have taken the victims to, noting "efforts are also in top gear to monitor activities of criminal elements in all coastal areas in the state."

Vanguard was informed that the Commissioner of Police, Adegoke Fayoade had already given stern directives to men of the Special Squad to move into action and rescue the victims without delay.

Police sources said the team of detectives are also spreading their dragnets across all neighboring states especially those close to water ways with a view to rounding up perpetrators of

The source said the measure was prompted by revelations from a notorious kidnapper recently arrested in one of the neighboring states after they abducted an oil magnet at Lamgbasa area of Lagos.

The kidnapper presently detained at the Command headquarters, Ikeja, submitted himself to the police after his tracks were uncovered and all his relations including his pregnant wife that were frustrating his arrest were apprehended.

When contacted over developments regarding the kidnap of the Lebanese, the state Police spokesman, Benjamin Hyndeyin simply said: "We are on top of the situation. Though, I may not give you all the details but I assure you that success will soon be recorded.

# Mohbad's toxicology result: Family demands review, transparency

•Calls on IGP to personally intervene, bring killers to book

LAGOS—THE battle for justice for late Nigerian musician, Ilerioluwa Aloba, popularly known as Mohbad, may not be over, as his family has rejected pathologist's declaration of the toxicology test results inconclusive and demanded for a review.

The family equally insisted that a reexamination should be conducted with the utmost transparency and strict adherence to the highest standards of forensic science.

Besides, late Mohbad's family also accused the Police of shoddy investigation into his death and called on the Inspector-General of Police, IGP Kayode Egbetokun, to personally intervene in the investigation and bring those who have hands in his death to

The family in a virtual briefing, yesterday anchored by its lawyers: . Wahab Shittu and Taiwo Odumosu, among others, said, "We, the legal representatives of the Aloba family, express our profound dissatisfaction and disappointment with the recent announcement regarding the toxicology test results of the late Ilerioluwa Oladimeji Aloba, which have been declared 'inconclusive' by the pathologist.

"This outcome is entirely unacceptable to us and the Aloba family and raises serious concerns about the integrity and thoroughness of the investigation by the Police and the medical team into the untimely death of their beloved son, brother, and friend. The Aloba family and, indeed, the whole world demand to know where the toxicology test was carried out as this has impugned the integrity.

"The legal team wonders how the letterhead and the address of the National Medical Services Laboratories in Pennsylvania, USA, appeared on the toxicology test report if the test was not

truly carried out in the USA.

"The legal team is puzzled more, given the discrepancies in the further response given by the NMS laboratories ascribing the test to another sister laboratory. The conflict of interest bothers on professional integrity. The public is interested in knowing the relationship between the Lagos State DNA and Forensic Laboratory, NMS in the USA and ITSI Biosciences who allegedly completed the toxicology test on behalf of the Lagos State government.

"The family's hope that the toxicology test reportedly conducted in the United States, would shed light on the circumstances surrounding his tragic passing, had been dashed'

They further stated that the declaration of the test as 'inconclusive' failed to provide the clarity needed and undermined the public as well as late Mohbad family's faith in the investigative process.

In light of these developments, they hinted that the Aloba family was "compelled to denounce the 'inconclusive' toxicology test results and demand that re-examination should be conducted with the utmost transparency and adherence to the highest standards of forensic science".

Other demands by the family as

highlighted by the lawyers were: "a thorough review of the procedures and protocols followed during the initial toxicology testing, that should include an assessment of the chain of custody, handling, and analysis of the samples to ensure that no procedural lapses or contamination occurred.

"We urge the involvement of independent international forensic experts to oversee and validate the re-examination process. Their participation will help restore confidence in the findings and one were that all possible. findings and ensure that all possible avenues are explored.

"The Aloba family demands full

disclosure of all findings and reports related to the toxicology tests. Transparency is crucial to understanding the cause of death and dispelling any doubts or suspicions.

Time is of the essence in this matter. We call upon the relevant authorities to expedite the re-examination process and ensure that the family receives definitive answers without undue delay.

The Nigeria Police has not done

enough in this case. The investigation so far conducted does not show the thoroughness and professionalism expected in a murder case of this nature. We call on the Inspector General of Police to personally intervene in this investigation and bring the perpetrators to book.

"The Aloba family remains steadfast in its pursuit of truth and justice for Ilerioluwa. They deserve clear, definitive answers regarding the cause of his death, and it is the responsibility of the investigative bodies to provide them with such clarity. The current 'inconclusive' results only serve to prolong their agony and uncertainty, which is both unfair and

# 500-level student commits suicide in Ondo after church vigil

**AKURE**—A final year student of Adekunle Ajasin University, Akungba Akoko, AAUA, Ondo state, Ayandare Modupe, has reportedly committed suicide after attending a church vigil.

Sources said the deceased walked into an uncompleted building close to the church where she attended a vigil at a white garment church and committed

She reportedly left a suicide note in

her bag after hanging herself.
A statement by the Public Relations Officer of the institution's student union, Olaogbebikan Noble, said "We express in strong terms our dissatisfaction and agony with respect to the death of one of our student, Ayandare Modupe; a 500 level student of the Department of Agronomy (Agronomy Departmental President)

"According to report the deceased was said to have committed suicide at the early hours of today (yesterday) around 4am after they finished vigil in her church. The incident happened beside the church around Sportless Villa.

"The law enforcement agency has been informed already and all hands are on desk in getting to the root of the situation. Be rest assured that justice will be served and the law enforcement agency will do thorough investigation.

"Should you have any information to supply regarding the incident that happened, kindly reach out to the students' union.

Similarly, the deceased department in which she was the President, in a statement by Faith Oluwatimilehin, among others, said "It is with a heavy heart that I write to inform you of a tragic event that has deeply affected our community. We have lost one of our own, Modesty who served as the President of the Department of

"Her passing, by suicide at Onireason Street's permanent site, is a profound loss to us all. During this difficult time, we urge everyone to come together in support of one another. The mental well-being of our members is of utmost importance, and we encourage anyone who may be struggling to seek help.

"Our faculty offers counseling services, and we are here to support you in any way we can.

Contacted, the spokesperson for the state police command, Funmi Odunlami, confirmed that the deceased left a suicide note in her bag before committing suicide at an uncompleted building.

### Suspected herdsmen storm Taraba community, kill 6 villagers Inflict injuries on several others

JALINGO—SUSPECTED herdsmen have invaded a Taraba community, killing no fewer than six and inflicted various degrees of injuries on several other villagers

According to sources, the invasion which occurred in Mararaban Azagwa and Alele villages of Maihula in the Bali Local Government Area, LGA, of the state, took place on Sunday.

One of the traumatized residents of

the area, Isah Abdul, informed that trouble started when a man who was drunk and might have taken hard drugs at Maihula market was found dead on his way home, saying "It is an unfortunate development. The relatives of the deceased, who later recovered his corpse, accused the Tiv villagers where the man died of been responsible for the death of their brother.

"There was nothing actually to point to the fact that the man was killed. He might have probably died from

complications arising from the alcohol and the drugs he took. But his relatives, who suspected that he was killed by the Tiv villagers, mobilised and started attacking and killing people."

Briefing on the development, Chairman, Taraba State Tiv Traditional Council, Zaki David Gbaa, said "six persons were killed and four others are in critical conditions in hospital. Those killed include; Aondohemba Salemkaan, Tersuugh Dondo, Terkuma Mbatim, Kumaga Ujam Asaaga Nev and Tersoo Memga.

He condemned the attack and lauded the security agencies for their quick intervention to calm the situation, expressing confidence that the attackers would be arrested by security agencies and prosecuted especially that all of them live in the community and could easily be identified.

State Police Public Relations Officer, DSP Gambo Kwache, who confirmed the attack said only two corpses were recovered by the police and added that no arrest had been made, but security operatives were combing the area in search of the

# ....Delta Police arrest GO, others, recover military uniform

JGHELLI—OPERATIVES of Delta State Police have arrested one Bishop, a General Overseer, GO, and founder of a new generation Church, his wife and others over alleged attempt to kidnap a fellow Bishop in Agbarho, Ughelli North Local Government Area of the state.

The GO, simply identified as Bishop

Vanguard learnt that the GO whose church is located in Agbarho was traced to a hide out after getting wind of the arrest of his wife and others.

According to a dependable source, "Our Bishop sent a text message of kidnapping and assassination to the other Bishop (name withheld) whose church is more populated than his demanding N150, 000. Out of fear the other Bishop sent N100,000 to an

account provided in the text message. "The delay in sending the balance of N50,000 resulted to multiple kidnapping and assassination text messages from the suspect."

The text messages read, "Hello Bishop, this is me Dust to Dust, the members of black axe cult (Eye) Ugolo

"Be informed that we were asked to assassinate you, kidnap and kill you right in your church at Agbarho. But we decided to change our mind based on one condition.

"We are demanding a ransom of

N150,000 from you which should be transferred into our account today Monday 10th June.'

While looking for money to balance the payment they sent another text to him with the caption, "Hey, you feel say we no go fit do u anything. No worry na

back we go take enter u. "If u no bal up d 100k, we go come for ur life. Do u know how many people we have with us, send the 100k if not, u done match line as your prayer of Holy ghost fire on our head for ur church after we done settle

# Nigeria confronts its worst economic crisis in a generation

**DEOPLE** in Africa's most populous nation are suffering as the price of food, fuel and medicine has skyrocketed out of reach for

Nigeria is facing its worst economic crisis in decades, with skyrocketing inflation, a national currency in free-fall and millions of people struggling to buy food. Only two years ago Africa's biggest economy, Nigeria is projected to drop to fourth place this year.

The pain is widespread. Unions strike to protest salaries of around \$20 a month. People die in stampedes, desperate for free sacks of rice. Hospitals are overrun with women wracked by spasms from calcium deficiencies.

The crisis is largely believed to be rooted in two major changes implemented by a president elected 15 months ago: the partial removal of fuel subsidies and the floating of the currency, which together have caused major price rises.

A nation of entrepreneurs, Nigeria's more than 200 million citizens are skilled at managing in tough circumstances, without the services states usually provide. They generate their own electricity and source their own water. They take up arms and defend their communities when the armed forces cannot. They negotiate with kidnappers when family members are abducted.

But right now, their resourcefulness is being stretched to the limit.

### No Money for Milk

On a recent morning in a corner of the biggest emergency room in northern Nigeria, three women were convulsing in painful spasms, unable to speak. Each year, the E.R. at Murtala Muhammed Specialist Hospital in Kano, Nigeria's second-largest city, received one or two cases of hypocalcemia caused by malnutrition, said Salisu Garba, a kindly health worker who hurried from bed to bed, ward to ward.

Now, with many unable to afford food, the hospital sees multiple

Mr. Garba was sizing up the women's husbands. Which source of nutrition he recommended depended on what he thought they could afford. Baobab leaves or tiger nuts for the poor; boiled-up bones for the slightly better off. He laughed at the suggestion that anyone

More than 87 million people in Nigeria, Africa's most populous country, live below the poverty line — the world's second-largest poor population after India, a country seven times its size. And punishing inflation means poverty rates are expected to rise still further this year and next, according to the World Bank.

Last week, unions shut down hospitals, courts, schools, airports and even the country's Parliament, striking in an attempt to force the government to increase the monthly salary of \$20 it pays its

But over 92 percent of working-age Nigerians are in the informal

More than 87 million people in Nigeria, Africa's most populous country, live below the poverty line— the world's second-largest poor population after India, a country seven times its size

sector, where there are no wages, and no unions to fight for them. For the Afolabi family in Ibadan, in southwestern Nigeria, the descent into poverty started in January with the loss of an electric

Forced to sell the taxi to pay his wife's hospital bills after the difficult birth of their second child, Babatunde Afolabi turned to occasional construction work. It paid badly, but the family managed.
"We had no thoughts about starvation," he said.
But then, he said, cassava — the cheapest staple in many parts of

Nigeria — tripled in price.

All they can afford now, he said, is a few biscuits, a little bread, and for their six-year-old, 20 peanuts a day.

### A Country Built on Gas

Nigeria is a country heavily dependent on imported petroleum products, despite being a major oil producer. After years of underinvestment and mismanagement, its state refineries produce hardly any gasoline.

For decades, the national soundtrack has been the hum of small generators, fired up during daily power outages. Petroleum products move goods and people around the country

Until recently, the government subsidized that petroleum, to the

tune of billions of dollars a year.

Many Nigerians said the subsidy was the only useful contribution from a neglectful and predatory government. Successive presidents have pledged to remove the subsidy, which drains a hefty chunk of government revenue — and later backtracked fearing mass unrest. Bola Tinubu, who was elected Nigeria's president last year, initially

followed through. "It was a necessary action for my country not to go bankrupt," Mr. Tinubu said in April, at a meeting of the World Economic Forum in

Saudi Arabia.

Instead, many Nigerians are going bankrupt — or working multiple jobs to stay afloat.

Mr. Garba, the hospital worker, used to be solidly middle class, even though 17 family members, including 12 children, depended

After shifts at the hospital, where he is setting up the first statewide  $\blacksquare$ ambulance service in addition to working in the emergency room, for which he is paid \$150 a month, he heads to the Red Cross. There he occasionally receives a \$3.30 volunteer stipend for helping tackle a severe diphtheria outbreak.

At night, he works at the pharmacy that he and a colleague set up. But few people have money for medicine anymore. He sells about \$7 worth of medication per day.

Last year, Mr. Garba sold his car when the gas subsidies were

removed, and now takes a *tuk-tuk* to work. Unable to power the generator, he reads medicine labels at the pharmacy by the light of a small solar lantern. He can only afford to buy rice and cassava in small quantities.

Life under the previous government was very expensive, he said,

but nothing like today.

"It's very, very bad," he said.

It's gotten so dire that there have been several deadly stampedes for free or discounted rice distributed by the government—including one in March at a university in the central state of Nasarawa where seven students were killed.

Mr. Tinubu promised to create a million jobs and quadruple the size of the economy within a decade, but has not said how. The International Monetary Fund said last month the state has started subsidizing fuel and electricity again — though the government has not acknowledged this.

"There's still very little clarity — if any — on where the economy is headed, what the priorities are," said Zainab Usman, a political economist and director of the Africa Program at the Carnegie Endowment for International Peace.

### Tapping Craze

A spate of new crypto-mining games that promise to generate income the more the user plays has people across Nigeria spending all day tapping on their smartphone screens, desperate to earn a few

People tap as they pray, in mosques and churches. Children tap under desks at school. Mourners tap at funerals.

There's no guarantee any of them will ever benefit from the hours

they put in mindlessly tapping.

Then again, they can't count on the national currency, the naira. The government has twice devalued the naira in the past year, trying to enable it to float more freely and attract foreign investment.

The upshot: It's lost nearly 70 percent of its value against the dollar. 🛛 Nigeria cannot produce enough food for its growing population; food imports rise 11 percent annually. The currency devaluation caused those imports — already expensive because of high tariffs to explode in price.

Nigerians can become paupers almost overnight. So they're searching for anything that might hold its value — or ideally, get them rich.

"People are looking for me everywhere," said Rabiu Biyora, the undisputed king of tapping in Kano, opening one of his five foldable phones to add to his 2.7 billion taps on the TapSwap app. "Not to attack me, but to collect something from me."

A relaxed, businesslike 39-year-old followed everywhere by young

tech-savvy acolytes, Mr. Biyora would only say that he made "over \$10,000" from the previous tapping craze.

He profits from everyone else's taps, so he encourages them in posts on social media, and by providing free internet to anyone willing to sit outside his house. Nigerians don't need much encouragement — despite the risks and volatility, Nigeria has the second highest cryptocurrency adoption rate in the world. So every evening, struggling young men gather by Mr. Biyora's

Pleas for Help
In much of Nigeria, it's normal to share with your neighbors and give alms to the poor.

Every day, people come to the gate of Kano's Freedom Radio station to drop off sheets of paper containing heartfelt appeals for help paying medical bills or school fees, or to recover from some

A radio presenter chooses three to read out daily, and often a sympathetic listener calls in to pay the supplicant's bill. But lately the appeals have multiplied, and offers of help have


dried up. Good Samaritans used to come to the E.R. and pay strangers' bills for them, Mr. Garba said. That rarely happens now either.

Still, Mr. Garba said, the number of patients coming to his hospital has almost halved in recent months. Many of the sick never even make it. They can't afford the 20-cent

It was gathered that Saudi hospitals within the area were busy attending to patients, while further emergency calls to health officials were overwhelming as some calls could not get immediate responses.

Head of Emergency Unit, through the Saudi Ministry of Health, Al-Shalhoub, said the 911 center in the Makkah region received a total of 78,872 calls on Sun-

The sun yesterday had

reached all time high of 47-48 degree Celcius, with a prediction that it would rise

further in the days ahead. Most pilgrims whose tents are located at the end of Mina, would have to walk 2.8 kilometres, an average of 90-105 minutes to Jama-

A pilgrim, who witnessed some of the incidents on the way to Jamarat from Mina, said: "I saw many of them falling asleep, a result of the heat, when I was walking to Jamarat. Mostly affected were the elderly and young non-Arabs, Europeans and Indians. Some died while some were rushed to the hospital.

"In fact, the police and the ambulance services were overwhelmed with the number of cases related to heat-

"Many were seen lying down with people offering first aid assistance mostly within a distance of 500

"Confirming the incident, Saudi Ministry of Heath also on Sunday, put the number affected by heat strokes and exhaustion at 2,764 pilgrims, blaming the development on non-adherence to instructions of drinking water and using the umbrella.

"The number of cases of heat exhaustion and sunstroke reached 2,764 cases during this day alone as a result of some pilgrims not adhering to the instructions.

'We recommend campaign organizers to guide and educate pilgrims to adhere to the guidelines and protect them from exposure

to any heat stress.

"Physical stress will lead to heat stress, and rest and spacing between performing rituals is important." Saudi Ministry of Health

### Saudi bans going out at peak time: 11am-

Meanwhile, the country's Ministry of Hajj and Umrah has banned going out from 11am to 4pm for the ritual of throwing pebbles.

This was contained in a memo issued to all heads of Hajj participating missions in Makkah yesterday.

The directive, titled "Urgent Notice to All Hajj Office Heads,", read: "By the directives of His Excellency, the Deputy Minister of Hajj and Umrah, and to ensure the well-being of pilgrims amid high temperatures and to prevent heat stress, the following measures have

implemented:""Pilgrims are prohibited from proceeding to the Jamarat Bridge for the ritual of throwing stones from 11 am to 4

"Security personnel will be stationed at camps to enforce this restriction and prevent any pilgrim from departing before 4 pm.

The Office of Hajj Affairs and service providers are tasked with ensuring compliance, and they will bear responsibility for any violations thereof."

### Measures towards reducing the effect

Saudi Arabia's measures towards mitigating the heat strokes include extensive cooling systems, both manual and automated water sprinklers strategically mounted along Jamarat-Mina road.

Some pilgrims also use rechargeable and batterypowered neck and handheld fans in their determination to offset the challenging conditions brought by the

There are also portable fans procured by individual pilgrim for personal cooling in crowded areas.

# LG autonomy: We'll await Supreme Court's decision, says Senate

BUJA: The Senate has Asaid it would await the decision of the Supreme Court on the contentious issue of local government autonomy before fashioning out the way forward by taking a fresh look at existing

Chairman of the Senate Committee on Media and Public Affairs, Yemi Adaramodu, said this in an interview in Abuja yesterday.

He explained that the upper chamber of the National Assembly was currently constrained and was not in a position to present an opinion until the Supreme Court made a pronouncement.

Adaramodu, however, noted that there was a time in the nation's history when local governments were largely autonomous but noted that a time came when those at the helm of affairs saw things differently . He noted that some people had raised concerns about the revenue allocation formula via-a-vis the issue of equity among other issues.

The Senate spokesman said: "We might not be able to say much about it (LG authonomy) but then, we are talking about distributiing funds to local governments.

'There are indices that inform the distribution of funds to local governments. Equality, land mass, social indices. So, when we talk about one of seven of the schools in Akure, that's social indices. That is where they indicate how many hos-

"How many dispensaries? How many primary schools? How many junior secondary schools? Then population. So they distribute based on that. So, definitely there's a local government that has only one primary school, and there's another one that has 37 primary schools that are not going to get the same thing because of that formula. So just for education.

"But for local government autonomy, we'll not discuss further until the Supreme Court rules accordingly. When the Supreme Court rules, then the National Assembly will know where to take it from , whatever the ruling is.'

# FG denies renaming Murtala **Mohammed Way** Abuja after Soyinka

ABUJA-THE Federal Government has de-bunked the report that the Murtala Mohammed Way, Abuja, has been renamed af-ter the Nobel Laureate, Professor Wole Soyinka, saying such name change has never been contemplated by the ad-

ministration.

It explained that during the inauguration of a new road in the Federal Capital Territory, FCT, Abuja, codenamed Arterial Road N20 (from Katampe to Jahi), the FCT Minister, Barrister Nyesom Wike, proposed to the President that the road be named after Prof Wole Soyinka, and the President agreed.

In a statement issued by Rabiu Ibrahim, Special Assistant (Media) to the Minister f Informatión and National Orientation, the government urged Nigerians to disregard any misinformation regarding the renaming of the Murtala Mohammed Expressway, describing the report as entirely false that existed in the imagination of its purveyors.

The statement read: "We

The statement read: have noted the rumours being circulated that the Murtala Mohammed Expressway in the Federal Capital Terri-tory, Abuja, has been renamed as Wole Soyinka Way. "The re-naming of the Murtala Mo-hammed Expressway Way has never been contemplated by this administration.

For the record, on June 4, 2024, President Bola Tinubu inaugurated a new road in the FCT, codenamed Arterial Road N20 (from Katampe to Jahi), which links the existing outer northern expressway (also known as Murtala Mohammed Expressway) to the Northern Parkway (also called Ahmadu Bello Way).

"During the inauguration of the N20 (which is a new road), FCT Minister, Barrister Nye or Wike, proposed to the President that the road be named after Prof. Wole Soyinka, and the President agreed.

# Tension in Prisons over rising food inflation

BUJA: The increasing Acost of food stuffs and gas has led to grumblings among some inmates in the nation's various prisons.

Relatives of some inmates who confided in *Vanguard*, noted that the rising cost of foodstuffs has impacted negatively on their wards behind

They are, therefore, asking state governments to liberalize bail conditions for petty crimes in a way that offenders could easily meet their bail conditions and attend trial from home.

Nigeria currently has 256 prisons with 81,647 inmate population as of May 31,

This is made up of 5,853 for federal offences, comprising 3,774 pre-trial detainees and 2,079 convicts, while those for state offences are 75,794, comprising 51,934 awaiting trial and 23,860 as convicts.

Recall that in 2021, the federal government had after a sustained public outrage, reluctantly increased the feeding allowance per inmate from N450 to N750 daily.

It was gathered that when taxes, cost of gas and profits for the food vendors are taken from this N750, the actual amount used for feeding an

N750 now inadequate to feed one inmate per day

inmate in a day could be less than N500.

"The slow response to adjustment of allowance for feeding inmates is actually worrisome. It is perhaps trite to say that the price of most commodities in Nigeria, especially food, has gone beyond the reach of the average Nigeri-

"As if this is not enough, one gets petrified that with this economic reality, the management of the Nigerian Correctional Service is still expected to feed inmates with  $N\overline{7}50.00$ per day, including vendors profit and tax.

"If the government would spend N700 on a little child of less than 10 years just for one meal as part of its school feeding programme, a child who probably ate breakfast before going to school and who would still eat dinner, you can imagine the implications of feeding a full grown adult who is incarcerated with N750 for a three square meal daily," said a top security personnel who did not want his name mentioned in the report.

Expressing fears of possible protests by some of the inmates, he said the situation could force some personnel to compromise security, especially with regard to "traffick-

He added: "The spirit behind legal internment of individuals, whether as suspects or convicted offenders, is to promote societal peace. This is in the understanding that some persons do not have the capacity to interact with others within civil boundaries, thus requiring the law to keep them out of circulation.

"It could also be to avoid tampering with the justice

process while cases are on trial or, to serve as deterrent for convicts as well as would-beoffenders. Sometimes, incarceration also protects offenders from a vengeful society, among others.

"However, contemporary practices in the management of persons denied of their liberty requires that such persons are kept humanely safe and basic needs for survival provided by the captors.

"A growing concern about the Nigerian Prisons Service is the 'inadvertent forgetfulness' of the Nigerian government to make the most basic provisions for the upkeep of its prisoners in accordance with prevailing economic ecosystem.

A 62-year-old retired civil servant, Sunday Jegede, who said his son was being remanded in one of the prisons in the south, faulted state governments for their lack of interest in Prisons.

"There is no doubt, state governments have shown no decorum in the use of incarceration for all manner of crimes in their jurisdictions and literally abandoning the inmates after remand, thus exacerbating the over-population phenomenon and the accompanying menace.

"This, more than anything else, justifies the decision by the federal government to transfer the burden of state offenders, which is over 85 per cent of the inmate population to states.

"But given that state governments do not have the capacity to provide for these persons, why can't they embark on massive decongestion of prisons, as against the tokenistic release of five to eight persons by visiting chief judges?

"Why can't they liberalize bail conditions to enable inmates attend court sessions from their homes, at least, for minor crimes? Why can't they even expedite trial processes so that the convicted population can be taken to farms to work and augment their up-

"We must realize that societal progress is a function of the level of safety the citizens enjoy. While chasing the criminals at large, those in custody should be kept in conditions that make them amenable to reformation and rehabilitation to promote enduring peace," he stated.





# **Lawyer faults** LASBCA's proposed demolition despite court order

AGOS—A Lagos-■based lawyer, Kenneth Odidika, has accused the Lagos State Building Control Agency, LASBCA, and the Ministry of Physical Planning and Urban Development of a plot to dispossess him of his property in the Lekki area of the state.

Odidika alleged that LASBCA has been struggling to find reasons to dispossess him and his neighbours of their properties and each time they countered their claims LASBCA would look for another reason to harass them.

The legal practitioner said: "Early in December 2022, LASBCA informed us that a certain company, Minkus Nigeria Limited (the Petitioner), is claiming that we were squatters on land. their subsequently served us with a Contravention Notice, and we successfully showed we were authentic residents. Then they said didn't Development Permits. We produced our Permits, including C-of-O and Governor's Consent which they duly acknowledged. Thereafter the Petitioner went to court to challenge our title. We responded with proof of ownership, forcing them to withdraw the case from court.

"We thought we were going to have some respite, but then again LASBCA came with the issue of building outside approved design, and fortunately for us, Governor Babajide Sanwo-Olu of Lagos State announced a 90day amnesty window effective May 2, 2024, for people to make good such shortcomings.

"We immediately applied for assessment and processing, but LASBCA refused to attend to us saying that there is a directive that they should not accept drawings and documents from the Maiyegun and Ologolo (families) for processing as the land was in dispute."





KOKORI—RESIDENTS of Kokori, Erhanaka, and Ofuoma communities in Ethiope East and Ughelli North Local Government Areas, Delta State, have lamented the agony they undergo daily journeying on the rickety and abandoned Ofuoma-Erhanaka-Kokori Road with a bridge constructed with planks.

They called on the governor, Rt. Hon. Sheriff Oborevwori, to reconstruct the road, saying that a former governor, Chief James Ibori, awarded a contract to a contractor to rebuild the road, but the outworker deserted the job after collecting money.

Twenty-five-year-old Kokori indigene, Precious Igho, carrying cassava stem for planting and her baby on a motorcycle, told NDV: "The road has been like this since I was born. I grew up to meet it like this. The politicians will come whenever they have something to do, change the planks on the bridge, then, claim that they had fixed the road.

"If they want to do this road, they should be serious about it. We are still passing it now but when it rains heavily, people suffer so much and cannot go to farm again. The government should address this road problem because those passing through it suffer so much."

An irate Kokori inhabitant, Mrs. Oyovwe James, bemoaned: "The whole road is destroyed. There is nothing you tell the leaders about it that they listen to. We pray that the government of the day be good and answer our prayers, if

not, we know our government is bad.
"Whenever you mention the road, the politicians will use deceptive methods and tell those leading that the road has been fixed. We have been suffering bad roads in the whole of Kokori town. Go round and you will see how terrible the

"There is no single good road in the town, the whole place is bushy and we suffer to get to our farms. We have cried out but no one seems to be listening.

"The government awarded the contract for the road before but they did not do anything about it. If you pass the road down to Kokori, you will see the level of deprivation and wonder if we are part of the state. We cry every day about this road, we want development in

Kokori is an ancient town and ought not to be as it is today. We are not happy with the current state of the community, and its backwardness, it is a pain to us. We call on the government to reconstruct the road and end our suffering.

# **Shattered condition**

A Kokori dweller, Mr. Stephen Oghenevwoke, stated: "The condition of the road is very bad. I do not know what is delaying the reconstruction of this road. But if the government can look inward and get this road done, it will help us. Everyone will tell you that the prayer of the Kokori people is for the road to be done. If this is the only project done for the Kokori people, they will be grateful. The government should come to our aid and construct this road. Honestly, the road is in a bad state.

"Sometimes, because of the nature of the road, people go through the Awirhe community of Agbarha to get to their farms. This is a short road linking Ofuoma, instead of spending 10 minutes, you spend hours because of the bad

### Road in a complete mess

-Erekahwevwe, farmer

A Kokori farmer, Mama Florence Erekahwevwe, asserted: "The road is a complete mess as it is and even worse during the rainy season. We cannot pass through to our farms during the rainy days. We have managed for a long time, but it is worse now.

"We complain daily but no one hears us. The poor state of the road is making us frustrated because we will not be able to pass in the next month. During the rainy season, the bridge area is flooded and no one can pass, causing the people

"When we cry and tell them that the contract was awarded in the past, they do not listen to us. If you get to the Kokori end of the road, you will see abandoned vehicles and equipment of the contractor which they left behind. These were supposed to be used in the construction some years ago.

"They abandoned it and went to Asaba to say they had executed the contract. Thank God you (NDV) are here today, and have seen for yourself. We cannot pass the road to our farms

during the rainy season and face severe hunger. This is the only route through which we go to the farm. We are farmers and do not have other jobs to sustain ourselves.

"This is the shortest route for us to get to Ughelli, we plead that the government reconstructs the road. The time it will take you to get to Ughelli from Kokori, you spend it going through other communities.

"Do you know that to get our farm produce from Erhanaka to Warri, people go through Ughelli and Ofuoma because of this bad bridge, instead of passing Kokori that is shorter? The road is important to us, we need help to boost our food production.'

### Why we are apprehensive

—Ayimogu, an elderly woman

An aged woman, Mrs. Florence Ayimogu, carrying a cassava load on her bicycle, said: "This is the route to Ofuoma and our farms, it also connects Odovie community. Since the collapse of this bridge, we have become apprehensive about how we can cope. We are afraid because this is the only road through which we earn our living.

"We have prayed and cried for this road to be fixed. During the rainy season, we cannot pass this dilapidated bridge. The water level in the bridge area is impassable. We have been suffering, we will be eternally grateful if it can be fixed."



# AKWA IBOM... **LAND OF PROMISE**

T JYO—NATIONAL President of the Host Communities of Nigeria Producing Oil and Gas, HOSTCOM, Dr. Benjamin Tamaranebi has revealed that the settlors (oil companies) have funded 70 Host Community Development Trusts (HCDTs) accounts with N80 billion from the annual three per cent Operational Expenditure (3% OPEX), as stipulated in the Petroleum Industry Act, PIA 2021.

Dr. Tamaranebi, who said the money was for the communities to embark on projects that would stand the test of time, disclosed this at a town hall meeting to sensitize impacted communities of Akwa Ibom and Abia states in Uyo, capital of Akwa Ibom.

Leaders of HOSTCOM, the Nigerian Upstream Regulatory Commission, NUPRC, HOSTCOM Projects Management and Advisory Consult Limited, and stakeholders from various communities attended the sensitization workshop.

### New Beginning

Speaking at the event, the HOSTCOM national president said that the settlors have funded 70 HCDTs accounts with over N80 billion, and urged the communities to use the funds for schools, roads, solar panels, and other specified projects.

He appealed to the stakeholders, especially the members of the Board of Trustees, BOTs, to judiciously execute the plan of their respective Trusts, in line with the provisions of the PIA 2021.

His words: "We went to the National Assembly that we want to manage our resources ourselves. And now that the annual three percent OPEX funds have started coming, we must manage the resources wisely. These funds will not be coming forever. The integrity test is before you, so live up to expectations. Do not misuse the funds so that more

"As stakeholders, go back home and think of sustainable projects to develop your communities. You must embark on sustainable projects, and put up structures that can stand the test of time like clinics, schools, roads, and solar panels to effectively utilize the funds.

### Our govs failed us

"We were in this struggle for years, the host communities producing oil and gas were deprived of their God-given wealth. The government did little for us, they created 13 percent derivation for host communities' development, but the governors hijacked the funds. They did not make good use of the 13 per cent derivation.

"They did not impact the affected oil and gas communities. Former President Olusegun Obasanjo had directed that the funds should impact communities producing oil and gas which were devastated and deprived. But whoever becomes the governor of any state decides how the derivation funds will be

### NDDC went the same way

"Sometimes, this money is not seen as oil-bearing communities' funds, but as their statutory allocation. It was based on this that we decided that we could not sit tight, we started pressuring. Then, the Federal Government said fine, let us see what we can do. They came up with Niger-Delta Development

"We thought that through the NDDC, our communities would develop, but the story was not different from the 13 per cent derivation. So, the communities now said no we need 'self-funding'. But instead of giving us self-funding, they said okay, the youths were making noise, let us see how we can pacify the youths. And they came up with the Presidential Amnesty Programme."

### We must not fail ourselves

Stressing that the participants, including traditional leaders, should understand why they must not fail in implementing the three per cent OPEX to host communities, he said: "For communities that have formed their HCDTs, the funds have been paid to the Trust for 2021 and 2022. That is what we have advocated; that we must develop our communities ourselves. That is the message we have come to give to all of you today.

"The BoT members should work closely with your respective communities. The complaints reaching us from many states is that BoT members now want to be like local government chairmen. Please let the not be in vain. People fought and sacrificed for our communities to develop

"As a BoT member, you are called to serve, you are to look at the projects initiated for your communities and ensure judicious execution of the plan. Until now, some host communities have not formed their HCDT because of litigations and other issues. In this case, it is not the oil companies that are delaying the process and development of our community. We caused the

# **CROSS RIVER...** THE **PEOPLE'S PARADISE**

N YANGASSING RESIDENTS of Nyangassng Community, a densely populated semiurban area in Calabar, Cross River State, and the Calabar Zonal Office of the Port Harcourt Electricity Distribution Company, PHED, are at each other's throats over the cutting off of power to the community.

NDV learned that over 500 households in the area were plunged into darkness since the last week of April when PHED officials disconnected the damaged transformer supplying voltage to the area, instead of effecting necessary repairs.

### Rubbing salt on injury -Eyo, community leader

A community leader, Chief Baron Eyo, who spoke on the plight of the residents, said: "We started experiencing abnormal voltage around March. Sometimes, it will go up to 280kva, then drop as low as 80kva in one swoop. Findings revealed that the neural phase from the transformer was burnt and needed to

"We called the zonal manager of the PHED, Mr. Gabriel Modupe, and notified him of the issue. He promised to address it immediately. Each time we called to remind him, he said the maintenance team was coming.

"We mobilised ourselves to provide logistics support to the mainland team to fast-track the repairs, but we waited in vain. They never showed up.

"Disconnecting us when we are marking the anniversary of our loved ones, who died in an electrocution tragedy caused by the carelessness, negligence, and professional incompetence of PHED is tantamount to rubbing salt on a wound," he added.

# **Electricity firm did** nothing for months

months, rather, they came and removed

Traders and housewives, who spoke to NDV, lamented that the blackout has compounded the already excruciating economic realities, arising from the exorbitant cost of petrol needed to power generators for the conservation of food, perishable goods, and freezing drinks in their shops.

### PHED official lets the cat out of the bag

An anonymous PHED staff said: "Our major problem is that for many years, our headquarters in Port Harcourt has deployed nonprofessionals, mostly bankers as zonal managers. These persons lack basic elementary knowledge of electricity. Once you report faults, they hardly act, their priority is revenue generation."

Crime escalates

Checks by NDV further showed that crime, especially breaking and entry, and car battery theft have skyrocketed in the area. Many residents, including Vanguard reporters who live in the area, had lost their car batteries to thieves, who took advantage of the power

More than a few Manchester United ians were allegedly electrocuted when a high-tension cable snapped and landed on the roof of a viewing center during a Europa match, after a heavy explosion from the said transformer.

Police statement indicated seven died while others suffered severe electrical burns. Members of the community contested the death toll, insisting that over 20 died.

# Activist slams govs for rejecting N60k minimum wage

SABA: A human Arights advocate and lawyer Chief Malcolm Omirhobo, has said that the N60,000 minimum wage that governors, under the auspices of the Nigerian Governors Forum (NGF), refused to pay workers was not up to the lunch money of a governor.

Omirhobo, who disapproved of the NGF's stance, stated yesterday, "I beg to differ with the governors under the aegis of the Nigeria Governors Forum (NGF) for rejecting the proposed N60,000 minimum wage for Nigerian workers as too high, not sustainable and realistic.'

"What are we talking about? The paltry sum of N60,000 in monthly wage for a worker, which they rejected, is not up to the lunch money of a state governor.

"If only NGF can be honest with itself, some state governments can afford to pay N100,000.00 minimum wage to their workers, not to mention the proposed N60,000 minimum wage, which is not up to the lunch money of governors.

"If every state taps and explores its human and natural resources, no state is poor. However, many state governments are not visionary and do not think outside the box or venture outside their comfort zone.

"Again, our governors are transactional and transformational in their approach to governance, which gives room to maladministration, misappropriation, massive looting of public

# LG polls: **Party** primaries in **Kwara holds** on June 24

# Makurdi residents fume over power outages, crazy bills • Jos DISCO blames outages on technical issues,

AKURDI — RESIDENTS Makurdi, the Benue State capital, have raised the alarm over the outrageous monthly electricity bills they receive from the Jos Électricity Distribution Company, JED, despite the poor power supply from the firm.

The residents also lamented the alleged unimpressive services they get from the company including several days of power outage without explanation from officials of the company.

They appealed to the Federal Government to call the company to order as it had allegedly capitalised on the increment on Band A tariff to effect blanket increment in charges on all electricity consumers even without commensurate power supply.

Some of the residents including artisans, traders and civil servants who voiced their concern on the issue in Makurdi could not hide their pains lamenting that they were paying outrageous electricity charges for services not rendered.

According to a barbing salon owner along George Akume Way,

New GRA, who identified himself as Odima, he was charged over N22, 000 in the month of May when he did not enjoy up 50 hours of electricity supply in the

He said, "the bill I got for May was over N22, 000 even when we did not enjoy up to 50 hours of electricity supply in the month. It is unacceptable. It is as if nobody is regulating and monitoring what JED is doing. We are completely at their mercy. We are paying for darkness not

Also, a civil servant who lives in the High Level axis of the town, Mr. Jethro Abo, who apart from lamemting the epileptic power supply in the area, said, even when we have faults on the lines and you call them to come and rectify the problem it takes them days to respond. But at the end of the month you get a bill as high as N30, 000 for a tenant of two bedroom apartment.

'One begins to wonder how they arrived at that and how they expect us to pay for that kind of

crazy bill. Is it that the company has capitalised on the increment on Band A Tariff to effect blanket increment on all electricity charges? That is why Labour is insisting that the increment should be reversed. We are being made to pay for electricity that we did not consume.

"In fact it is becoming obvious that the privatisation of the power sector was done in error. Power supply and maintenance services were obviously better under NEPA. We are now paying very high bills without commensurate electricity supply. We appeal to the President Bola Tinubu-led Federal Government to reverse the privatisation of the power sector as it has completely failed to achieve the purpose for the sale.

Reacting, the Regional Manager of JED in Makurdi, the Regional Ojochide Agbata, posited that the review of electricity tariff was not peculiar to Makurdi "and it is only for the Feeders on Band A who had their electricity tariff reviewed upward. Moreover Distribution Companies do not have the authority to review tarrifs. Consumption is also a factor in determining bills. When you consume high you pay high and when you consume less you pay less, that is the truth."

# Sense and nonsense of Nigeria's economic crisis

TIGERIA is probably in the worst eco nomic crisis of a generation, screamed The New York Times on June 11, 2024. Two other influential global publications, Foreign Affairs and The Economist, had earlier said the same thing under different headlines. Although Nigeria's economy is not yet in a recession, all other economic indicators have gone south, and the curve is not bending in the short run.

Statistics on inflation (above 33%), youth unemployment (above 50%), poverty levels (over 133 million multidimensionally poor), the value of the Naira (over 200% decline against dollar in the past year), education (18.3 million out of school children), healthcare (inadequate health facilities and professionals), insecurity (144th position in the 2023 safest countries in the world ranking), and homelessness (24.4 million people without a home) are frightening. More than ever, Nigeria needs crisis leaders to

turn things around.

Great leaders have always come up to guide their countries out of the worst crises throughout history. The American people looked up to Barack Obama in 2008 to lead the nation through its worst economic crisis since the Great Depression. He conducted many consultations and made critical but well-considered decisions to lay a new economic foundation. We are in an "economic war' and cannot use the tools applicable in normal times.

Leadership during normal times is different from leading in the storm which is the subject of my forthcoming book. The expertise and skill set required for both cases are different. The dynamism and multiplicity of socio-economic and political factors converging to create the Nigerian volatile ecosystem are such that effective crisis leadership is needed at all governance strata.

Although required in normal times, these crisis leadership competencies are most relevant during a crisis. They include sensemaking, effective decision-making, team coordination, facili-tating learning, emotional intelligence, and effective communication. It is the masterful use of these competencies that makes great crisis lead-

The commentariat has attributed our present economic crisis to a cycle of thoughtless policies, squandering as governance, negative or low investment in innovation, uncoordinated economic thinking and placing of politics above commonsense economic frugality. It is also true that our poor understanding of the interplay of global events and their impact on local economic factors also contributed. The consequence is

the country's inability to respond to vulnerabilities, shocks and opportunities.

Nigerian leaders need to make sense of these complex circumstances. The situation requires a more focused perspective on historical and immediate causes and possible solutions to the current crisis. Sensemaking is critical to effective crisis leadership, especially in complex and diverse environments like Nigeria. Sensemaking involves gathering information and putting it in context, exploring different perspectives to develop a coherent narrative, and interpreting and understanding complex, ambiguous, and rapidly changing situations to guide decisionmaking and action. During this economic crisis, sensemaking allows leaders to comprehend its scope, identify its root causes, anticipate its impacts, and develop appropriate responses. This piece will focus on and explore sensemaking as the first step in crisis leadership.

Our leaders must develop a contextual understanding and historical context of our economic crisis. Nigeria is characterised by significant cultural, ethnic, and economic diversity. Effective crisis leadership requires leaders to understand these complexities, how they influence the crisis, and the potential responses. Economic crises in Nigeria often have roots in historical issues such as colonial legacies, policy missteps, structural inequalities and global turbulence. Leaders must consider these historical contexts to grasp the crisis's nuances fully. They must identify and interpret economic, social, and political signals.

Furthermore, the way our leaders frame this economic crisis matters. We often tend to reduce complex issues to one or two narratives. This is what my Kellogg Professor, Loran Nordgren calls "narrow framing". Based on the robust content analysis we carried out, we identified the dominant frame of this economic crisis by the government as 'inherited and requires tough actions that will cause some pain to the citizens in the short run, but the pain is necessary for achieving better economic prosperity in the medium to long term'. The danger of this framing is that it sounds more like an excuse than a creative strategy to upturn our economic woes. This frame lulls our leaders to the proverbial sleep of inertia – inaction when there is fire on

How this economic crisis is communicated to the public and stakeholders influences their perceptions and reactions. Effective crisis leadership involves framing and communicating the situation in an understandable and actionable way for diverse audiences. Little wonder Nigerians are at a loss regarding our political class' perceived poor choices. The government needs to rethink its crisis communication strategy.

Since economic crises are by their very nature dynamic and unpredictable, leaders must update their understanding of the issues, mod-

ify their response strategy and adapt their strategies accordingly. Involving various stakeholders, including experts, community leaders, and affected populations, enriches the process, and ensures more comprehensive insights. This comprehensive insight allows crisis leaders to make informed decisions that cater to the greater good. Things like the government being more prudent, quitting luxury spending, reducing taxes to encourage savings and investment fixing insecurity to encourage inflow of investment and borrowing less from external sources, are easily intelligible choices.

To illustrate the importance of deep insight in Nigerian leadership during the economic crisis, let us examine three recent crises. The first is the economic recession of 2016. The 2016 recession was triggered by a significant drop in oil prices and compounded by policy challenges and security issues. Our leaders needed to interpret the interconnected causes, including global oil dynamics, domestic economic policies, and securify concerns in the Niger Delta. The Economic Recovery and Growth Plan, ERGP was developed as a response, focusing on diversification and stabilisation. While the ERGP provided a strategic framework, the process highlighted the need for consistent policy implementation and addressing underlying structural issues. This still needs to be done and our leaders have yet to learn any lessons they could apply in subsequent crises.

The second is the current economic crisis that

has been exacerbated due to the implementation of fuel subsidy removal policy. Every Nigerian knows the need to remove fuel subsidies, but it takes work. Periodic attempts to remove fuel subsidies faced public resistance due to their impact on living costs and inflation. Our leaders needed to balance fiscal sustainability with socio-economic impacts. Understanding public sentiment and economic realities was crucial in framing and communicating subsidy reforms. Subsidy removals were often met with protests, highlighting the need for transparent communication, phased implementation, and


accompanying social protection measures.

However, the hurried end of the subsidy without mapping the multiple scenario implications and making adequate provisions to cushion the impact threw our economy into a whirlwind of desperation, and the repercussions have been devastating, as indicated in the above economic statistics. Developing multiple scenarios based on different interpretations of the crisis helps prepare for various potential outcomes

**S** noted by Gerald Ep Astein, Professor of Economics, University of Massachusetts, Amherst, USA, central banks in developing countries have powers to promote economic growth by adopting the policy of "Controlled Expansion" of bank credits to undertake direct financing of development projects. He further noted that central banks frame their monetary and credit policy in such a way that larger and desired quantities of bank credit go to primary sectors such as agriculture, small industries, export trade, corporations, etc.

Development financing played a significant role in accelerating industrial development in India. India has been methodical in driving economic development. After 1991, the country phased out Development Financing Institutions, DFIs, and established new institutions, including the National Investment and Infrastructure Fund, NIIF, to focus on funding infrastructure.

Governor, Central Bank of Nigeria, CBN, Olayemi Cardoso, has been decisive in his policy options and tried to roll back and streamline the functions and operating

frontiers of CBN to minimise wastages and increase efficiency.

Cardoso, swiftly abrogated development financing and intervention funds for agriculture and other sectors which were established by his predecessor. Some of the intervention funds of CBN include, the Anchor Borrower's Programme, ABP; Commercial Agriculture Credit Scheme, CACS; Accelerated Agriculture Development Scheme, AADS; Maize Aggregation Scheme; Paddy Aggregation Scheme and Private Sector-led Accelerated Agricultural Development Scheme, and others.

CBN had noted that the intervention schemes were established to improve local food production, reduce food import bill and conserve foreign reserve. Due to the absence of vibrant capital and money markets in developing countries, central banks in developing countries are expected to fill the funding gap by performing both the traditional and non-traditional functions and using development financing as a tool to accelerate economic growth and adapt and for the reduction of poverty and income inequality.

Cardoso stopped develop-

ment financing because of the magnitude of the outstanding debts from the interventions schemes, especially the Anchor Borrower's Programme, ABP, which was established in 2015. The IMF reported that 76 per cent of loans under ABP were unpaid, only 24 per cent were paid.

Reportedly a total of 4.67 million farmers in various crops were involved in the

programme and about N1.12 trillion was disbursed to 563 anchors. The sum of N670.4 billion was repaid

leaving an outstanding of N450.90 billion. The development is not encouraging and which is a good reason for the discontinuation of development financing by Cardoso so that CBN could focus on its core mandates. But it is noteworthy that the Anchor Borrowers Programme reawakened the interest of many to return to farming.

Cardoso and his team also launched a wild fight against inflation with the quantum hike in the Monetary Policy Rate, MPR, by 400 basis points, from 18.75 per cent to 22.75 per cent and further to 24.74 per cent, and presently to 26.25 per cent.

The CBN Governor acknowledged the necessity for a trade-off between spurring economic growth and implementing the inflation targeting policy. All over the world, central banks are obsessed with inflation and they deploy significant amount of resources to fight inflation to ensure price stability.

Inflation creates many negative impact in the economy. As CBN noted, inflation devalues currency, discourages long term plantnings and reduces savings and capital accumulation. It

also reduces investment, creates shifts in the distribution of real income and consequent misallocation of resources, and uncertainty and distortions in the economy

Present inflation is costpush, there is a general increase in the cost of production, and also because of expansionary fiscal policy. It is widely believed that the previous government increased money supply by Ways and Means and foreign debts, at a rate greater than the growth rate of the GDP. Other causes of inflation include disruptions in the supply of food products and increase in pump rate of fuel.

CBN is working hard to find lasting solutions to the problems of the economy. Cardoso and his team have reset policy tool kits towards ensuring stability in the short to medium term.

Efforts should also aim at increasing the supply side of the economy. It has been noted by experts that it is the supply side production potential that gives an economy the energy to grow without suffering from acceleration in cost and price inflation.

democracy some 25 years ago. The question is: has he continued in that light since he became a full-fledged politician? Has he lived up to the ideals which he demanded as an activist?


Never in the 25 years of our renascent democracy have we witnessed the quantum of impunities such as abductions and brutalisation of journalists and other citizens as in Tinubu's first year in office. Journalists are now abducted and detained for alleged offences that could easily have

President Tinubu must walk his talk.





A<sup>T</sup> the backdrop of the escalating cost of living crises, the National Bureau of Statistics, NBS, has released the long awaited 'Gross Domestic Product (GDP) Report by Expenditure and Income Approach', the first since second half of 2023, H2'23, showing negative shift in household consumption expendi-

The report covering third quarter and fourth quarter 2023, indicated that Nigerian households reduced their consumption expenditure Year-on-Year (YoY) to -13.7 percent during the period from -12.47 percent in Q4'22.

The period covered by the report is approximately six months into the fuel subsidy removal and exchange rate floatation regime, the two policies that drove price instability in the economy.

The decline in household consumption expenditure reflects the sustained upward pressure in the prices of goods and services during the period which lingers till now, also indicating that the consumption expenditure index is expected to have gone down further by now.

The NBS report stated: "Household final consumption, in real terms, grew by -10.12 percent and -13.68 percent in Q3 and Q4 of 2023 respectively, on a YoY basis.

'Moreover, these growth rates were lower compared to the growth rates of the corresponding quarters of 2022 which stood at -5.83 percent and -12.47 percent.

"The observed trend in recent times indicates that real household consumption expenditure declined since Q2 of 2022 but improved in Q2'23 when the growth rate was 7.08 percent.

"However, household consumption expenditure declined in the subsequent quarters of Q3 and Q4 of 2023, accounting for negative growth rates of -10.12 percent and - 13.68 percent.

'The growth rates of Q3'23 and  $Q\check{4}'23$  indicate lower rates relative to the corresponding quarters of Q3'22 and Q4'22.

"On a quarter-on-quarter basis, real household consumption expenditure decreased by 5.13 percent in Q3

of 2023 and declined by 1.4 percent in Q4'23.

"Household consumption accounted for 56.8 percent of real GDP at market prices in Q3'23, and 50.4 percent in Q4'23." According to NBS, the GDP at market prices grew YoY in real terms by 2.54 percent in Q3'23 and 3.46 percent in Q4'23.

"This shows a sustained positive trajectory of the growth of the economy.

"This indicates a rise of 0.3 percentage points from the figure recorded in Q3'22 which was 2.25 percent and 0.05 percent points fall compared to Q4'22 growth at 3.52 percent.

"However, on an annual basis, GDP grew by 2.74 percent in 2023, a decline of 0.36 percentage points from the growth reported in 2022 (3.1 percent).'

# Nigeria's oil output rises marginally to 1.46mbpd

Contrary to 1.7mbpd given by Ministry, NNPCL

Tigeria's total oil output increased marginally by 1.45% in May 2024 to 1.46 million barrels per day (mbpd) up from 1.44 mbpd barrels per day in April.

However, this marginal gain fell short of the country's OPEC quota of 1.5 million barrels per day and the 1.7 million barrels per day benchmark set for the 2024 national

The latest production figures from the Nigerian Upstream Petroleum Regulatory Commission (NUPRC) contradict claims by Minister of State Petroleum Resources (Oil) Senator Heineken Lokpobiri and Nigerian National Petroleum Company Limited CEO Mr. Mele Kyari that oil production has reached 1.7 million barrels per day.

This development highlights the challenges facing Nigeria's oil sector, despite efforts to increase production and meet global demand.

The data from NUPRC showed that oil production in the first five months of the year has so far failed to improve. Production in January was 1.64mbpd, February 1.54-mbpd and March 1.43mbpd.

On a year on year basis, to-tal production in May also rose slightly by 2.6 percent compared to 1.43 million barrels per day recorded over a similar period in 2023.

As part of efforts to grow the nation's reserves and improve oil production, the NÜPRC has disclosed that it would put additional oil fields on offer in the ongoing oil field licencing bid round.

According to him, "the Commission, in partnership with its multi-client partners, has acquired more geologi-cal data resulting in the identification of more prospective blocks. "In addition to these blocks, the seven deep offshore blocks from the 2022 Mini-Bid Round Exercise which cover an area of approximately 6,700 km2 in water depths of 1.150m to 3.100m shall also be concluded along with this Licensing round".

Your Excellency,

# A CASE FOR ANIOCHA/OSHIMILI FEDERAL CONSTITUENCY TO BE INCLUDED IN THE SOUTH EAST DEVELOPMENT COMMISSION

e bring you warm greetings and hearty felicitations on the Celebration of your first Anniversary as the number one citizen of our country, following the successful completion of your eventful one year in office, as the Executive President of Nigeria and Commander-in-Chief of Nigeria Armed Forces. Congratulations Your Excellency.

Mr. President Sir, it is with profound humility and a deep and sincere sense of patriotism that we write to you today, June 13, 2024, to formally request the inclusion of Aniocha/Oshimil Federal Constituency in your considerations, as you give assent to the South East Development Commission (SEDC) Bill, which is already on your table for Presidential Approval.

Recall Sir, that on Thursday, 22nd February, 2024, the Nigerian Senate passed the Bill seeking the establishment of the South East Development Commission (SEDC). In the same vein, the Federal House of Representatives had also, on December 21, 2023, at its Committee of the Whole, chaired by the Deputy Speaker, Benjamin Kalu, who is also the sponsor of the bill, unanimously passed it for a third reading and sent it to the Senate for concurrence.

Permit me to quote, with your kind permission Sir, the words of Senate President, Obong Godswill Akpabio, on the day the bill was passed after its third reading in the hallowed Chambers of the Senate: "A bill for an Act to establish the South East Development Commission charged with the responsibility of, among other things, receiving and managing funds from allocation of the Federation Account for the construction and rehabilitation of roads, houses and other infrastructural damages suffered by the region as a result of the civil war as well as tackle the ecological problems and any other related environmental or developmental challenges faced by the south-eastern part of Nigeria and for related matters 2024

"The Commission when established, will be charged with the responsibility of receiving and managing funds from allocation of the Federation Account for the reconstruction and rehabilitation of roads, houses and other damages suffered by the region as a result of the effect of the civil war in addition to ecological problems and other related environmental or developmental challenges in the Southeast states, which include: Abia, Imo, Enugu, Anambra and Ebonyi."

Your Excellency, we wish to reiterate with emphasis, some of the stipulated terms of reference and engagement of the SEDC, which states that: "This commission, when established, shall, among other functions, conceive, plan and implement, in accordance with the set rules and regulations, projects and programmes for the sustainable development of the South East states.

"The areas of intervention will include transportation including roads, health, education, employment, agriculture, industrialization, housing and urban development, water supply, electricity and telecommunications.

Other functions will include, "tackling ecological and environmental problems that arise from the extraction and mining of solid mineral, exploration of oil mineral in the Southeast states and advise the Federal Government and the member states on the prevention and control of oil spillages, gas flaring and environmental pollution; liaise with the various solid mineral extraction and mining companies and oil and gas prospecting and producing companies on all matters of pollution prevention and control; and execute such other works and perform such other functions which in the opinion of the Commission are required for the sustainable development of the South East States and its peoples."

Mr. President Sir, flowing from the above, the desire and advocacy to formally seek the inclusion of Aniocha/Federal Constituency, which is in Delta State, as a veritable geographic and demographic space to be seriously considered and accommodated within the operational purview of the South East Development Commission, SEDC, becomes even more germane and central in the collective interest of our national unity and well-being, for the under-listed incontrovertible reasons:

- 1. The geographic territory of Aniocha/Oshimil Federal Constituency, which has now morphed into the Delta State Capital territory, was the without doubt, the tragic hub of one of the most horrendous, harrowing and blood curdling collateral incidents of the civil war; the Asaba Massacre, which occurred on October 5, 1970, by Nigerian government troops who entered the Delta State community of Asaba, having driven back Biafran troops from the area and summarily executed Asaba Indigenes who had come out, gaily dressed to welcome them with songs and dance.
- 2. This singular, most horrible, genocidal incident, akin to the narrative of the second world war holocaust carried out by Nazi Germany against European Jews, witnessed the cold blooded, mass execution of between 500 and 700 townspeople who were mowed down by the Nigerian military, most lined up and shot in the town square of Ogbeosowa village. The Survivors buried the dead in pits on the site where they died.
- 3. It will therefore be to the eternal credit to you Mr. President that, in addition to the official apology, rendered by former Head of State, General Yakubu Gowan to Asaba people, the very first step towards giving effect to the policy of Reconciliation, Reconstruction and Rehabilitation (3R) enunciated by General Yakubu Gowon himself,

53 years ago, would be given practical expression during your era as President of Nigeria. Our people are yet to recover from the losses and the pains from the civil war.

- 4. Our Constituency, which provided a safe haven for many South Easterners pouring into our territory, to begin to rebuild their lives after the devastating civil war, has in the last decade also become a second home and secure abode for most indigenes and other persons, who have fled from the alarming insecurity ravaging the troubled South East states. This has certainly put so much pressure on our facilities.
- 5. It is on record that our people of Aniocha/Oshimili Federal Constituency have been fully integrated and recognized as members of Ohaneze, the apex socio-cultural umbrella body of the South East, (Igbos). One of our leaders, late Ambassador Chief Ralph Uwechue was founding Secretary General and later President General of the body, presently a lot of our sons and daughters are members of the Executive of the Ohaneze Worldwide.
- 6. We want to state categorically Your Excellency, that there is no way a development agenda for the South East will be considered comprehensively inclusive without our Constituency. Today, the Aniocha/Oshimili Federal Constituency presently serves as the single federal constituency with the highest number of South Easterners, not included/located in the geographical nomenclature of the South East region.
- 7. This has greatly limited the benefits from the Federal government to only a geographical location called South East and we believe that it is largely unfair especially given that most South easterners in Asaba and its environs have huge population that even threaten to dominate the indigenous population.
- 8. More so, even some sections of the Aniocha/Oshimili Federal Constituency have historical, cultural and linguistic similarities, ties and affinities with many areas of the South East like Ogbaru and Nteje, which are largely associated with Oko, Okwe, Asaba, Ibusa and other towns in Delta State.
- 9. Mr. President, we wish to most respectfully refer you to the establishment and operations of the Niger Delta Development Commission, NDDC and its forerunner, the Oil, Mineral Producing Areas Development Commission (OMPADEC), which not only served the interests of the core South South States, but also extended its scope of influence into the South East and South West regions, as a result of the common peculiarities shared by the states across regions. There is/are no reason(s) therefore, why benefits from such a laudable initiative like the South East Development Commission SEDC, should only be limited to the five states of South east, instead of being extended to the other areas which were also heavily impacted and are still suffering from the effects of the Civil war, 53 years later.
- 10. It is worthy of note that in these precarious and uncertain times when every even the merest which of perceived marginalization can trigger ethnic agitation and unprovoked uprising, a law which ostensibly provides benefits for the victims of the civil war, without a holistic consideration and inclusion of all those who were greatly affected by the war, may lead to uncertain agitations where original settlers may be compelled to begin to impose special taxes, levies and other draconian existential conditions on the people of the South East which may result in highly preventable conflicts.
- Mr. President, with your kind permission, We wish to, with every sense of unalloyed loyalty and sincere humility, admit that it may be out of place, particularly at this time, to suggest a change of the title of the bill to recognize the inclusivity of neighbouring communities that also carry the huge burden of increased population without provision of increased population from aftermath of the civil war, especially now that the document is already on top of your table for presidential assent.

However Your Excellency, We make bold to proffer Sir that such consideration, which you can graciously effect with an Executive Order or indeed any of the other instruments of authority at the disposal of the Office of the President can effectively articulate and give presidential effect to the inclusivity of the Aniocha/Oshimili Federal Constituency as a component beneficiary of the South East Development Commission SEDC.



# Nigerians struggle as high drug prices fuel

### healthcare

Another consultant medical practitioner, Dr. Bola Akinlolu, identified three major roadblocks to receiving good healthcare in Nigeria today: exorbitant costs for medications and treatment, long distances to reach medical facilities, and sometimes dismissive attitudes from healthcare providers.

Akinlolu emphasised that high cost remained the most critical hurdle, saying without health insurance or the ability to pay out-ofnecessary pocket, treatment or medication might be out of reach.

"Of these, the issue of high cost is the most significant, because even if the patient succeeds in getting to the healthcare facility, and there are health workers to attend to them, there is little that can be done if such patient is not covered by health insurance, and cannot pay the treatment bill out of pocket or cannot afford to buy the required drugs," he remarked.

Titilola Lawal, a registered nurse and midwife at a Lagos government hospital, blames skyrocketing medication prices as a key reason patients struggle to stick with their treatment

While acknowledging that side effects could also make treatment compliance difficult, Lawal argued that cost was the biggest hurdle.

'Several factors can affect medication adherence but nowadays, high cost is number one. Medications in general are expensive, but some prescriptions, especially 'orphan drugs' for chronic illnesses like cancer, heart disease, and diabetes, can cost millions of naira," she said.

Lawal explained that with health even insurance, the cost of these could drugs overwhelming, leading patients to skip doses or ration their medication.

She added that some patients might even start treatment but abandon it halfway when the costs become unbearable.

She expressed particular concern for patients on medication, multiple saying managing such regimens could challenging, and that high costs could increase the risk of accidentally skipped doses or medication errors.

Adetola, pharmacist also regretted the development, warning that delay is dangerous.

"When people delay seeking medical attention, their condition can worsen and become more difficult to treat. This can lead to complications, increased healthcare costs, and even death.

"Worse still, if people with

health crisis infectious diseases don't seek medical attention, they can unknowingly spread the illness to others. This can be a particular risk for vulnerable populations.

"The rising costs of medical treatments and drug prices, exacerbated by the weakening value of the naira against foreign currencies, are negatively impacting families.

'Many households struggle to manage their healthcare expenses, which in turn affect their allocation of funds for necessities such as food and transportation.

"The general lack of reliable health insurance coverage by significant number of Nigerians further complicates the situation. Even where insurance is available, insurance companies are grappling with higher costs due to expensive medications," Adetola said.

Catastrophic health expenditure

Launched in 2005, Nigeria's National Health Insurance Scheme, NHIS, aimed to make healthcare affordable and accessible.

However, many Nigerians still face out-ofpocket medical expenses, risking financial hardship due to high costs. "What most Nigerians are facing today as a result of the economic downturn is catastrophic health expenditure.

This is the health care payment beyond a certain fraction, that incurs negative economic consequences, ranging from sacrifice of basic goods and services, depletion of savings by individuals and families, to loss of income, and productivity, as well as disruption of welfare and living standards.

"Narrowing economic status gap across households, increasing the depth of insurance are crucial mechanisms to reduce the probability of incurring catastrophic health expenditures in Nigeria,

# APC has failed in fulfilling campaign promises

**AGOS** Former **⊸**National Chairman (North-East) of All Progressives Congress, APC, Salihu Lukman, said yesterday the party has done badly in meeting its campaign promises.

Lukman, who stated this in an interview with Arise TV, said APC's performance on key campaign promises, such as security, economic stability, and anti-corruption, had been

The former APC chieftain said he hoped that the new leadership would depart from the practices of the previous administration of President

He said: "I admit that in terms of meeting up with our campaign promises, we have

done badly, no doubt about it. "What are those campaign promises? Issues of security, the economy, fighting corruption. We have done badly and people are free to reach the conclusion whether or not APC is worse than PDP. "But as of 2023, before the election, I had the hope that because our leaders were not in denial of the challenges facing us, they would be humble enough to admit that we have not done what we needed to do between 2015 and 2023.

"That's why I was practically very confident that he would not really do business as usual the way President Buhari did.

"Unfortunately, here we are. He's doing business as usual. And as it is, we are going to end up in a worse situation.

"So to that extent, you might be right in criticising some of us who were in APC  $and\,who\,supported\,President$ Tinubu.'

Faults subsidy policy

The former national vice chairman of the APC noted that one of the most contentious decisions made by President Tinubu was the immediate declaration of the end of the petroleum subsidy with its lack of planning and preparation.

Lukman noted that the abrupt decision had led to a significant deterioration in the country's living conditions.

He said: "One of the biggest mistakes that President Tinubu made was making that declaration on his inauguration day, declaring petroleum subsidy is gone without even sitting down to put up a plan and today, no plan to respond to that challenge.

"That is why the living condition in the country is crashing and the government is just grandstanding.

"All of us in the party have become onlookers. We are not able to even access President Tinubu and influence decisions in terms of what needs to be done.

"From the way things are going, my prediction, which is why I had to act the way I acted — is that by the end of this year, if we don't take time, the campaign for 2027 will start and people will be forced to just queue behind any leader.

"Out of anger, out of frustration, with the reality before us, we'll end up even electing a worse successor to President Tinubu and all the

challenges of the country will even get worse."

### On Lagos-Calabar coastal highway

Lukman also cristisised the government's major spending on infrastructure projects such as the Lagos-Calabar coastal highway, while neglecting urgent needs in education and health.

While noting that the allocation for education was insufficient to address such a critical issue. Lukman said: "APC was founded on the vision of being a social democratic party. A social democratic party prioritises the well-being and condition of living of the citizens.

'So, issues of education, issues of health, issues of social welfare should have been the priority and that should be reflected in public investment driven by government.

"Unfortunately, what are the first steps President Tinubu took? Apart from the fact that on account of corruption, social investment has been suspended, which is why the question of responding to hardship is so weak, also look at the major decisions of President Tinubu.
