Edo points the way as FG steps up CNG conversion drive

s the Federal Government steps up the Ltempo of its Presidential Compressed Natural Gas Initiative (PCNGI), Edo State has emerged as a shining example for other states of

the federation and the Federal Capital Territory, Abuja, in the conversion of road transport vehicles from the use of petrol and diesel to Compressed Natural Gas (CNG).

Over 5,600 vehicles already run on CNG in Edo State, according to data from NIPCO

Gas, a joint-venture company between NIPCO and the Nigeria Gas Company Limited (NGC).

This is even as the Presidential CNG Initiative - which aims to convert the bulk of road transport vehicles in Nigeria (especially commercial passenger buses and goods trucks) from the

use of more expensive fuels (petrol and diesel) to CNG, which is about 65 percent cheaper - is just gradually taking off.

President Bola Tinubu approved the establishment of the PCNGI last August in furtherance of his commitment to easing the impact of fuel subsidy removal on Nigerians by reducing energy costs, which impact the cost of food, goods and transport.

Motor vehicles and other machinery in Nigeria currently use up about 93 million litres of petrol daily. The Nigerian Midstream and Downstream Petroleum Regulatory Agency

(NMDPRA) reveals a staggering average daily consumption of 14 million litres of diesel as at Q2, 2023, primarily driven by the unreliability of on-grid power.

Experts say CNG vehicles burn cleaner than petrol and diesel, re-

Telcos require new strategy as industry GDP falls to \$21bn —FDC

Ţigeria's telecoms industry's GDP has begun to lose its tempo, implying that the Federal Government needs to implement policies that will attract more investments into the sector, according to analysts at Financial Derivatives Company Limited (FDC), a Lagos-based investment cum think tank firm.

The FDC analysts stressed that the forward and backward linkages the sector possesses means that a slowdown in the sector's productivity will cause many sectors to perform below their potential.

The telecoms industry's GDP which initially responded to reforms by increasing from \$0.04 billion in 2000 to \$32.8 billion in 2010, and further to \$37.1 billion in 2020, has begun to lose its tempo, declining to \$20.7 billion in 2024, an indication that a new strategy is needed for the sector to regain its allure, they said.

These disclosures were made last week during the Lagos Business School (LBS) Breakfast Session which focused on "Nigerian Economy on the Brink: Adapt or Collapse?" The LBS Breakfast Session is a monthly top-down appraisal of the global, African and the Nigerian economy, coordinated by the Chief Executive Officer of FDC, Bismarck Rewane.

Nigeria's telecoms sector grew by 6.1 percent in 2000. And in response to the reforms in that sector in 2001, which saw the emergence of companies like MTN Nigeria, Globacom, and Airtel, the sector stupendously grew by 34.8 percent in 2010 but moderated to 15.9 percent in 2020. However, the sector only recorded a 6.2 percent real growth in 2024.

The declining growth in the telecoms sector affected the amount of taxes industry players paid to the central government, which also affected the amount of revenue available to the three tiers of government for develop-

Okomu clash: Obaseki visits wounded soldiers, pledges to apprehend perpetrators • to pay hospital bills of attack victims

The Edo State Governor, Mr. Godwin Obaseki, has visited soldiers wounded during an attack by assailants in Okomu Community.

The governor, who expressed

his displeasure over the incident, vowed that the State Government will fish out individuals and groups behind the attack.

The governor was represented during the visit at the Military Hospital in Benin City by the Edo State Commissioner for Communication and Orientation, Chris Nehikhare. He was received by the Director of the Military Hospital, Brig. Gen. Pauline Olubunmi Aburime.

Other government officials in the entourage include the Commissioner for Public Safety and Security, Kingsley Uwagbale; Commissioner for Mining & Energy, Enaholo Ojiefo, and heads of security agencies in the

Obaseki said, "It is not right for the military personnel to be attacked in any community here in Edo State. A few weeks ago, we were aware of what happened in a community in Delta State where over twenty (20) soldiers were killed by youths.

"In Edo, we have the issues of cultism and Okaigheles. The data available to us at the State Security Council meeting showed that Okaigheles are largely responsible for the threat to the security of Edo State which led to the ban on their activities."

The governor said after the State Government banned Okaigheles and their activities, some people condemned the ban and asked people to ignore it, adding that it was such attitude that has encouraged those that went to Okomu forest to attack soldiers protecting the state's assets.

"Three soldiers were badly wounded. We have one here now while others are worse. Their gunboats were destroyed. We don't want a situation where we will be losing soldiers to reckless, dangerous cult groups,"


"We appeal to leaders of Edo

South to discourage the youths who are armed to desist from these acts as they are not only attacking soldiers but also civilians on the streets. We are here to visit the soldiers and appeal to them that the Edo State Government will take care of the bills incurred," he said.

Obaseki warned the perpetrators to desist from such acts because the State Government will not tolerate such acts to prevent what happened in Odi Community in Bayelsa State or the incident in Delta State.

"All Edo people, irrespective of party affiliation, must support the government in this fight against cultism and killings in the State as the State has lost over 150 people as a result of the acts. We thank the Nigerian Army, a responsible organisation that doesn't take the laws into their own hands, if not it would have been a different story.

'We will start an operation this week to flush these people out, as we have a lot of security information and data that will help us flush them out. We advise those that belong to any cult group to return the arms they have, renounce their membership of any cult groups they belong to," he said.

ducing greenhouse emissions by between 15 and 27 per cent, depending on vehicle type.

Impressed with the impact of CNG roll-out in Edo State years back, the Federal Government directed an expansion of the initiative into other parts of the country. A mega CNG station was then commissioned at Ibafo, Ogun State, to convert automobiles to CNG, as well as to supply nearby industries.

Currently, about 40,000 trucks ply Nigeria's roads dispatching solid, liquid and gaseous cargoes but only between 20,000 and 25,000 of them are required to effectively service the country's haulage needs, experts say. The majority of the trucks currently run on the more expensive diesel fuel.

Analysts say that food prices would begin to noticeably trend downwards when up to 25 per cent of required haulage trucks (being 5,000 trucks) in the country are CNG-powered, and that the downward progression would flow incrementally as more trucks become CNG-enabled, reducing the burden of high food costs on the wallets of teeming Nigerians and freeing up disposable income for other pressing needs.

The cost of goods and services witnessed a marked upward spiral following the removal of the troubled fuel subsidy regime by President Tinubu in May last year and the free float of the naira.

Economy experts described

both moves as right, necessary and beneficial in the long run, adding, however, that they would cause severe discomfort to Nigerians in the short run.

As the Tinubu administration marked its first anniversary in office on May 29, the conversion to CNG featured prominently in presentations by the government.

Recently, the Federal Government inaugurated a 5.2 million Standard Cubic Feet Per Day (MMSCFD) CNG plant at the Isolo Industrial Area, Ilasamaja, Lagos State. The Federal Government said the move was aimed at providing an alternative source of fuel and alleviating the effect of petrol subsidy removal on Nigerians.

The CNG facility was built

through a partnership between the NNPC Gas Marketing Limited (NGML), a subsidiary of the Nigerian National, and Transit Gas Nigeria Limited, a subsidiary of Axxela Limited.

Minister of State for Petroleum Resources (Gas), Ekperikpe Ekpo, who inaugurated the plant, said the occasion represented a critical turning point in the development of affordable, sustainable, and secure energy sources in the country.

Programme Director, PCNGI, Micheal Oluwagbemi, had said earlier that the Federal Government intends to establish 1,000 conversion workshops across the country, create 50,000 jobs in the process and deliver one million CNG vehicles by 2027.

"We have a goal, one million

vehicles by the year 2027 and that allows Nigeria to save about \$20 billion in 10 years and also allows us to manage transport inflation," Oluwagbemi added.

"If we have 1, 000 workshops, we are talking about 5,000 jobs for technicians, including the cost of the labour and manpower that will go into the increased supply of CNG processing stations, model stations, and refuelling stations that will not run on this ecosystem," he said.

For his part, the Special Assistant on Special Duties and Domestic Affairs to the President, Toyin Subaru, said conversion to CNG would save Nigeria a huge cost on petrol import.

We are going to develop an app that will enable you to know where a CNG station is located. We should be able to buy gas for our cars at N230 when today petrol is N680. So, it will help save about two-thirds of your money," Subaru said.

Meanwhile, more and more Nigerians, especially commercial transporters, have been rushing to have their vehicles enabled to run on CNG so as to cut down on operating costs.

Consequently, private CNG conversion companies in Nigeria have raised their charges for converting vehicles to CNG from an average of N300,000 for salon cars to the range of N420,000, while the cost of converting mass transit buses and other heavy-duty vehicles has gone up from between N600,000 and N700,000 to between N1,000,000 and N1.2 million.

mental purposes.

According to the FDC analysts, the telecoms sector paid \$875.6 million as taxes to the Federal Government in 2015; \$390.2 billion in 2020; \$807.6 billion in 2022, and \$518.7 billion in 2023. But the naira float and subsidy removal policies of the FG affected the industry's biggest player, MTN Nigeria, which declared a loss after tax of N137 billion in 2023, showing the extent of the challenges the sector currently faces.

"Telecoms CAGR was 32% per annum between 2000 and 2010. The sector's growth is now stagnating at 6% but still above population growth rate of 2.2%. The telecoms industry is becoming relatively unattractive. Expenditure has increased over the years, but returns and revenues have squeezed to negative margins," FDC said.

Citing the big push theory in economics, which says that a growth in one strategic sector of the economy could stimulate growth in other sectors, the analysts emphasised that the telecoms sector is such an area with potential to transform other sectors of the economy.

The sectors that stand to benefit immensely from a rebound in the telecoms sector include manufacturing, transportation and logistics, education, tourism and travel, financial services, healthcare, retail and commerce, among others.

This linkage to other sectors is vital for economic growth, innovation, and productivity across various industries, making it a key enabler and driver of development in modern economies. If the telecoms industry collapses, all other sectors will follow," FDC stressed.

The FDC analysts added that countries with higher investment in the world usually end up having higher growth levels. The think tank firm said for Nigeria to be like the Asian Tigers - Hong Kong, Singapore, South Korea and Taiwan - the country must invest more and investment in telecoms has a linkage effect on other sectors.

"India is the second largest "The telecoms sector has both telecoms market in the world with a market size of \$44 billion. Massive reforms and investments in the sector supported the growth of the sector. 2021 spectrum auctions alone fetched a record-breaking amount of approximately \$10.5 billion, indicating the high level of investment and competition in the sector. National Digital Communications Policy (NDCP) aims to attract \$100 billion investment in the telecoms sector in four years," FDC said.

India currently has 1.19 billion subscribers, as the sector generates 4 million employment opportunities. The sector attracts an average of \$20.7 billion as foreign direct investment, making India's telecoms GDP worth \$232 billion.

Justifying why the focus of

the discourse was on telecoms, FDC said in a matter of 23 years, teledensity, which is the number of telephone connections for every individual in Nigeria, skyrocketed from 1.89 per cent in 2001 to 103.66 per cent in 2024. Internet users as a proportion of the nation's population increased from 0.02 per cent to 55.4 per cent in 2024 during the same period.

Also, base stations rose from 51,160 units in 2018 to 127,294 units in 2022. Total telephone subscribers increased from 100,000 in 2001 to 222 million in 2024, just as Nigeria's per capita income rose from \$538.2 in 2001 to \$1,109.9 in 2024.

Additionally, as of 2023, telecommunications sector contributed 10.97 per cent to the country's Gross Domestic Product (GDP), which means for every N100 the Nigerian economy generates now, N11 comes from the telecoms sector.

Notwithstanding, the telecoms sector has witnessed some not-too-impressive performances in recent times, according to FDC analysts. The causes include limited access to foreign exchange, rising inflation, higher operating costs, regulatory burden, multiple taxation, right of way issues, and vandalism. All these combined acted as nexus leading the industry to have marginal cost far less than marginal revenue, which means should telecoms companies in the country attempt to invest more resources, the additional income will not be sufficient to recoup their investments.

FG should allow states negotiate minimum wage based on their capacity —SANs

s the argument between the Organised Labour and the Federal Government over a new National Minimum Wage continues, some Senior Advocates of Nigeria (SANs) have expressed divergent views on whether the proposed agreement between the two parties should be binding on states.

In their separate interviews with THISDAY, all the senior lawyers agreed that the issue of minimum wage is under the Exclusive List on Item 34 of Part 1 of the Second Schedule to the 1999 Constitution, which provides that the National Assembly has the power to "prescribe a national minimum wage for the Federation or any part thereof."

However, Mike Ozekhome, Joseph Nwobike, Ebun Adeg-John Baiyesea, Ahmed Raji, and Dayo Akinlaja, argued that Nigeria is a federation, the different federating units should negotiate separately based on their individual financial capacities.

But human rights lawyer, Mr. Femi Falana, a former Chairman of the Nigerian Bar Association (NBA), Abuja branch, Mr. Moses Ebute and Abiodun Olatunji, insisted that Constitution, the National Assembly is exclusively empowered to legislate on National Minimum Wage in Nigeria.

This is as the Nigeria Labour Congress (NLC) and the Trade Union Congress (TUC) described the claim by the Nigeria Governors' Forum (NGF) that most of the states cannot pay a minimum wage of N60,000 as an act of bad faith.

Oyo State Governor, Seyi Makinde, however, insisted that the states should be allowed to sort the issues out with the organised labour, saying, "If you ask for my position on this issue, I will say the states should be left to sort themselves out with the labour," Makinde told THIS-DAY, Saturday night.

According to Ozekhome, the power given to the National Assembly by the 1999 Constitution "is somewhat curious, as one would have thought that, given our federal as against unitary structure under the self-same Constitution, the National Assembly ought to only legislate for the federal workers, while states did the same for theirs. But that is clearly not the case."

The constitutional lawyer stated that until the Constitution is amended, the National Assembly possesses the exclusive

imum wage for the whole country or any part thereof, which obviously includes the states.

He, however, argued that in practice, the states have always prescribed their own minimum wages as dictated by their individual financial capacities, adding that the Edo State government only just recently pegged theirs at N70,000.

On his part, Adegboruwa noted that Section 4 of the Constitution provides that only the National Assembly has the powers to make laws relating to issues of national minimum wage.

"However, we run a federation, which consists of the Federal Government, the state government and the local government. When laws are made by the National Assembly that applies to federal institutions and employees.

According to him, when the National Assembly makes an Act such as the National Minimum Wage Act, the state Houses of Assembly should work to also implement and incorporate that Act into their own laws for the purpose of enforcement.

He insisted that the Federal Government is not competent to negotiate on behalf of the states on minimum wage for workers.

Also contributing, Nwobike said the states being a legal entity are independent, and are entitled to enter into negotiations with their respective labour unions before enforceable agreements can be reached or implied.

He said: "There is no agreement between the organised labour and the federal government which binds the state governments. The state governments are independent legal entities which are entitled to enter into negotiations with their respective labour unions before enforceable agreements can be reached or implied. That

Cut high cost of governance, minimise corruption to pay minimum wage, Labour tells govs

The Organised Labour has rejected the claim by state governors that they cannot pay N60,000 minimum wage and urged the governors not to send the nation into a severe financial crisis.

The Nigeria Labour Congress (NLC) charged the governors with lying about their resource allocation, as the governors see the N60,000 the Federal Government had suggested to be impractical.

In a statement, Halima Ahmed, the Nigeria Governors' Forum's (NGF) acting director of media affairs and public relations, noted that many states would use their whole monthly allotment from the federation account to pay employee salaries if permitted to fly.

But a statement by NLC's head of information and public affairs, Benson Upah, said Federation Account Allocation Committee's (FAAC) allocations have since grown from N700 billion to N1.2 trillion, increasing the governors' capacity to pay more than N60,000 as minimum wage.

The statement reads: "Nothing can be further from the truth as FAAC allocations have since grown from N700 billion to N1.2 trillion, making the governments extremely rich at the expense of the people.

We are alarmed by the statement credited to the Nigeria Governors' Forum that state governments cannot even afford to pay N60,000 as minimum wage as a few states will end up borrowing to pay workers every

"We do believe the governors have acted in bad faith. It is unheard of for such a statement to be issued to the world in the middle of an ongoing negotiation. It is certainly in bad taste.

"As for the veracity of their claim, nothing can be further from the truth as FAAC allocations have since grown from N700 billion to N1.2 trillion, making the governments extremely rich at the expense of the people.

"All the governors need to do to be able to pay a reasonable national minimum wage (not even the N60,000) is cut the high cost of governance, minimise corruption as well as prioritise the welfare of workers.

"It is important to explain here that a national minimum wage is not synonymous with the different pay structures of different states. The national minimum wage is the lowest floor below which no employer is allowed to pay. The aim is to protect the weak and the poor."

Nigeria Army kills 6 in raid of IPOB camp in Aba

¬roops of Operation UDO KA have neutralised six terrorists following a successful raid on the camp of the proscribed Indigenous People of Biafra (IPOB) and its armed wing, the Eastern Security Network (ESN) in Igboro Forest, Arochukwu Local Government Area of Abia State on Saturday.

The Nigerian Army disclosed this on its X handle on Sunday, saying the operation was embarked upon to apprehend the perpetrators of the attack on its troops in Aba last week.

According to the army, during the intelligence-led operation, troops encountered improvised explosive devices along its axis of advance and one soldier sustained minor injury from the fragment.

'The terrorists' feeble firefights were adequately subdued with superior firepower that led to the neutralization of six members of the criminal terrorists group while others escaped into adjoining bushes with varying degrees of gunshot wounds as blood stains were seen along their escape routes.

'The gallant troops recovered three locally fabricated Rocket Propelled Grenade launchers, two locally fabricated Artillery guns with tripods and bombs.

"Other items recovered include dane guns, Biafran flags as well as Toyota Tundra and Hilux vehicles that were burnt. Also, all of their camps with different inscriptions were destroyed," according to the statement.

The statement noted that the Joint Task Force Operation UDO KA called on the people of Abia to continue to cooperate with security agencies by giving credible and timely information that will help to annihilate the criminals in the state and the whole of South Eastern Nigeria.

It could be recalled that six soldiers were killed last week in an attack by the IPOB/ESN, at Obikabia Junction Checkpoint in Obingwa Local Government Area adjourning Aba metropolis, where troops of Operation Udoka

were deployed to enforce peace in the area and protect the citizens. The attackers were said to have

come in three-tinted Toyota Prado SUVs and others, from built-up areas surrounding the checkpoint.

Six civilians were killed in the crossfire that ensued between the terrorists and the troops.

Following the killing of the soldiers, the Nigerian Military in a statement by its spokesperson, Major General Edward Buba, pledged to retaliate the attack on its troops brutally.

"The armed forces mourn the death of these troops as each and every soldier lost in battle is a terrible loss. Meanwhile, investigations are ongoing concerning

Don seeks support for persons infected with diseases at AAU's 112nd inaugural lecture

n a landmark demonstration of its giant strides in the sphere of learning, Am-

Ekpoma has held its 112nd inaugural lecture, with a call to show support and kindness to people infected with diseases.

The inaugural lecture titled "To be infected is not to be stigmatised: An invitation for socio-medical balancing" was a captivating intellectual

journey through the lens of a medical sociologist, Professor Theophilus Agweda, who is the Acting Deputy Vice Chancellor (ADVC) of the university.

Prof Agweda unravelled the major frantic efforts that could help to mitigate the discrimination and stigmatization levels against persons who have been infected with the Human Immunodeficiency Virus (HIV) and the Acquired ImmunoDeficiency Syndrome (AIDS).

The distinguished Professor shared extensive knowledge, guiding his audience through his presentation which he divided into seven neatly knitted parts, viz: Reflecting on the Basics of Medical Sociology, Health and Illness Relations, Demystifying HIV/AIDS as Infectious Disease in History, Rethinking Stigmatization and Its Implication on HIV/AIDS Patients, Effects of Stigmatization, among others.

He shared his insightful experiences during the period under review, explaining how he had engaged people of different categories/professions (including teenagers, youths, the elderly as well as Persons Living with the Virus), to get adequate knowledge, while x-raying ways through which managed and treated, noting that HIV/AIDS is not a death

He stressed the need to deliberately and consciously support PLWHA by showing some support, kindness, empathy, discipline, determination and circumspection which are key aspects of social medical balancing.

Earlier in his welcome address, the Acting Vice Chancellor of Ambrose Alli University (AAU), Prof. Sonnie Adagbonyin, disclosed that the lecture was delivered timely, as individuals who are infected with various diseases are often targeted and become victims of stigmatization, noting that socio-medical balancing is an approach that seeks to mitigate social and medical perspectives in addressing health and wellbeing.

High point of the ceremony was the official decoration of the Inaugural lecturer, Prof. Theophilus Agweda, by the Acting Vice Chancellor, who welcomed him to the Committee of AAU's academic giants.

Rivers approves N74.9bn for Assembly, hospitals, road

ivers State Executive Council has deliberated and approved N74.9 billion contracts for the reconstruction of the Rivers State House of Assembly Auditorium, construction of Kalaibiama/Epellema Road, and completion of four zonal hospitals across the state.

Also approved is the renovation of Bonny General Hospital; renovation and upgrade of Neuropsychiatric Hospital, Rumuigbo, as well as construction of new General Hospital at Rumuigbo in Obio/Akpor Local Government Area of the

While the reconstruction of the demolished Assembly Auditorium in Port Harcourt will cost N19,566,621,284.24; the Kalaibiama-Epellema Road and bridge in Opobo-Nkoro Local Government Area will gulp N29,035,907,233.76; just as the hospitals will cost N26,350,310,714.88.

The zonal hospitals are located in Ahoada Town in Ahoada Local Government: Degema Town in Degema Local Government; Omoku Town in Ogba/Egbema/Ndoni Local Government, and Bori Town in Khana Local Government Area.

The state government said it decided to complete the construction of the zonal hospitals in four local government areas of the state in order to strengthen the secondary level healthcare service delivery to the people of the state.

At its meeting, presided over by Governor Siminalayi Fubara, and attended by Deputy Governor, Prof Ngozi Odu and other Council Members at Government House in Port Harcourt on Friday, approval was also given for the cancellation of all previous contracts awarded for the construction of those zonal hospitals.

Briefing newsmen after the meeting, Commissioner for Health, Dr Adaeze Oreh, said the approval was sequel to the memos presented by the Ministry of Health to the State Executive Council.

Specifically, Dr Oreh said the ministry requested for the approval of the cancellation and termination of all existing contracts for those zonal hospitals in the state, and the re-awarding of fresh contracts that will enable completion of the projects, including the renovation of the Bonny General Hospital.

Dr Oreh stated that there was also the request for the renovation and upgrade of the Neuro-Psychiatric Hospital

and the construction of a new General Hospital at Rumuigbo in Obio/Akpor Local Government Area of the state.

She said, "We are thankful to the Rivers State Executive Council that the various decisions sought and prayers that were made by the Rivers State Ministry of Health for the approval of the termination of the contracts for completion of the zonal hospitals at Ahoada, Bori, Degema and Omoku, and the re-award of fresh contracts for their completion were approved.

"That the request to the State Executive Council for the approval of the award of these contracts in total summed up to N26,350,310,714.88k that was approved for the completion of those zonal hospitals, the renovation of Bonny General Hospital and the upgrade of the Neuro-Psychiatric Hos-

"This also included the construction of a new General Hospital at Rumuigbo, Obio/ Akpor Local Government Area, which were not among those initially awarded for renovation."

The commissioner explained that the State Executive Council also approved that following the termination of the previously awarded contracts, fresh contracts should be awarded to new competent contractors who have such capacity to deliver on those projects.

She emphasised that such contractors would also be mobilized to site so that they can commence construction work on those separate projects in the health sector in order to advance healthcare delivery in

On his part, the Permanent Secretary of the Rivers State Ministry of Special Projects, Dr Roland Obed-Whyte, said his ministry presented two memos that requested for the award of separate contracts.

He said the first is a request for Council's approval for the award of contract for the reconstruction and furnishing of Rivers State House of Assembly Auditorium Complex.

He said, "This contract has been awarded to Monier Construction Company Nigeria Limited (MCC) at the cost of N19,566,621,284.24 kobo with completion duration of nine months.

"This Rivers State House of Assembly Building Complex is made up of about 34 ensuite offices, two-storey building with elevator, gallery, meeting rooms and conference hall.

"It also includes the renovation and refurbishing of other existing structures within the House of Assembly Complex. ambulances and other external

Dr Obed-Whyte explained that by the time the work on the Rivers State House of Assembly building is completed, it will turn out to be one of the very best Assembly complexes

Also, he said the second memo that was presented to the State Executive Council requested for the approval of the contract for the award of the construction of the 5.75 Km long Kalaibiama-Epellema Road, with a 450 meters length of bridge and carriageway of 10.3 meters with solar lights.

He said, "It is awarded to Monier Construction Company Nigeria Limited (MCC) at the cost N29, 035, 907, 233.76 kobo with completion duration of 12 months.

"Again, in these two contracts, 30 percent mobilization is to be paid as an advance payment. We believe strongly that when that road is completed, it will connect over four or five communities within that axis, and the issue of boat mishap and its attendant problems that riverine transportation faces will be a thing of the past."

The Governor is determined with his mantra of "Rivers First" to open up the coastal areas with what he is doing on the Trans-Kalabari Road project, he said, adding that with this project in the Opobo axis, the people will be the greatest beneficiaries.

In her presentation, the acting Director General of Rivers State Bureau for Public Procurement (RSBOPP), Engr. Ine Briggs, said due diligence has been done by the agency in scrutinising the projects and the cost efficiency, adding that after due diligence was conducted, the agency issued certificates of no objection to each of the projects.

She said, "The consideration of all these projects approved today by the Rivers State Executive Council, the Bureau is glad to inform the general public that it has duly carried out its regulatory function in

ensuring that value for money has been met, economy has been met, fitness for purpose has been met in defending the stakeholders' position in expenditure of fund from the

"So, the Bureau has issued a certificate of no objection for the two projects from the Ministry of Special Projects and the projects for the Ministry of Health"The Bureau wants to assure the public that it will carry out its oversight functions at ensuring that quality specifications as enshrined in the approvals, would be met, and the people will feel their government, and that is our assurance as a regulatory body".

He also stated that the injustices Ibori fought against as governor still existed today and appealed to him to continue to join forces with other stakeholders in the region to right the wrongs.


The Bayelsa helmsman restated the need for Nigeria to practice true federalism based on equity, fairness and justice.

Delta police arrests armed robbers, recovers Beretta pistols, locally made cut-tosize guns

↑he Delta State Police Command said that, on 05/06/2024 at about 1745hrs while acting on credible intelligence, the special squad deployed to Ughelli by the commissioner of Police Delta State, CP Abaniwonda Olufemi, to checkmate the activities of kidnappers and armed robbers in Ughelli, Warri, Sapele, and environs successfully arrested three suspected armed robbers and recovered their weapons used in terrorizing innocent residents in Sapele.

According to a press release made available to journalists on Friday by the police public relations officer, Mr Bright Edafe (SP) in Asaba, the Delta State capital, the team led by ASP Julius Robinson stormed Sapele town on the said date and effected the arrest of one Blessing Atima aged 23 years 'm' of Jesse Community in Ethiope West LGA of Delta State.

The gang leader, Destiny Okpako, aged 23 years 'm' of Oviri-Okpe Community in Okpe LGA of Delta State and Wisdom Akpohirowho, aged 20 years 'm' of Jesse Community in Ethiope West LGA of Delta State, all residents of Sapele town and the following exhibit were recovered from them; one Beretta pistol, one locally cut-to-size gun, three cutlasses, phones and ATM cards belonging to victims.

Some of their victims have identified the suspects and their valuables recovered from them. Interrogation of the suspects revealed that they have so far taken part in six of the armed robbery operations in Sapele. The said suspects are in police custody, while investigation is ongoing.

In the same vein, the police command said that, on 3/05/2024 at about 0830hrs, RRS Operatives, while acting on credible information that some suspected robbers were sighted in an uncompleted building along Issele-Asagba Expressway.

The operatives stormed the uncompleted building and arrested one Usman Bello 'm' aged 40 years, and one locally made fabricated Beretta pistol was recovered from him.

The suspect who pretends to be a mentally unstable person is in police custody and investigation is ongoing.

In another development, on 04/06/2024, at about 1300hrs, the Area commander Asaba, acting on intelligence reports on the activities of some suspects who come from across the Niger to Asaba at night, break into and loot the shops of their targeted victims.

The Asaba Area commander immediately deployed undercover operatives who embarked on a discreet operation that eventually paid off when the duo of one Ameachi Michael 'm' aged 42 years of Wuje Street Port Harcourt and Ogochukwu Ogbode 'm' aged 38 years of Aronomen Enugu were arrested along DLA Road, Asaba.

Preliminary investigations revealed that after breaking and looting the shops of their victims, they carried their loot to Port Harcourt to sell.

Investigation and efforts to arrest the receivers of these stolen items are ongoing.

Connecting the CNG project to road repairs

Soaring food prices constitute one of the more telling manifestations of the ongoing economic crunch that Nigerians find themselves faced with as inflation rides high on the back of the Federal Government's decision to put a stop to fuel subsidy and set the local currency, the naira, on a free float on May 29, 2023.

Experts say the measures will bring relief to the economy in the long run but cause significant distress in the short term.

As part of measures to cushion the attendant rising cost of living, government has embarked on some mitigating ventures.

One of these is the Presidential Compressed Natural Gas Initiative (PCNGI), which aims to convert the bulk of road transport vehicles in Nigeria (especially commercial passenger buses and goods trucks) from the use of more expensive fuels, petrol and diesel, to CNG which is about 65 percent cheaper than the first two listed fuels.

Analysts say that food prices would begin to noticeably trend downwards when up to 25 percent of required haulage trucks (being 5,250 trucks) in the country are CNG-powered and that the downward progression would flow incrementally, as more trucks become CNG-enabled, reducing

the burden of high food costs on the wallets of teeming Nigerians and freeing up disposable income for other pressing needs.

The initial phase of the conversion programme is being initiated in Lagos, Kwara, the Federal Capital Territory (FCT), and Rivers states. This phase will be executed in partnership with major transport unions, including the National Union of Road Transport Workers (NURTW), the Road Transport Employers' Association of Nigeria (RTEAN), and the Nigerian Association of Road Transport Owners (NARTO), according to government.

To ensure the success of the programme, the PCNGi says the rollout will commence in eight of over 120 designated conversion workshop sites, after which the key union partners, will have the opportunity to observe, evaluate the conversion process, and provide valuable feedback as the initiative plans to scale up operations across 15 states over the next few days.

The rollout, it is said, will be backed by a 50 per cent discount on equipment and kit costs, and support to qualified union members for installation cost.

The Federal Government says it will deliver 100 conversion workshops and 60 refuelling sites spread across 18 states before the end of 2024.

Converting to a cheaper fuel does promise to offer significant relief from the current high costs. However, vehicles that run on more cost-effective fuels are only one half of the solution.

Another consideration is the state of the roads that these vehicles will ply.

Between late 2023 and the early weeks of 2024, the Federal Government kicked-off the rehabilitation of some of the largely deplorable network of federal highways linking Nigeria's 36 states and Abuja.

In November last year, Minister of Works, David Umahi, after a meeting with President Tinubu in Abuja, told journalists that the President had approved more than 260 road repairs across the 36 states of the federation and the Federal Capital Territory (FCT), Abuja, to the tune of N217 billion.

Among the projects Umahi listed, were the resurfacing of the Third Mainland Bridge, construction of Lekki Deep Seaport Road, reconstruction of two collapsed bridges in Enugu, Benin-Sapele Road, reconstruction of two locations on the Onitsha-Owerri Road, upgrading of the Abuja-Keffi-Akwanga-Lafia Road, and dualisation of the Lafia by-pass.

Other areas slated for repair,

he said, were 17 points along the East-West Road that had been destroyed by floods.

He also spoke of two bridges that collapsed in Enugu, two locations on the Onitsha-Owerri Road, as well as points on the Lokoja-Abuja Road.

Also included was the reconstruction of the Benin-Warri Dual Carriageway (Section I, II and III) and dualisation of East-West Road Section III: Port Harcourt (Eleme Junction) Onne Port Junction Road in Rivers State, among others.

In all, the minister mentioned 260 emergency repairs approved all over the country to the value of about N217 billion.

Umahi, a civil engineer and former governor of Ebonyin comes with a worthy track record on road projects delivered in that state and is reported to have been hard at work since assuming office as works minister.

A brief summary of road repairs effected so far, and timelines for the conclusion of others, would make the vital connection between the Presidential Compressed Natural Gas initiative and the state of the roads that the project would ride to bring efficiency and financial reliefs to stakeholders, especially more affordable food to teeming beleaguered Nigerians.

Bigotry. One of the ugliest words in the English Language, if you ask me. Its connotations are not beautiful: narrow-mindedness, intolerance, prejudice, ignorance, and in extreme cases, societal upheaval. The Cambridge English Dictionary defined bigotry as 'the fact of having and expressing strong, unreasonable beliefs and disliking other people who have different beliefs or a different way of life.'

Bigotry can be religious, political, cultural, and even sexual. It is a universal trait that manifests itself in various ways in different societies. Sadly, Nigeria is not exempted, even among her educated classes. Indeed the average Nigerian who knows what bigotry is will be offended if you call him or her a bigot. But a short objective interaction with such an individual will convince you that bigotry is probably embedded in his or her DNA.

At this point let us find out how to identify a bigot. There are basically five attributes of bigoted people. Studies show there are certainly more features of bigoted people but only five are discussed here.

First, bigots usually have a literal, one-track, narrow understanding of their beliefs. They do not accept that their beliefs, whether religious, political, cultural, etc. can be seen from different perspectives. Examples are Christian and Muslim fanatics and how they interpret the Bible and Quran.

Also, because they see their be-

liefs and ideas as sacrosanct, bigots do not question THEIR beliefs. Thus, the political bigot will never critically look at the candidate or ideology or political party he is prepared to kill or die for. The cultural bigot will say tradition should be followed unquestioningly. Anyone who has a different view is 'Haram' (to use the Arabic term for forbidden), even when logic and reason are brought to bear on such rigid beliefs. Interestingly most of the mindsets of bigots fall to pieces if you can get their owners to answer this fundamental question honestly: what really is the basis for this belief

Third, bigots are usually ignorant about views, people and ideas outside their narrow domain. This has absolutely nothing to do with being educated. The average bigot will not take the time to look at life beyond his or her cocoon. Why? Maybe the bigot was bred on a diet of ignorance and lies by authority figures like parents, teachers, religious leaders, etc. For those of them who went to school their education may be so wonky it only embedded prejudice, instead of expelling it. Perhaps this example from my experience in the classroom may amplify this point. I was teaching a history class of junior secondary school boys.

These lads come from different ethnic groups in Nigeria, and if you know Nigerians, you will know that tribal prejudices are passed from one generation to the next. As I was outlining some rather unsavoury historical facts committed in a pre colonial Nigerian state, students who had been indoctrinated to regard people from the ethnic group that came from that area as bad people began to mock their mates, confident that they had history on their side. Of course I burst their bubble with some ugly facts about their own people. The essence of what they learnt from me that day is that every person has ugly stains recorded on them by history.

The mind of a bigot

Bigots love emotionalism. That is why many leading bigots throughout history and right into our time are demagogues who draw crowds of unthinking and unquestioning followers. Bigots wrap their bigotry in different cloths to get their wonky beliefs into people's hearts and minds. Thus the jihadist will turn his aspiration to destroy the house of infidels into an appeal to Islam.

The Christian bigot will justify his maltreatment of unbelievers and destruction of worship places of adherents of African traditional religion with the Great Commission of Jesus Christ to spread the gospel. The tribalists will argue that the other tribe should be dealt with because they are responsible for the bigots' woes. Indeed there are so many apparels one can cover bigotry in.

If you are critical you will observe that bigots, including those in positions of power and influence, are hostile towards sincere and persistent thinkers and questionnaires? They put labels on them: 'philosophers who do not know God and will go to hell', 'corrupters of morals', 'haters of our culture and tradition,' 'atheists', etc. Some are even accused of reading many books! (I have been found guilty of this). In cases where power is on the side of the bigots, those who refuse to be swayed by their demagoguery may end up in unpleasant situations.

Finally, bigots are not outright liars. In many cases the average bigot's warped belief system and thought processes emanate from reality.

But the problem is how they chose to interpret reality. Do they work with full information about this reality? The 2023 presidential elections in Nigeria is a case study. The ethnic and religious backgrounds of the three major candidates were the reality political bigots drew upon and based their understanding of electoral outcomes. Subsequently, people from the other sides were labelled, and age-old myths were reinforced. Other realities did not matter. For example, there were Yoruba who truly believed in the Labour Party candidate. Just as there were Igbo committed to the APC candidate. But as we saw in ensuing narratives, bigots turned such realities on their heads and used them to justify their perceptions.

Bigotry is far deadlier than cancer. It destroys individuals, societies and nations. The Rwandan genocide of 1994 is just one eloquent testimony to the power of bigotry. While the war against bigotry should be fought by all, those of us who are called to create worlds with words, pictures, songs and symbols are unique front liners in this age-old war. How much of other worlds, cultures and lives do

we know? Do our creations speak to the principle of humanity before any other creed?

Do we, the creatives, give our gifts to the service of bigots just to satisfy our stomachs and bank accounts? Worse, do we use our talents to push the narratives of the bigots? Let nobody be fooled: the writer, singer, sculptor, film maker, is human and thus capable of bigotry. But it is doubly painful because by our calling we are supposed to be arrowheads that pierce the deepest hearts of systems of bigotry. Perhaps the first imaginative step in fumigating the minds of bigots with our creations is to immerse ourselves in cultures that are not ours by the accident of birth. That is why my hat remains permanently doffed for two great writers who did this admirably. The immortal Cyprian Ekwensi, an Igbo, who so immersed himself in Hausa/Fulani/Kanuri worldviews that his fiction set in those cultures remain evergreen in the hearts of all who read them. Contemporaneously, Henry Akubiro walked the same line with 'Yamtarawala, the Warrior King' which deservedly made the shortlist of the NLNG Nigeria Prize for Literature last year. The play opened up the cultures of the vast swath of Northeastern Nigeria far better than any history textbook. These are just a few of the measures we creatives can take to kill the seeds and plants of bigotry.

Federalism as a circle of chaos

ccording to available information at Wikipedia, the world's information power house, Nigeria is among the roughly/about 25 countries in the world where the federal system of government is practiced today. Interestingly also, these countries when put together represent 40 percent of the world's population. These countries include but are not limited to; namely, India, the United States of America (USA), Brazil, Germany and Mexico, among others.

Typically, the federal system of government tends to have so much passion for constitutional governance based on a mixed or compound mode of government that combines a general government with regional governments in a single political system.

While many political commentators accept as true that its greatest strength as a system of government is that in a country where there are many diversities and the establishment of a unitary government is not possible, a political organization can be established through this form of Government. In this type of government, local self-government, regional autonomy and national unity are possible, others argue that with the division of powers, the burden of work on the centre is lessened and the centre has not to bother about the problems of a purely local nature. It can devote its full attention to the problems of national importance. Because of provincial or regional autonomy, the administration of these areas becomes very efficient. To the rest, in a federal government the provinces, regions or the states enjoy separate rights and they have separate cabinets and legislatures. Local governments also have separate rights and the councils are elected by the people to run the local administration.

Despite these virtues, recent con-

versations about this system of government across the globe manifest signs that it enjoys appreciable burdens and in some cases act as pathways to discord.

Take as an illustration, in India, the system presents a conflicting scenario.

It is a quasi-federal system containing features of both a federation and a union that allows power to be divided between the central government and the states. Article 1 of the Indian Constitution suggests that the territory of India shall be classified into three categories; the Union Government (also known as the Central Government), representing the Union of India, the State governments and the Panchayats/ Municipalities. Basically, it implies an inculcation of a strong sense of love and respect for one's region, ethnicity, language, and culture.

It is this love which makes regions fight for greater autonomy within the nation and directly puts the authenticity of Indian federalism in danger. Another area of concern is that the most important power of the Governor sometimes comes in conflict with the federal structure of the country. To illustrate this claim, the power vested upon him by Article 154 of the Indian Constitution states that all the executive powers of the state are held by the Governor. This provision going by analysis implies that the Governor can appoint the Chief Minister and the Advocate General of the State, and State Election Commissioners. The most paramount and in my view troubling executive power at his disposal is that he can recommend the imposition of constitutional emergency in

In Brazil, the burden of challenge is not different. More specifically, the problems facing the federal system and constitutional governance in the country involve several issues. First and most importantly, Brazil is a federation characterized by regional and social inequality.

Although the 1988 Constitution and those preceding it have provided several political and fiscal mechanisms for offsetting regional inequality and tackling poverty, these mechanisms have not been able to overcome the historical differences among regions and social classes. Governments of the three orders have not been able to reduce poverty and regional inequality.

Their ability to act is limited by a number of factors, not the least of which is the fiscal requirements of international leaders and federal financial institutions and regulations.

Another factor, says a report; adversely affecting states is the opening up of Brazil's economy. This tends to make intergovernmental relations more complex, as it increases the differences between developed and less developed states. This also contributes to the current trend towards reversing previous, although timid, initiatives favouring economic decentralization. An added issue is that in Brazil there are few mechanisms to provide for coordination between the three orders of government. This has become more important because municipal governments have had their financial standing upgraded within the federation vis-à-vis the states and have also been given responsibility for important social policies. The prospect of transforming constitutional principles into policies for regional development is not currently on the agenda for Brazil.

While the world sympathizes with Brazilians on whose shoulders lay this awkward situation, the federal system in Germany, says 75 years old Rain-Olaf Schultze, author of the book; the Politics of Constitutional Reforms in Northern America, is at a crossroad



and dramatizes worrying concerns.
Schultze noted that the new weaknesses have emerged in the success

story of the postwar German federal system.

The highly successful West German federal system, which for 40 years brought economic and social prosperity to Germany's "second" democracy, has fallen into a state of crisis, mostly as a result of the momentous changes that occurred toward the end of recent decades.

On the surface, German reunification looks complete – however, reunification is still in progress on the cultural and economic levels, the consequences of which will continue to evaluate German politics for decades to come. These strains have made structural reforms essential for the political system.

From Germany to Nigeria, the situation is not different.

Today, restructuring debate rends the political wavelength of the political space called Nigeria.

Synoptically, this is how the whole debate was recently captured by a political commentator; the south-south claim continued deprivation and blight from oil pollution, despite being the hub for the nation's oil wealth. The south-east legitimately gripes that nothing will change the history of the Igbos being divested of some of their properties and wealth after the war and being handed only twenty pounds each; and that fifty-six years after independence, the Nigerian presidency continues to elude the Igbos. The North has valid stitches too. Most of Nigeria's insolvent states are in the North; the broadest swathes of underdeveloped Nigeria are in the North and the largest numbers of uneducated and unskilled youths are from the north. Because northern states are not oil producing, they also lose out on preferential derivation from oil.

While it has, from the above concern, become obvious that the Federal System is riddled with challenges particularly in a country like Nigeria, the truth must be told to the fact that, in absolute terms, federalism remains the answer to many of the nation's political and socioeconomic challenges if well practiced.

Aside from many supporting the validity of a federal system of government, the greatest lesson of the federal system, says Scott Moore, a research fellow at Harvard's Belfer Center for Science and International Affairs, is that countries can often become stronger by adopting a looser union.

By this assertion, it will also not be characterized as unfounded to conclude that we are doing this country more harm than good and quickening its disintegration by refusing to restructure the nation Nigeria.

Edo Cult Prohibition Law: A lifeline to end secret cult killings

In December 2018, the Edo State government took a bold step to address the menace of secret cults by passing a bill to repeal and re-enact the law prohibiting their existence, membership, and activities.

The move came after a protracted war between rival cult groups that left several people dead in Benin City metropolis.

The law prescribes a 21-year jail term for secret cult members and a seven-year imprisonment for anyone who harbours a cultist. It also empowers the Police to arrest suspected cultists without a warrant and ensures that all offenses under the law are tried summarily.

The motion to consider the Bill at the committee of Edo State House of Assembly was moved by the then Majority Leader, Roland Asoro, a member representing APC Orhionmwon South, and seconded by the former Chief Whip, Hon. Iyoha Osaigbovo APC-Oredo East and now the Chief of Staff to the Edo State government.

The passage of the 11-Section Bill followed the suspension of House Rules 20, 27, 42, 43, 44, 45, 46, 47, 48

and 49

The set objective of summary trials by the then House of Assembly was to ensure that justice is delivered swiftly, without compromising on the principles of natural justice and fair trial.

This was also to ensure that only offenses of certain gravity are tried summarily, and cases with higher potential punishments are dealt with through regular trials.

Summary trials are appropriate in cases where the Court can determine the facts of the case through written documents only, and there is no need to fully present evidence through the testimony and cross-examination of witnesses. An application strike is a "chamber's proceedings".

In July 2023, the Chief of Staff to the Governor, Hon. Osaigbovo Iyoha, reassured Edo people that the Government would flush out cultism and cult-related activities in the State.

Iyoha while reacting to viral audio attacks on him and the clampdown on suspected cultists in their hideouts said with support from security agencies, cultism would become history in the state adding that the strategy being deployed would be extended to tertiary institutions in the state.

He added that the government cannot be intimidated or blackmailed.

However, between July and December 2023, the Governor declared that no fewer than 135 lives were lost to cult-related activities, and again recently, the Governor said over 150 deaths were recorded in the first half of 2024.

This seriously created doubt on whether the government was ready to face the menace.

Many have observed that despite the passage of the law, its implementation has been lax.

Following this, Governor Godwin Obaseki has declared a total war against cultism and has set up a special task force headed by the Director of SSS to review every cult-related incident.

The Governor disclosed that what is particularly worrisome about cultism is the related homicide that goes with cult-related activities.

From January to date, according to him, "We have lost over 150 people to cult-related activities and homicide. We can't tolerate and accept this situation anymore."

Obaseki stated that in his first attempt, cultism would be addressed

from two distinct approaches, which include ensuring diligent investigation and prosecution of cult-related crimes and ensuring high publicity.

With the new Secret Cult Prohibition Law of Edo State, any student or public officer who is involved in a secret cult by way of membership, initiation, behaviour, identification marks, regalia, etc, assaults, uses threats, or threatens to use actual violence on anybody or property in promotion of secret cult within the state is guilty of an offense and liable to 21 years imprisonment.

The law also stated that any person who directly or indirectly assists, permits, promotes, or helps secret cults in getting members, retaining its existence, or any other activities; And/or any person who knowingly provides housing, shelters, or quarters to any member of a secret cult, is guilty of a felony and is liable to 5 years imprisonment.

The most adorable part of the law is that when a person is caught, he has no claims for Option of Fine.

The government must act decisively to implement the Secret Cult Prohibition Law, and hotel operators and security operatives must join the fight

against killer cultists.

With the law in place, anyone involved in secret cult activities faces 21 years imprisonment without an option of a fine.

The government must ensure that no one is exempted from arrest, and the right to association must not be used to assemble and kill.

As Governor Obaseki's tenure comes to an end, his legacy will be defined by his ability to sanitize Edo State and rid it of killing sprees, restoring nightlife and investor confidence.

The people of Edo State demand action and the government must respond with decisive action against secret cults.

Enough blood has been shed; it's time for justice to prevail.

CBN's directives on oil proceeds repatriation to boost naira appreciation —Experts

igeria's national currency, the naira, is set to experience appreciation in value against major international currencies, especially the United States dollar, in view of the new directives of the Central Bank of Nigeria (CBN) to International Oil Companies (IOCs), through deposit money banks in the country, economic experts at the Financial Derivatives Company (FDC) have said. This prediction was based on the assumption that the directives of the CBN will increase dollar supplies to authorised forex dealers in the country.

Recalled that on May 31, 2024, the CBN, through a circular with reference number TED/FEM/PUB/FPC/001/017 explained the purpose of the earlier directives given to deposit money banks on IOCs' proceeds, to the effect that 50 percent of IOCs' repatriated proceeds could be used to settle financial obligations in Ni-

"The 50% balance of the repatriated export proceeds could be used to settle financial obligations in Nigeria, whenever required, during the prescribed 90-day period," the CBN said in a circular to banks in the country.

It further listed percent balance of their pro- to authorized FX dealers and

ceeds could be used for, and these include the petroleum profit tax, royalty, domestic contract invoices, cash call, domestic loan principal and interest payment, transaction taxes including the Nigerian Content Development (NCD) levy, education tax, and forex sales at the Nigerian Foreign Exchange Market.

The naira has oscillated against the US dollar in recent times. According to the exchange rates data provided by the CBN, the naira-dollar exchange rate was N1330.76 as of March 2024. The rate remained almost the same as at the end of April this year. The naira depreciated to N1483.48 to the US dollar as at the end of May 2024. And on June 6 2024, the naira traded at N1485.82 to the US dollar at the NFEM market.

The naira also depreciated against the Chinese Yuan. As of March 2024, the exchange rate of naira/yuan was N184.11/ Yuan. It became N190.26/Yuan by the end of April 2024. The naira further depreciated to N204.90/Yuan as of May 2024. And by June 6, 2024, the naira was exchanged for N205.07 to the Yuan.

"The forex market is about to witness a turnaround as the CBN continues its efforts to bring stability in the market. Recently, the CBN permitted IOCs to sell 50% of repatritransactions for which the 50 ated export proceeds directly

eligible users of foreign exchange. This move is aimed at increasing forex availability in the market, thereby aiding in exchange rate stabilization," FDC stated.

The research firm added that naira will likely trade within the band of N1,350 to N1,450/\$, through June. But due to lags, the positive impact of the CBN position will come later towards the end of 2024 and beyond.



What moved the money and capital markets last week?

uring its June meeting, the European Central Bank (ECB) cut interest rates by 25bps to 4.25% in June 2024 (marking the first rate cut in five years). The monetary authority attributed this decision to recent price stability and the downward trend in the area's inflation (EU area's inflation decreased from 10.60% in October 2022 to 2.60% in May 2024). In the near term, we anticipate the ECB will adopt a wait-and-see approach, closely monitoring relevant indicators to ensure prices remain on the downtrend and achieve its 2.00% inflation objective.

In Sub-Saharan Africa, Statistics South Africa reported that the country's economy shrank by 0.10% in Q1:2024, down from a revised 0.30% growth in Q4:2023 and 0.60% in Q1:2023. The downturn is attributed to widespread contraction across six economic sectors, including manufacturing (- 1.40%), mining (-2.30%), and construction (-3.10%), exacerbated by intensified power outages. However, we anticipate a return to economic growth in the upcoming quarters, driven by the government's efforts to stimulate economic expansion, potentially influenced by changes in government dynamics and subsequent fiscal reforms.

Lastly, Zambia's bondholders have approved a debt restructuring plan, a potential relief to the country's debt crisis following its default over three years ago. The plan (which is a prerequisite to access the previously secured \$1.30 billion facility from the IMF,) involves swapping three bonds due in 2022, 2024, and 2027 for two amortising bonds with revised payment terms. Additionally, Zambia has requested an increase in the IMF's loan programme from \$1.30 billion to \$1.70 billion to bolster its response to the worst drought in four decades and support the country's economic recovery.

Organization of the Petroleum Exporting Countries and its allies (OPEC +) have adjusted Nigeria's oil production quota to 1.50 million barrels per day (mbd) until December 2025, an increase from the initial 1.38mbpd. Although this falls short of the 1.78mbpd target set in the country's 2024 budget, the upward review offers Nigeria a chance to enhance its oil production and consequently boost its oil revenue.

Going forward, we expect the government to intensify efforts to boost output in the sector, potentially leading to further quota increases in the near to mid-term. In a separate development, the African Export-Import Bank (Afreximbank) has disbursed \$925.00 million under the \$3.30 billion crude-backed facility sponsored by the Nigerian National Petroleum Company (NNPC) Limited. This latest disbursement brings the total amount disbursed under the facility to \$3.18bn. We anticipate that this additional funding will improve liquidity in Nigeria's foreign exchange market in the near term. Moreover, since repayments are tied to oil production, we do not expect this increased borrowing to significantly strain the country's debt service capacity.

Furthermore, the Central Bank of Nigeria (CBN) has revoked Heritage Bank Plc's licence, citing the failure of its board and management to improve financial performance, posing a risk to financial stability. The CBN appointed the Nigeria Deposit Insurance Corporation (NDIC) as the bank's liquidator, with depositors expected to receive insured benefits of up to N5.00 million. We believe this action by the CBN aims to strengthen public trust in the banking sector and also sends a signal to other banks to adhere to regulatory standards and maintain strong financial performance.

Product mgt in Nigeria rapidly evolving -Adesanya

Adeyinka Adesanya is one of the fastest-growing Nigerian female Product Managers who is revolutionizing the tech space. She is passionate and detail-oriented with a strong focus on process, strategy, and solving user problems. Despite her relatively young age in the industry, she has developed a deep understanding of how to leverage market feedback, stakeholder management, and cross-functional team inputs to develop nimble processes and create concise product road maps. In this interview which was monitored by THE NIGERIAN OBSERVER, she gives deep insight into how product management is evolving in Nigeria and what it takes to be a successful product manager. Excerpts:

How did you get into product management?

My journey into product management was not planned. After completing a degree in Mass Communication, I was drawn to the vibrant world of technology. My first job was at iTap Solutions Limited, where I worked as a Customer Service Representative. While helping customers troubleshoot issues with our software, some expressed their struggles with understanding how to utilize our Deluxe application effectively. They found the setup to be rigid and confusing, which led to frequent queries and mounting frustration.

Based on the feedback I got from our users, I proposed the development of a Comprehensive Standard Operating Procedure (SOP) for the application. My idea was to create a clear, step-by-step guide that would walk users through the various functionalities of the Deluxe application, making it more accessible and user-friendly.

To support my proposal, I shared specific examples from user feedback, highlighting common areas of confusion and frustration. I emphasised how a well-structured SOP could empower users with the knowledge they needed to navigate the application confidently. This, in turn, would likely reduce the volume of support queries and enhance the overall user experience. My proposal was met with enthusiasm from the team. We collaborated to design and implement the SOP, ensuring it was comprehensive yet easy to understand. After the launch, we monitored user feedback closely and observed a significant decrease in support queries related to navigation and functionality. Users reported a smoother, more intuitive experience with the Deluxe application, validating the positive impact of the SOP.

This experience underscored the value of listening to user feedback and proactively acting on their queries. It also highlighted the importance of clear communication and thorough documentation in improving product usability and customer satisfaction. Although the journey was not without its challenges, transitioning from Mass Communication to a tech-focused role required me to learn new skills and adapt to a different way of thinking. I spent countless hours studying, attending workshops, and seeking advice from industry experts to bridge the gap.

Looking back on my journey, I am reminded of the importance of staying open to new opportunities and embracing challenges and opportunities for growth. While my path into product management may have been unconventional, it has been a rewarding journey filled with learning, growing, and the thrill of bringing innovative ideas to life in the ever-evolving tech landscape of Nigeria.

AfDB 2024: Experts call for new financial mechanism to mitigate foreign exchange risk in energy financing

inancial experts and policy makers have called for a new financial mechanism to address foreign exchange risk in energy financing in Africa. These calls were made at a session organised by the African Development Bank (AfDB) Group as part of its 2024 Annual Meetings in Nairobi, the Kenyan capital. The debates focused on rethinking how clean energy projects are financed in Africa.

Moderated by Wale Shonibare, Director for Energy Financial Solutions, Policy and Regulation at the Bank, the panel included Maureen Hinda-Mbuende, Namibia's Deputy Minister of Finance, Amadou Hott, Special Envoy of the AfDB Group President for the Alliance for Green Infrastructure in Africa (AGIA), Demba Diallo, Executive Director and ehad of Project Development at Africa50, and Auguste Claude-Nguetsopde, partner and head of Banking Sector Advisory at KPMG in South Africa.

Kevin Kariuki, AfDB Vice-President for Power, Energy, Climate and Green Growth, pointed to the issue at the opening of the session: "Energy transition remains a priority for Africa's development, but it is underfinanced. The main problem is exchange rate volatility, which remains a concern for investors."

"So long as we do not have a common currency, we need a transparent and well-governed mechanism in order to guarantee stability for investors, facilitate borrowing and reduce currency risks," he said.

Demba Diallo seconded Kariuki's comments: "Africa50 investors have borne the brunt of the devaluations of several African currencies, such as the Nigerian naira. Reducing currency risk will lower costs and offer a better return per project," he said.

Wale Shonibare pointed out that for Africa to meet its energy and climate targets by 2030, annual investments of \$200 billion are needed whereas investments in 2022 were less than \$90 billion.

"African countries need to increase their national savings and pool their natural resources so that they can use these resources to raise the funds they need for investment in energy infrastructure. That calls for a paradigm shift in project financing in Africa," he said.

Achieving the paradigm shift depends on three key factors. First, access to long-term sustainable financing that mitigates currency risk and keeps electricity tariffs affordable in a context where 600 million Africans still lack access to electricity. Second, African counties must pool and harness their wealth to attract international investors to projects that earn local currency without the need for government guarantees. Third, the continent must make best use of its rare

mineral wealth. Many of these minerals are essential for clean energy technologies and should create new export markets.

The African continent has 60 percent of the world's solar capacity and 50 percent of its wind power capacity. It also has 71.4 percent of the global reserves of cobalt, 76 percent of platinum and 58 percent of manganese. And yet, Africa currently attracts just 3 percent of global investment in energy and 2 percent of all investments in green energy.

African countries could avoid long-term borrowing in hard currency for infrastructure projects that generate revenue in local currency given this context, and pool their natural resources to facilitate borrowing in African accounting units. Panelists made the point that these units would be exchangeable against

international currencies while maintaining stability in relation to local African currencies.

Most countries on the continent rely on hard-currency debt to provide the capital needed for development, exposing project developers to significant currency mismatches and currency risks that are difficult to hedge. This often has a very significant impact on national energy costs. Currency hedges exist, but can be costly and are not available for the currencies of many African countries, particularly in the long term, at low cost, and on the scale necessary to support clean-energy investments.

"We need to engage all stakeholders in the creation of a financial mechanism that enables African countries to mitigate exchange-rate risk in financing of energy infrastructure," Maureen Hinda-Mbuende said.

'If we want to lift Africa out of poverty, we need to do more than pool our resources – we also need to act on pricing. Many of our resources leave our continent without us being aware of their real value," said the Namibian Minister. Namibia is particularly rich in rare earths.

"African countries fail to recognise the immense wealth that they possess. Borrowing on the basis of a basket of currencies would be beneficial to them, and if they can pool their resources, it will bear fruit," said Auguste Claude-Nguetsopde.

'We know that Africa possesses immense commodity wealth. Let's start by looking at the resources in each of our countries and consider how we can make the most of them," Hott concluded.

Landmark ECB cut vindicates Lagarde's monetary strategy

The landmark 0.25 percentage point cut in euro bloc interest rates caps an extraordinary period when the European Central Bank has coped much better than expected in mitigating strains on its 26-member governing council.

Christine Lagarde, ECB president, has managed to steer a middle path between steadfastness in the anti-inflation fight and sensitivity towards central bank governors chafing over the 0.25-point rise in the key deposit rate in September 2023, which an important minority on the council thought was unnecessary.

Announcing the cut on 6 June, the first for five years, Lagarde pointed to the need for prudence in coming months in view of continued upward wage pressures and a headline inflation rate still above the 2%

target. The bank said it was 'now appropriate to moderate the degree of monetary policy restriction' after a 2.5-point fall in inflation since the September hike.

Although the ECB said it was not 'pre-committing' to further interest rate reductions, leading figures on the council have spoken in favour of quarterly rate cuts over the rest of the year. There is a significant belief that above-average wage rises do not indicate any danger of a wage-price spiral. Rather they are seen as a normal catch-up reaction to sharp falls in real wages in the euro area throughout the past few years' inflationary spell.

The ECB is aware of potential vulnerability in moving relatively fast on rates in the current easing cycle, ahead of the Federal Reserve and Bank of England. However, these risks are felt to be manageable in view of the fragile state of large parts of the

euro bloc economy, especially Germany. In view of the Bank of Canada's 0.25-point rate cut on 5 June, as well as reductions in Switzerland and Sweden since March, the ECB can be viewed as occupying the rate-cutting middle ground among a wider group of leading central banks.

The controversial interest rate rise in September was pushed through following a decisive intervention by Joachim Nagel, the Bundesbank president, who has forged a strong strategic bond with Lagarde since taking over in January 2022. The September rise is now termed an 'insurance' hike guarding against the risk that internal and external price pressures could have accelerated during the winter. This eventuality turned out not to materialise. Yet Nagel can be expected to garner credit in managing to push through the rise and stiffen ECB resistance to any slackening of the restrictive stance in the last few month

Lagarde has spoken out against formal 'forward guidance' on interest rates and insisted on adherence to a 'meeting by meeting' assessment of the economic and monetary position. However, the ECB's reduction represents vindication of the position she has maintained for several months that rate cuts were not likely before June.

On his appointment in December 2021 Nagel was enjoined by his backers in the German finance ministry both to help forge a tight ECB monetary policy and to overcome the Bundesbank's previous frequent isolation in the council. Nagel's predecessor Jens Weidmann, now president of the supervisory board of Commerzbank, suffered spells of fractiousness with previous ECB president Mario Draghi.

The relationship between Lagarde and Nagel has gained in

importance amid general praise, even from some monetary hard-liners on the council, for the ECB president's deft psychological handling of her colleagues compared with the often secretive and acerbic Draghi.

The strength of the Lagarde-Nagel axis was underlined already in July 2022 when the Bundesbank president engineered a 0.5-point rate increase to launch a belated start to the ECB's tightening cycle. This was part of a bold and somewhat risky compromise with Lagarde and other key council members. To secure bargaining power over winning the sharp interest rate rise, Nagel first agreed to back the ECB's hotly debated 'transmission protection instrument' to safeguard the position of higher-debt euro members.

In other moves to underpin cohesion in the council, Nagel has organised behind-the-scenes diplomatic initiatives with Fabio Panetta and Pablo Hernández de Cos, heads of Banca d'Italia and Banco de España, two central banks whose monetary views in the past have frequently been at odds with the Bundesbank's.

An intriguing role in delicate ECB council maneuverings has been played by Robert Holzmann, president of Oesterreichische Nationalbank. He has frequently taken up provocative minority positions on interest rates as well as other issues such as optimal levels of minimum reserves.

Part of Holzmann's reasoning is that, by adopting extreme positions, he allows leeway for other traditionally hawkish council members such as Nagel and Klaas Knot, president of De Nederlandsche Bank, to present their views as relatively centrist. In line with this strategy, Holzmann was the only member of the council on 6 June to argue against the interest rate reduction.

How to plan and develop a new product for your business

ay by day, people and companies get innovative and come up with ideas of new products, which they bring to fruition. They manufacture products and introduce them into the market to meet the needs of consumers and for profit. Before a product is developed, there are some factors to consider in order to ensure its success. New products are a vital part of a company's competitive growth strategy. Most manufacturers cannot live without new products because they can have more of current sales in good new products.

Below are the product attributes that have significant impacts on a new product purchase and acceptance by consumers:

Superiority: For a new product to be accepted by consumers, it should be unique and better than the existing products. It should provide something beneficial that the old ones don't. If it's a product that has never existed, it should be of high quality and assurance.

Sociability: The new product should be compatible or consistent with consumers' beliefs, values, and lifestyles. For example, if you want to produce a new design of clothes for elderly women, you should produce wears that will fit and cover their bodies properly and not skimpy ones.

Satisfaction: You should consider if consumers will be content with your product. Every new product should be designed and developed to meet a need, and consumers should be pleased and satisfied after using it.

Simplicity: Your new product should be easy for consumers to understand and use and for marketers to promote. Don't go designing a product that a consumer can't easily fathom opening it. I've seen products like that: sometimes, you would have to start looking for an intelligent guy around to help you open it or show you how it works. There are even some food grinders that you cannot use for the first time, even with the instructions on the cartons, unless someone else shows you how to operate them.

Speed: The extent to which the benefits of the product are being experienced immediately, rather than at a later time should be considered.

After a new product is developed, the steps that should be taken include:

Test marketing: Until now, the product has been the company's secret. During test marketing, there should be programs in line with plans for launching the product, which involve general marketing strategies that would entail lots of promotions. The product is introduced to wholesalers, who then introduce it to retailers, who introduce it to consumers. At this stage, feedback is vital and required to help improve the product to make it consumer-friendly. It would be bad for the product if 1000 consumers buy it at the initial stage and have negative experiences with it. Thus, further improvement might not really help the product stand well in the market

the market.

Commercialization: This is the launching step. During this stage, great emphasis is on the organization structure and management talent needed to implement the marketing strategy. Emphasis is also given to following up on such things as faults in the design, production costs, quality control, and inventory requirements. Furthermore, procedures and responsibility for evaluating the success of the new product by comparison with projections are also finalized.

CAUSES OF NEW PRODUCT FAILURE

Many new products with satisfactory potential have failed to make the grade. Some of the reasons for new product failure are connected with execution and control problems. Below are the main causes of new products' failures after they have been carefully screened, developed, and marketed:

- 1. Faulty estimates and market potential.
- 2. Unexpected reactions from competitors.
- 3. Poor timing in the introduction of the product.
- Rapid change in the marketing procedures after the product was approved.
- 5. Inadequate quality control.
- 6. Faulty estimates in production costs.
- Inadequate expenditures regarding the initial promotion process.
- 8. Faulty marketing testing.
- 9. Improper channel of distribution.

Some of the above problems are beyond the control of management, but it is clear that successful new product planning requires large amounts of reliable information in diverse areas. Each department assigned functional responsibility for product development automatically becomes an input to the information system needed by the new product decision-maker. For instance, when a company is developing a new product, it is wise for both engineers and marketers to consider both the kind of market to be entered, such as consumer, industrial, defense, and specific target segments. These decisions will be of paramount influence in the design and cost of finished goods, which will directly influence price, sales, and profits.

THE NEED FOR RESEARCH

The keystone activity of new product planning is research, not just marketing research but technical research also. New product project reports should be more than a collection of expert opinions. The following questions should be answered during the research:

- What is the anticipated market demand? Are the potential applications for the product restricted?
- 2. Can the product be patented?
 Are there any antitrust prob-
- 3. Can the product be sold through present channels and sales force?
- 4. At different volume levels, what will be the unit manufacturing costs?
- 5. What is the most appropriate package to use in terms of color, material, design, and so forth?
- 6. What is the estimated return on investment?
- 7. What is the appropriate pricing strategy?

While the above list is not exhaustive, it serves to illustrate the serious need for reliable information, which can be obtained through time-consuming and expensive marketing research studies. Other data can be generated in the engineering laboratories or pulled from accounting records. Certain types of information must be based on assumptions, which may or may not hold true, and on expectations about what will happen in the future, in the case of anticipated competitive reaction or the projected level of sales.

NEW PRODUCT POLICY

In developing a new product policy, the first question a marketing manager should ask is, in how many ways can a product be new? There are at least nine different ways:

- A product performing an entirely new function, such as television, which for the first time permitted the transmission of audiovisual signals.
- 2. A product that offers improved performance of an existing function, such as a wristwatch, whose balance wheel has been replaced by a timing fork.
- 3. A product that is a new application of an existing product.
- A product that offers additional functions. The hands-free telephone, for instance, does what the earlier telephone did and more.
- An existing product that, through lower cost, is able to reach more buyers. The hand calculator is an example.
- An existing product offered to a new market. This may be done by repositioning or taking a regional brand into other regions.
- An upgraded product defined as an existing product integrated into another existing product, such as the clock-radio.
- 8. A downgraded product. For example, a manufacturer that switches from buying a component to producing a cheaper component in-house and marketing it.
- 9. A restyled product, such as annual auto and clothing changes.

Nigeria and the regionalism question

espite the House of Representatives' coming out to publicly deny any Bill entertaining the thought of regionalism, the mere suggestion of reintroducing regionalism has resurrected a long-simmering discussion on the nation's political framework. Recently, a trending draft bill that proposes a return to the regional system of government in Nigeria surfaced, kicking off a maelstrom of scrutiny and speculation.

The proposed legislation aims for the revival of the regional system of government, dormant since 1967, which would mean that the existing 36-state federal structure would be supplanted. Intense dialogue has followed this revelation, leading many to speculate on the country's future.

The document was titled "A Bill for an Act to substitute the annexure to Decree 24 of 1999 with a new governance model for the Federal Republic of Nigeria", and was authored by Dr. Akin Fapohunda, who is neither a senator nor a member of the House of Representatives.

Proponents of regionalism have argued in the past that it would promote greater autonomy, decentralization, and more effective governance. On the other hand, critics fear it could exacerbate ethnic tensions and undermine national unity.

At any rate, the House of Representatives spokesman, Akin Rotimi, apparently dismissed the bill, stating, "The Committees on Rules and Business and Constitution Review have confirmed that there is no such bill before them." However, Nigerians are still left wondering if regionalism might be the answer to the country's political woes or a step backward into a tumultuous past.

NIGERIA AND REGIONALISM

The roots of regionalism in Nigeria can be traced back to the pre-independence era, when the British colonial administration fragmented the country into three autonomous regions: Northern, Western, and Eastern. Each region was endowed with its own government and premier, in a bid to accommodate the country's kaleidoscopic ethnic and cultural diversity. The Hausa-Fulani dominated the North, the Yoruba the West, and the Igbo the East.

However, this system was fraught with political tensions, corruption, and ethnic rivalries, which ultimately led to its demise in 1967. The federal government, under the leadership of General Yakubu Gowon, supplanted the regional structure with a 12-state federal system, which has since undergone multiple transformations, culminating in the current 36-state framework.

Can Nigeria's development truly be revolutionized by actively decentralizing power to the country's geopolitical zones? With deep consideration of the political landscape and strengths of each region, many believe that by



harnessing the unique resources and advantages of each zone, Nigeria has the potential to unlock more effective governance and tackle its entrenched challenges.

But what are the potential benefits and drawbacks of this approach? And how do the political dynamics of each zone shape the viability of regionalism as a solution to the country's political quagmire?

DELTA, A MICROCOSM OF NIGERIA'S ETHNIC DIVERSITY

Let's take Delta State. Located in the Niger Delta region of Nigeria, the state offers a compelling case study for the potential benefits of regionalism in the country. As a microcosm of Nigeria's ethnic diversity, with various ethnic groups including the Urhobo, Itsekiri, Ijaw, Isoko, Anioma, etc, this diversity had often led to tensions and conflicts over resources and political power.

However, with their organized governorship rotation system among its ethnic zones, Delta State has demonstrated that regionalism can be a powerful tool for promoting peace, stability, and development.

Under the zoning system, the governorship of the state is rotated among the three senatorial districts, each representing a distinct ethnic zone. The rotation is based on a principle of equity and fairness, ensuring that each zone has an opportunity to produce the governor of the state. This system is expected to promote a sense of belonging and inclusivity among the various ethnic groups, reducing tensions and conflicts over political power.

The success of Delta State's governorship rotation system has important implications for regionalism in Nigeria. It suggests that by devolving power to the regions and promoting a sense of ownership and inclusivity among ethnic groups, Nigeria can harness the unique strengths and resources of each zone and promote more effective governance.

ARGUMENTS FOR AND AGAINST REGIONALISM

As Nigeria grapples with the challenges of governance and development, many are turning to regionalism as a potential solution. Last year, Aare Onakakanfo of Yoruba land, Iba Gani Adams, described regionalism as the best option to salvage Nigeria's future.

"Democracy thrives in a country where the majority of the people have their ways in determining the quality of their lives. Democracy is the best form of government when the leaders place the general good of the people above theirs," Adams said.

"That is when there is unity, peace and tranquility in the country. But in a situation where there is prolonged hardship, both economic, social and political tension and insecurity, the purpose of government is defeated," he said.

On the other side of the debate, Stanley Osifo, a former presidential aspirant in the ruling All Progressives Congress (APC), rejected the concept of regionalism, instead choosing to stress the importance of national unity and collaboration with the current administration to foster development across Nigeria.

When asked in an interview with the New Telegraph about his take on restructuring and regionalism some months back, Osifo asserted that reverting to regionalism would stifle development, and that the creation of more states was a more feasible approach to the idea of restructuring.

He said, "If you say we should go back to regionalism, is it because of the cost of governance? If we want to develop, we will incur cost, we cannot develop in isolation. If we want to make Nigeria one of the most developed countries in the world, we must create more states and have capitals in areas that are not developed so that this would lead to many other things that come with development."

Meanwhile, under the auspices of De Renaissance Patriots Foundation, the Lagos Indigenes issued a statement recently via their Media Office, asserting their refusal to accept any Bill aimed at reverting Nigeria to a regional system. The group vehemently declared that Lagos State will not be absorbed into the Western Region.

Adelani Adeniji-Adele, representing De Renaissance Patriots Foundation, posited that the Bill portends an ominous fate for Lagos State, threatening to subsume their distinct aspirations within a larger entity that fundamentally contradicts their values and beliefs as Lagos Indigenes.

"In recent times, our various indigenous groups had always maintained that we as indigenes of Lagos had always been having a raw deal from our neighbours in the South West, who see nothing good in us as they are only for a project to marginalize us and see our state as 'spoils of war," Adeniji-Adele said.

"We recall that in our history of over 100 years, Lagos indigenes in their various forms, towns and villages have never made progress and development as part of any region not to talk of the Western Region. The brief balkanization of our state to be part of the Western Region was an aberration," he said.

PRESIDENTIAL OR PARLIAMENTARY SYSTEM?

There have also been calls for a parliamentary system of government, where the head of government draws their legitimacy from the support of the legislature, to which they are accountable.

In this setup, the head of government's authority stems from their ability to command the confidence of the parliament, fostering a more collaborative and representative democracy. Many believe that this system has the potential to revolutionize Nigeria's political dynamics, promoting a more responsive and accountable government.

However, the former Lagos State governor, Babatunde Raji Fashola (SAN), cautioned proponents of a parliamentary system comeback to reassess their stance, pondering whether the underlying factors that led to its downfall in the First Republic still linger, necessitating a thorough examination of the political landscape before revisiting a seemingly antiquated governance model.

He posited, "Those calling for the system change are instigated by economic reasons, if only they are confident the government would provide their economic needs, they won't chant this clamour for change."


n the days and weeks before Bola Tinubu became president, he had many sobriquets. The sobriquets depended on the side of the aisle that the admirers or the traducers stood. To the Obidients, Tinubu was Balablue, emilokan and an alleged drug lord. But to his admirers and fans, he was the man with the magic wand who with just an abracadabra, had come to take away the heavy burdens that Muhammadu Buhari inflicted on us all. They couched that belief in President Bola Tinubu as a 'master strategist'.

There are many reasons why Bola Tinubu was often referred to as 'master strategist'. A very close person had told me that the man is a very good listener who has a knack for taking notes. He is said to keep a notepad somewhere with which he records sensitive info on which he peruses before taking crucial decisions. Another story said to be responsible for Tinubu's vaunted deftness is that he has a knack for spotting great talent, and would often discard ethnic, religious and primordial considerations to get at those talents for his own use. Critics of his adoption of this strategy say that he stole the idea of pooling outstanding talents from MKO Abiola. Before June 12, 1993, MKO Abiola who was criticized for not having any economy or finance background had fired back that as president of Nigeria, he had no need of an economy background if as president he can hire and fire an economist.

In his years as governor of Lagos State, Bola Tinubu had gone ahead to get as many talented people, Lagosians and non-Lagosians, to join him with running the state. They include Mr Yemi Osinbajo SAN, Ben Akabueze, Babatunde Fashola, Rauf Aregbesola and their ilk. It is mostly the successes recorded with his grooming his lieutenants and propping them for future leadership that more or less made him to be perceived as a strategic thinker and political tactician. He has also been said to have built a political empire like a behemoth that has a better reach and connection than the tentacles of an octopus.

But one year after being president of Nigeria, is his 'master strategist' sobriquet still relevant and strong? Less than one year after being sworn in as president of Nigeria, the master strategist so-called has unleashed suffering so intense on Nigerians. One of the very first things he did was remove fuel subsidy. Said to be a good move not well-thought through, the fuel subsidy removal spiralled and set off a chain reaction of pain and suffering among Nigerians so intense that many Nigerians began to wish for the return of the life and times of Muhammadu Buhari instead of that by Bola Tinubu. A little while after that fuel subsidy removal came a staccato of tax after tax after tax after tax. Those taxes have begun to look very much like the biblical story of a king who told his subjects that while his father flogged his subjects with whips, he would do his own flogging with scorpions. Whilst the rest of Nigerians were carrying these extremely heavy burdens, and were requested to make more and more sacrifices, the ruling elite were having what looks like a field day on a spending spree: members of parliament were getting fantastic monies for state-of-the-art vehicles, and

the presidency was still junketing here and there with extremely large entourages. It seemed as though there were two Nigerias - the one which hardly pays those taxes, buys its own food, pays those electricity bills, but which goes to the same market as the other who does.

Ekpenyong Ntekim, while the Secretary to the Government of Akwa Ibom State, Prince Enobong Uwah, will serve as the Special Guest of Honour.

According to the Center, a former Speaker of the Akwa Ibom State House of Assembly and immediate past member of the House of Representatives, Rt. Hon. Onofiok Luke, is billed to deliver a keynote address while the Chairman of the House Committee on Public Accounts and member representing Ukanafun/Oruk Anam Federal Constituency in the House of Representatives, Rt. Hon. Unyime Idem, will be the distinguished guest of honour.

CHRAN further stated that the Deputy Speaker of Akwa Ibom State House of Assembly, Hon. Kufre Abasi Edidem, will be the Guest of Honour, while the Akwa Ibom State Commissioner for Local Government and Chieftaincy Affairs, Hon.

Electronic transactions stall as NIBBS suffers glitch

The Nigerian Inter-Bank Settlement System (NIBSS) has been experiencing glitches which have caused downtime and large-

scale delays in electronic transactions to financial institutions across the country.

The said downtime has affected the efficiency of banks and financial technology firms across the board, stalling and

delaying the transactions of teeming customers.

Fintechs including Eversend and Kuda Bank have alerted their customers about the development.

Eversend informed its users

that delays in naira transactions are expected to persist, affecting top-ups and payouts within the app. Similarly, Kuda Bank notified its customers that intermittent issues with NIBSS are causing delays in

Transfers to and from Kuda accounts, as well as transfers between Kuda and PalmPay accounts, are reportedly unaffected.

We'll keep you updated on our status page – status.kuda. com," Kuda said in a notice to its customers.

NIBBS provides infrastructure for the automated processing and settlement of transactions between banks acting on their own account as regards deposit placements, treasury bills transaction, naira settlement on inter-bank foreign exchange transactions

It also initiates and develops an integrated nationwide network for the electronic or paperless payments, funds transfer and settlement of transactions.

The exact cause of the downtime and the estimated time for resolution have not been disclosed. In the meantime, customers are advised to use alternative means of transactions where possible and remain patient as efforts to restore the NIBSS platform continue.

Cybercrime a big challenge for fintechs, says RoutePay MD

"The CBN insists on the interoperability of the systems. The regulators are making efforts. Everyone is expected to contribute to the sanction listthat is, the name of any blacklisted merchant. It is an obligation to submit these names," he said.

To him, a central database of records will prevent businesses from on-boarding blacklisted merchants. "We need a tech-driven approach to reporting and solving the problem. It should be a well-defined sys-

tem of collaboration capable of fighting fraud. Yes, WhatsApp groups of industry players are essential, we must go beyond informal relationships to fight cybercrime.

"The name of the game is collaboration. There is a need to leverage on partnership. Systems should not run in silos. The level of collaboration needs to be improved and that's why we need a centralised database to supply report on blacklisted merchants"

He also emphasised the need for a joint session on fintech to discuss the issue, noting that Service providers should encourage the use of common database.

UNIBEN Mgt reconsiders SUG, sets up electoral commission

mid controversy concerning the suspension ▲of Student Union Government (SUG) activities as well as several executives, the management of the University of Benin (UNIBEN) late May released a memo containing the list of cleared electoral commission members ahead of the 2024 SUG elections.

According to the memo dated 27th May, the Senate, in a meeting held on 2nd May 2024, approved the recommendation

for the setting up of an electoral commission comprising representatives from the various faculties and schools across the university to oversee student affairs, amongst other functions.

The university management had suspended SUG activities due to an incident that occurred at the Senior Staff Club on 12th April 2024 during the visit of the Labour Party governorship candidate in the Edo 2024 election, Olumide Akpata.

"The commission was set in place to handle issues pertaining to the interests, welfare and development of students and conduct the election of a new set leadership," the memo said.

The list of the cleared members includes Mr Collins Obhiozone (Pharmacy), Miss Idode F. (Law), Mr Peter Omotosho (Agriculture), Mr Eric Bassey (Arts), Mr Eghosa T. Eghiosun (Dentistry), Mr Omosigho J. Owire (Education), and Mr Caleb J. Cookeygam (Engineering).

Others are Mr Jeremiah Wilson-Koro (Environmental Sciences), Miss Margaret Iyasele (Life Sciences), Miss Clara Kikeboh (Pharmacy), Miss Lucy

Eriamiatoe (Physical Sciences), Mr James Olawale (Basic Medical Sciences), Miss Okpare Ojiyovwi (Social Sciences), Mr Osayi M. Eubadoloyi (Veterinary Medicine), Mr wisdom Omorogbe (Medicine), and Mr Stanley I. Ige (Management Sci-

The memo said the commission is to ensure the election process is carried out smoothly and efficiently, as well as maintain student decorum in the days leading up to the election.

UNIBEN Mass Comm has moved into the realm of digitalization -Dr. Ekereafo

The Department of Mass Communication, University of Benin (MAC-SA UNIBEN) has taken a significant leap forward with the introduction of new facilities and equipment, poised to revolutionize the learning experience for students.

The Acting Head of Department, Dr. Dan Ekereafo, who disclosed this, said the department has overcome the long-standing challenge of inadequate equipment, achieving significant milestones in recent times. The acoustic work on all studios has been completed, the radio studio has been revived awaiting the installation of a transmitter, a cinema room has been set up, equipped with a 75-inch television for an immersive experience, he said.

Dr. Ekereafo emphasized the importance of digital skills in today's media landscape, highlighting the department's commitment to organizing monthly workshops to address specific areas of digital media. He said students will receive hands-on training in editing, studio editing, and software applications, empowering them with practical skills.

"We have hands-on experiment and appropriate software what we call self-learning andragogy. So, part of the vision is to teach and allow students to practice what they've learnt," he said.

To ensure proper maintenance and safety, the department has implemented measures such as requiring permission for studio usage, restricting flash drives, and providing technical guidance. The cinema room offers a cinematic experience, and the department has established a YouTube channel and blog to showcase student content and serve as a reference site for future projects.

The photo studio boasts basic equipment, with plans to replace obsolete items. The control room is now equipped with necessary tools for studio production and editing processes. However, the department still faces the challenge of acquiring cameras, with a goal to secure three cameras for the studio and two for the photography studio.

Despite ongoing challenges, the department has secured funding from registration revenue and alumni contributions, channelling these resources into specific needs.

The library has also been enriched with book donations from Dr. Ekereafo, Prof Okhaku, Prof Asemah, and De Wilfred Oyegu, a former staff member.

Again Super Eagles fail to defeat Bafana Bafana

remain winless?, play Benin Republic today

Inidi's first match as Nigeria's coach saw the Super Eagles again rallied to another 1-1 draw against Bafana Bafana of South Africa in the first leg of their fading hopes of 2026 World Cup qualification encounter on Friday at the Godswill Akpabio International Stadium, Uyo.

As a result, Nigeria is now placed fifth in a six-team table after three matches in the 10-match competition. Nige-

ria has drawn all three of their matches so far.

Fisayo Dele-Bashiru's second-half strike earned the team a point, thereby cancelling Thembo Zwane's first-half strike to ensure the Super Eagles earned a share of the spoils.

In pursuit of a desired win, coach Finidi opted for Stanley Nwabali in goal behind the defensive four of Calvin Bassey, Semi Ajayi, Bright Osayi-Samuel and Tanimu Benjamin.

Wilfred Ndidi marshalled the team in midfield alongside Alex Iwobi and Dele-Bashiru, while Paul Onuachu, Kelechi Iheanacho and Ademola Lookman led the attack.

Ndidi had said the team's preparation for the game was partly hampered by Nigeria's Organised Labour strike that shut down Nigeria earlier last week.

The stretchy preparedness was apparent in the early stage of the game, and the South Africans took the lead in the 29th minute. Themba Zwane drove into the Nigerian goal area and received a brilliant pass before waltzing through to smash the ball into the net beyond Nwabali

Bafana Bafana looked better until the halftime break when the Eagles emerged as an improved side. Immediately after the restart, Nigeria got the equaliser after Dele-Bashiru swivelled beyond Mothobi Mvala on the edge of the South African goal area and slotted his shot past a sprawled Ronwen Williams.

Nigeria remain winless after three games of the 2026 World Cup qualifiers. Recall Nigeria drew Lesotho and Zimbabwe last year.

The team sits fifth on the log with three points.

With three consecutive draws from two home matches and an away duel, the Super Eagles appear unlikely to emerge leaders at the end of the 10-match series. They may not even emerge among those to go for the playars.

It had been envisaged that Nigeria would not drop any of the six obtainable points on Matchdays 3 and 4. But that has faded out like smoke.

The Super Eagles will play the Benin Republic, their fourth game of the campaign, in Abidjan today, Monday, June 10, 2024

Meanwhile, South Africa head coach, Hugo Broos has praised his players after their hard-earned 1-1 draw against Nigeria on Friday night.

The South Africans who have never lost a match to Nigeria at the Uyo stadium, were even more daring and more purposeful in the attack. They were forced to a 2-2 draw in their first match with Nigeria in Uyo 10 years ago.

They followed up with a shock 2-0 win seven years ago before this Friday's 1-1 draw.

Bafana Bafana now have four points from three games and remain in contention to secure a place at the 2026 FIFA World Cup.

With a home match against bottom-placed Zimbabwe at the Free State Stadium, Bloemfontein on Tuesday, they look a more candidate to emerge from the group, although they are currently fourth on the log.

Benin Republic national team, Cheetahs, must be elated with the 1-1 draw the Super Eagles laboured to grab against Bafana Bafana on Friday in the ongoing World Cup qualifiers. The scoreline put Benin Republic ahead of Nigeria just as three others – Lesotho, Rwanda and South Africa.

The group winners will qualify for the 2026 World Cup in Canada, Mexico, and the United States; the four best-ranked runners-up will enter play-offs, with the winners advancing to an intercontinental tournament where six nations will compete for two spots

Champions from seven countries within the WAFU-B Zone, including Benin, Burki-

na Faso, Côte d'Ivoire, Ghana, Niger Republic, Nigeria, and Togo, will compete for the sole slot in the finals.

Edo Queens clinched their first-ever Nigerian title last month in Yenegoa and will represent Nigeria after finishing at the top of the NWFL Premiership Super Six table in a thrilling finale.

In the past three years, the final of the WAFU-B Women's Champions League Qualifiers has predominantly featured a showdown between Nigeria and Ghana, with Ghana emerging victorious in two out of three editions.

During the inaugural WA-FU-B Women's Champions League Qualifiers in 2021, Rivers Angels represented Nigeria and reached the final, where they were defeated by Ghanaian side Hasaacas Ladies.

Bayelsa Queens emerged victorious in the second edition of the WAFU-B Women's Champions League Qualifiers, securing a 3-0 victory over another Ghanaian side, Ampem Darkoa, in Cote d'Ivoire. In a separate match, Ampem Darkoa defeated Nigeria's Del-

ta Queens 1-0 to claim the title in the 2023 edition.

Cote d'Ivoire has hosted two out of the past three editions of the WAFU-B Women's Champions League Qualifiers, in 2021 and 2022, while the last edition in 2023 was held in Benin City, Nigeria.

Alcaraz defeats Zverev in five

arlos Alcaraz becomes the seventh man - and I the youngest - to capture Grand Slam titles on all three surfaces after winning

Carlos Alcaraz was made to sweat but clinched his first French Open title by outlasting Alexander Zverev 6-3 2-6 5-7 6-1 6-2 in Sunday's final at Roland Garros.

Fourth seed Zverev had sent old warrior Nadal out on time in the first round.

But young pretender Alcaraz vanquished the German to join fellow Spaniard Nadal as the only men to lift the Roland Garros trophy aged under

The Spaniard became the youngest man to win a Grand Slam title on all three surfaces, adding the Paris clay to his hard-court US Open success and last year's win on the Wimbledon grass.

He boasts a perfect record in major finals, while for Zverev it is two defeats from two following his loss to Dominic Thiem at the US Open four years ago.

Alcaraz was the clear aggressor as the first set wore on and he took it in 43 minutes.

Swiatek tops Paolini, wins fourth French Open title in five years

ga Swiatek of Poland has defeated Jasmine Paolini, her Italian counterpart, to clinch the 2024 French Open women's singles title.

The Polish tennis star continued her relentless dominance on clay as she claimed her fifth Grand Slam title overall with the victory at the Court Philippe Chatrier on Saturday.

It took Swiatek just 68 minutes to close the final out in an utterly ruthless display against Paolini, who was in her first Grand Slam final.

Swiatek successfully defended her French Open title with an emphatic two sets 6-2, 6-1 win over Paolini.

Swiatek becomes the third woman to win three French Open titles, and the victory is her fourth French Open title in five years, having triumphed in 2020, 2022, 2023 and now 2024, and the third in a row, matching the feats of only Monica Seles (1990-92) and Justine Henin (2005-07) in the Open era by winning three consecutive finals at Roland Garros.

At just 23 years old, she's now three off equaling Chris Evert's record of seven women's singles titles at Roland Garros. Fittingly, it was Evert and Martina Navratilova who handed over the Suzanne Lenglen trophy to the new master of clay.

The 12th-seeded Italian broke Swiatek in the third game of the opening set to take a 2-1 lead. However, the number one seed prevailed over Paolini in 69 minutes.

The second set was a stroll in the park for Swiatek as she dispatched off the 28-year-old Italian easily to her fourth Coupe Suzanne Lenglen.

The 23-year-old inked her name as the youngest woman in the Open Era to win four French Opens.

Swiatek was the overwhelming favourite heading into the final. She had to survive a match point in her second-round tie with Naomi Osaka, but from there, she was in complete control -including winning her fourthround match against Anastasia Potapova 6-0, 6-0 in just 40 minutes. She then overcame 2023 Wimbledon champion Marketa Vondrousova in the quarterfinals and Coco Gauff in the final four, winning that 6-2, 6-4.

Paolini was an outsider for the title heading into the competition, but she put together a brilliant run that included knocking out 2022 Wimbledon champion Elena Rybakina in the quarterfinals and

then 17-year-old prodigy Mirra Andreeva in the semifinals.

Swiatek will turn her attention to Wimbledon and grass, the last remaining surface on which she has yet to win a Grand Slam.

In the co-main event, Ireland's Katie Taylor, the undisputed women's light-welterweight world champion, will face Puerto Rico's Amanda Serrano in a rematch at the AT&T Stadium in Arlington, Texas, home of the NFL side Dallas Cowboys.

Originally slated for July 20th, the two fights were delayed due to medical advice after Tyson, who will turn 58 later this month, experienced a recent flare-up of an ulcer.

The Tyson-Paul match, set

to be aired on Netflix, has received official sanctioning as a professional fight and will consist of 10 two-minute rounds.

Tyson's last professional fight dates back to 2005, although he did participate in an exhibition match in 2020.

hiny objects catch our attention. When job searching, you want to be that shiny object that catches the attention of employers; exposure is the key. There's no "shiny" without exposure.

Some people—perhaps you know one or two-are constantly sought after by employers, while most chase employers. Sought-after people understand it's not their knowledge or experience that will make them attractive to employers, but what they show. (read: expose) Consequently, the adage "It's who you know, not what you know" has been replaced with "It's not who you know, it's who knows you."

In today's job market, finding a job boils down to making yourself as attractive to employers as possible. When you appear on an employer's radar, you want them to say, "I must meet this person!" The more attractive you are as a "must-meet," the more opportunities will present themselves.

Whether or not you successfully attract opportunities depends on what you strategically (keyword) show the world. Fundamentally, when searching for a job, your skills and experience matter less than what you show.

(Of course, you must show employers what they want to see.) Showing requires visibility; visibility requires exposure, which can be achieved in several ways.

UTILIZE SOCIAL MEDIA TO BUILD A STRONG PRESENCE

Employers and recruiters pay attention to online "goings-on," hence the obvious: Use social media to promote vourself.

When done correctly and consistently, your digital footprint will showcase your expertise and connect you with influencers in your field and industry, along with:

- 1. Positioning you as an expert in your industry and/or profession.
- 2. Demonstrating your communication skills, a skill employers highly

The key is to be active, ideally daily, and not just passively observe. Don't just create profiles and let them sit there. Participate in LinkedIn groups, write posts and guest blogs, share insightful content, and ask questions.

Social media's reach is unfathomable. You never know who might read your profile or content and contact you. Years ago, I got a call from Crocs's VP of Human Resources. The head of marketing had seen my Pinterest board, 'Brands That Have My Heart,' which included Crocs— it's common for employers to Google themselves to see what's being said about their products-and after reviewing my LinkedIn profile, felt I might be a good fit for an open position he had. I ended up working for Crocs for sev-

My social media posts often lead to recruiters and employers contacting me. When used to build a visible personal brand, the Internet and social media are job seekers' best friends.

BECOME AN ACTIVE MEMBER OF A PROFESSIONAL ASSOCIATION

Professional associations are the perfect place to increase your visibility with like-minded individuals who share a passion for a particular profession or industry. Employers often look for candidates among association members. Understandably, employers prefer players in their industry, people who exhibit an affinity for their profession and industry by staying current with news, trends, and market changes, information that can come in handy during interviews.

As with not leaving your social media idle, don't join an association solely to list it on your resume and LinkedIn profile. Being visible in an

organization requires active participation. Volunteer to recruit conference speakers, or, even better, be a speaker/panellist yourself. Write for the association's newsletter, offer to manage their social media, or sit on a committee.

Becoming a member of an association opens you up to a smorgasbord of networking opportunities with people who are most likely attached to opportunities in some way. Hence, to be top of mind for the opportunities they're connected to, they first need to know you.

VOLUNTEER 'STRATEGICALLY'

You probably know someone whom everyone knows because of their volunteer work.
