

Police invitation to Ajaero: More critical unions give strike notices

•As US-based union petitions Nigerian Embassy

LAGOS — Following Dolice invitation of President of Nigeria Labour Congress, NLC, Joe Ajaero, for questioning over allegations of criminal conspiracy, terrorism financing, treasonable felony, subversion and cybercrime, more critical unions, which are NLC affiliates, yesterday gave strike notices to their members to proceed on indefinite strike should Ajaero be arrested.

This came on a day the International Longshore and Warehouse Union, ILWU, based in North Point, San Francisco, United States of America, petitioned the Nigerian Embassy in Washing ton, faulting the perceived harassment and persecution of trade unions and their leaders in Nigeria.

Among unions that had already given strike notices to their members are the National Union of Electricity Employees, NUEE; Nigeria Union of Teachers, NUT; and National Union of Textile Garment and Tailoring Workers of Nigeria, NUTGTWN.

Others include MWUN; Iron and Steel Senior Staff Association of Nigeria, IS-SAN; Fitters Senior Staff Association of Nigeria, FIS-SAN; Nigeria Union of Agriculture and Allied Employees, NUAAE; National Union of Railway Workers, NUR; Nigeria Civil Service Union, NCSU; and National Union of Postal and Telecommunication Employees, NUPTE.

MWUN in a circular to its local leaders in all port formations in Lagos, Warri, Calabar and Port Harcourt, said its members would comply with the strike directive.

Deputy Secretary-General of the union, Oniha Erazua, said the directive for indefinite nationwide strike was also extended to terminals, jetties, dry ports and oil export terminals.

The notice read: "The decision follows an emergency National Executive Council, NEC, meeting of the NLC held on Tuesday, August 20, 2024, in response to what the Congress describes as 'persistent orchestrated attack' on the labour movement by the Nigeria Police Force, NPF.

"As an affiliate of Nigeria Labour Congress, NLC, we are in compliance and have consequently directed all our members to commence the mobilization of our members to effectively ensure their participation in the nationwide indefinite strike and be on red alert.

"The strike, set to begin at midnight, is a protest against the NPF's investigation into NLC leadership, including charges of terrorism financing, cybercrime, subversion, criminal conspiracy, and treasonable felony, which the NLC has condemned as 'clearly unfounded and politically motivated.'

MWUN's leadership emphasized the urgency and importance of the strike, calling on all members to unite in solidarity with the NLC and the broader Nigerian working class.

"This decision is due to the clearly unfounded and politically motivated police investigation... labelled against the Congress President and the Nigeria working class.

"As the deadline for the strike approaches, MWUN has instructed its members to remain vigilant and fully prepared to participate in the industrial action, which is expected to significantly impact the maritime sector and related industries nationwide," the union stated further

NUT asks teachers to prepare for nationwide strike, if...

On its part, the Nigeria Union of Teachers, NUT, also directed teachers nationwide to down tools and begin an indefinite strike should the Police arrest Ajaero.

NUT in a circular to its state wings nationwide by its President and Acting Secretary-General, Audu Amba and Abdullahi Mohammed, said: "As you may be aware, the President of NLC was invited by the Nigeria Police Force on the premise of unfounded and politically motivated investigation into alleged ter-

rorism financing, cybercrime, subversion, criminal conspiracy, and treasonable felony.

"The Congress considers the act of harassment and intimidation as an attempt by the Police to stifle the voice of the working people as represented by the Leadership of Congress.

"Consequently, the NEC of the NLC met and resolved to, among other things, direct all affiliates and state councils to immediately commence the process of mobilizing their members across the nation as the Congress would not hesitate to take all necessary actions to protect the integrity and independence of the labour movement.

"In the light of the above, the NUT hereby directs all state wings of the union to mobilize all teachers and be prepared to proceed on an indefinite nationwide strike, if anything happens to the President or any other leader of the Congress.

"The NUT stands with the NLC in this struggle to uphold justice, fairness, and the rule of law in our nation. All state wings are, therefore, directed to be on alert as they await further directives.

US based union fumes Meanwhile, the International Longshore and Warehouse Union, ILWU, based in North Point, San Francisco, United States, has lashed out at the Nigerian security agencies for alleged persecution of the labour movement in Nigeria

In a letter to the Nigerian

Embassy in Washington DC, ILWU President, Trent Willis, said: "The International Longshore and Warehouse Union Local 10, which represents longshoremen working in the San Francisco Bay Area, protests in the strongest terms this attack against our fellow trade-unionists.

"We demand that all the seized materials be returned, and that there be no further reprisals against the NLC.

"This raid came just hours after the NLC held a meeting critical of your government's repression against students and others who have been protesting over the last two weeks against the austerity measures imposed by your government. Scores of protesters have been killed.

"Hundreds more, including prominent protest leaders, have been arrested and many are still in jail.

"These include protest leaders such as Adaramoye Michael ("Michael Lenin"), national coordinator of the Youth Rights Campaign, Mosiu Sodiq, Eleojo Opaluwa and Babatunde Oluajo ("OSB Sankara"). "According to the latest reports, Michael, Sodiq and Eleojo remain in custody. The NLC rightly condemned your attempt to criminalize protest.

"We have active members of our union who were born in Nigeria and who maintain ties with their homeland. The international labour movement is watching. We demand an end to the repression and freedom for all the detainees, hands off the NLC."



#EndBadGovernace: CSOs berate FG for prolonged detention of protesters without charges

•NHRC writes NBA, seeks help to free detained protesters

BUJA— FOLLOWING the Afailure of the Federal Government to arraign #endbadgovernace protesters since August 1, 2024, Civil Society Organisations, CSOs, yesterday, berated the action of the Federal Government and Police and called on President Bola Tinubu to release them unconditionally.

Meanwhile, the National Human Righte Commission, NHRC, has written the Nigerian Bar Association, NBA, seeking help to secure the release of over 1,000 detained #EndBadGovernance protesters across the country.

The police failed to arraign the protesters on Monday and Tuesday, despite fixing those daysfor arraignment, as the protesters have continued to languish in custody for more than two weeks, without access to their lawyers.

President and Founder, One Love Foundation, OLF, Chief Patrick Eholor, yesterday, reacting to the development, said: "No suspect is to be detained more than 24 hours. It is sad that President Tinubu, who is one of the champions of democracy, who fought along side National Democratic Coalition, NADECO, has been the one that has derailed, bastardised and destroyed the fabrics of democracy.

"If the protesters are not released unconditionally, I and my foundation will write Amnesty International, Human National Rights Commission, and we might protest at the court house or United Nations in Abuja or embassies in Abuja.

These people barely fought for the soul of the nation and their families, and the President is insensitive to them, even the military didn't treat us like this

Tinubu should allow rule of law takes its course -ActionAid

On his part, Country Director, ActionAid Nigeria, AAN, Andrew Mamedu, said: "Failure to arraign protesters is a breach of their fundamental human rights and ActionAid Nigeria frowns at that because justice delayed is justice denied.

'We always advocate due process and rule of law. So for rule of law, what does it take government to arraign them? They don't have enough evidence or what it takes?

Executive Director, CISLAC, Auwal Rafsanjani, said: ''When you are trying to correct something and you are doing something wrong, then you don't have the moral superiority to that.

"The police should tell us why they have kept people in custody as many of them were not even at the protest ground or doing anything criminal but you decided to punish everybody and there is an inherent danger on that.

"Another issue is there is a financial benefit some people having in the name of feeding the protesters because of the financial gain by those who are keeping protesters in custody in terms of feeding contract. Also this delayed arraignment is creating situation for people to revolt.

"What police is doing is that they are demarketing and destroying Tinubu, and making him unpopular, they are not helping him and are making to look like the greatest human rights violator, and we call on Tinubu to send away those who are destroying his reputation and ensure they stop it, if he is not the one instructing them to do that."

Also, Executive Director, African Network for Environmental and Economic Justice, ANEEJ, Rev David Ugolor, said: "This is unacceptable and portrays the government as insensitive to the rule of law.

"I hope the Tinubu government will find a way to address the issues raised in the no to bad governance and corruption.

"The issue of hunger is real and many people are suffering and the only way to draw the attention of government is through peaceful

Protest. "The government should provide opportunity for dialogue and show respect to the people. Keeping people in prison will not solve the problem."

NHRC writes NBA, seeks help to free detained protesters

NHRC in a letter by its Executive Director, Dr. Tony Ojukwu, SAN, to the NBA President, said: "The NHRC writes to exprese deep concern regarding the reported alleged detention of over 1,000 Nigerians following protests against worsening living conditions during the #Endbadgovernance protest.

"As a body committed to protecting the rights and freedoms of all Nigerians, we find it alarming that peaceful demonstrators are being detained and their rights infringed upon. The right to peaceful assembly and expression is guaranteed under our constitution and various international human rights treaties to which Nigeria is a signatory.

Nigerian BarAssociation, NBA, plays in upholding the rule of law and ensuring that justice is not denied to the vulnerable in our society. It is in this context that we seek your urgent intervention to ensure that those detained are granted their legal rights, including access to legal representation, prompt and fair trials, orimmediate release where no lawful grounds exist for their continued detention

"TheNHRCurgestheNBAtotake steps in this matter, including mobilizing legal support to secure the release of those unlawfully detained across the country by visiting all police commands in all the states to attend to people detained. "Collaborating with relevant

authorities to ensure that due process is followed and that any violations of human rights are addressed swiftly."

Bizman refutes involvement in land-grabbing, threat to life, fraud

Lagos-based businessman and Athe Akinrogun of Ibeju Lekki Kingdom, Lagos, Chief Jelili Akande, popularly called Jejelaye, has denied allegations of involvement in landgrabbing, threat to life, kidnapping and fraud.

It will be recalled that on February 22, 2024, a newspeper had reported that Akande was grilled for hours by the Zone 2 Command of the Nigeria Police Force, Onikan, Lagos, over alleged involvement in landgrabbing, threat to life, kidnapping and fraud as brought against him.

The publication had added that Akande was, thereafter, asked to return on another day for more interrogation over his alleged family land, along Lagos-Epe Expressway, Oreki village, in Ibeju-Lekki Local Government Area of the state In refuting the allegations, Akande, who insisted that the allegations were false and far from the truth, said: "In response to the allegations, I want to clarify the circumstances of the land transactions at Oreki village between me, Chief Akande (the Akinrogun of Ibeju-Lekki Kingdom) and Chief Akanni Olufowora. "I am a businessman, whose business revolves around real estate and property consultant, with a well commendable experience and reputation in this regard. "In 2015, a power of attorney was executed in my favour by Chief Akanni Olufowora, now making accusations over the land belonging to the Abereoje Oguntakun-Onibeju family, which I later discovered was under litigation in suit No: 1927/2009 between Lasiru & Ors vs Oladapo Olufowora & Ors before Justice Ipaye sitting at the High Court of Lagos State, Ikeja Division

"Over the years, I acted in good faith, purchasing multiple plots of land from Olufowora and facilitating transactions for my clients based on the trust built over time, which he (Olufowora) collected huge amount of money from me and also from my clients, including vehicles in exchange for plots of land at Oreki



• Gives FG 21-day ultimatum

TMUAHIA—National President of Academic Staff Union of Universities, ASUU, Emmanuel Professor Osodeke, has accused former Minister of Labour and Productive, Dr Chris Ngige, and his collaborators of truncating the over five years of negotiations between ASUU and the Federal Government in 2021.

He regretted that instead of the former minister to get government to sign the document after years of painstaking engagement, it was dumped for reasons best known to him.

The ASUU boss, who made the allegation at a briefing at Michael Okpara University of Agriculture Umudike, MOUAU, Abia State, also gave the Federal Government a 21-day ultimatum to address all outstanding issues raised by ASUU, or the union would be forced to take appropriate actions to achieve their demands.

Flanked at the briefing by ASUU Coordinator, Calabar Zone, Comrade Happiness Uduk, her Owerri zone counterpart, Professor Denis Aribodor; ASUU Chairman, MOUAU branch, Professor Michael Ugwuene; his Nnamdi Azikiwe University, NAU, counterpart, Professor Kingsley Ubaoji, among other chapter chairmen and officials, Osodeke said government was unwilling investing in the education sector.

He identified some of the lingering issues to include review and signing of the renegotiated 2009 FGN-Agreement;

earned academic allowances.

Others are immediate release of withheld salaries, promotion arrears, and thirdparty deductions of members; stoppage of recruitment; illegal proliferation of public universities/abuse laws, universities' regulations, and processes.

He also demanded $immediate \ implementation$ of the presidential directive for the removal of university lecturers from the Integrated Personnel and Payroll Information System, IPPIS, wondering why the directive by the Federal Executive Council, FEC, since December 2023 was yet to be implemented by the accountant-general of the federation.

He said Nigeria was the only country in West Africa where university lecturers were poorly remunerated, adding that it was disgraceful that some of Nigeria's best

brains were migrating to even war-torn Sudan in search of jobs.

The ASUU boss, who regretted the total collapse of the primary and postprimary education system in Nigeria, said but for the struggles by ASUU, the university system would have since collapsed.

Fake certificate: Uganda, Kenya write JAMB, demand students' verification other countries

FOLLOWING cases of fake certification recently detected by the Joint Admissions and Matriculation Board, JAMB, examination board examination boards in Kenya and Uganda have written the federal government to verify records presented by Nigerian candidates seeking admissions into tertiary seeking institutions in their respective countries.

JAMB made this known in document, titled "Registrar's Report on 2023 Admission & 2024 UTME Policy Meeting" obtained yesterday

According to the document, JAMB stressed the need to protect Nigeria's tertiary institutions from international disrepute.

While stating that it would not falsify the records of any students, JAMB said:

"Uganda and Kenya examination boards are now writing to JAMB to confirm records presented by candidates for admission. JAMB would not falsify record.

Recall that the federal government recently suspended the verification of degree certificates from Uganda, Kenya, Benin Republic, Togo and some

over allegations of certificate racketeering.

The government's decision came on the heels of an investigation by Daily Nigeria reporter, Umar Audu, on how he obtained a degree within six weeks in Benin Republic. After his report, the

Federal Government set up an inter-ministerial investigative committee on degree certificate milling to probe the activities of certificate racketeers.

Consequently, JAMB threatened to sanction higher institutions that failed to submit lists of students admitted immediately after matriculation.

He said: "Over 94% of malaria cases (among 233 million people) and 95% of malaria deaths occurred in Africa and children under 5 accounted for about 80% of all malaria deaths in the region.

"The diseases harboured and transmitted by insects (vectorborne diseases) constitute over 60% of deadly and life-threatening diseases of humans

(Service, 1999).

"Aside from death that malaria is responsible for, other complications and socioeconomic retrogressions that include illness, frequent school and work absenteeism, abortion, and stillbirth are also other unfriended diseases to humanity."

On ways to tackle the menace, he urged the government and policymakers to adopt integrated vector control strategies to combat vector-borne diseases rather mon-policy approach to the issue.

KURE — THE governorship Acandidate of the Labour Party, LP, in Ondo State, Dr Ayodele Olorunfemi, yesterday, insisted that he remains the authentic candidate of the party declaring that anybody posing as the party's candidate in the November 16 governorship election is a counterfeit.

Recall that the secretary general of the pan-Yoruba sociopolitical organisation, Afenifere, Chief Sola Ebiseni, had claimed that Olorunfemi was a placeholder and had since stepped down for him.

But speaking in Akure, Olorunfemi said that he was duly elected by party members at its primary held in April 2024.

He said: "I want to tell you that I remain the party's candidate and any other candidate is a counterfeit.

"You can only get to know the party's candidate through the INEC portal and my name is written as the Labour Party candidate.

"Apart from this, we are not aware that he has resigned from PDP or maybe he has done that now we don't know but as of now. we are not aware of his resignation from PDP.

"He was never a member of the Labour Party and he contested under the PDP platform and after contesting on the platform of the PDP is he now claiming to be a member of the Labour Party without documentation or due process." On the claim by Ebiseni that he is a placeholder, Olorunfemi said: "Let him provide evidence

that I am just a placeholder. "Ebiseni called after the

Concerned Igbo clerics accuse S'East govs of abandoning Nnamdi Kanu

TGBO clerics under the aegis of Concerned Igbo Ministers Commission, have accused South East Governors, of abandoning the detained leader of the Indigenous People of Biafra, IPOB, Mazi Ňnamdi Kanu, despite their repeated promises to pursue his release.

The group which expressed disappointment over the failure of the Governors to aggressively pursue Kanu's release, sought to know why the Governors "suddenly chickened out" in their earlier promise to engage President Bola Ahmed Tinubu, to negotiate Kanu's release.

Concerned Igbo Ministers Commission which recalled that the Yoruba united behind Oduduwa independence agitator, Sunday Igboho, when he was arrested in Benin Republic until he regained his freedom, told South East Governors to follow suit.

The group in a statement issued by its International Coordinator, Rev. Tony Uzo Anthony; and Secretary, Apostle Tony Osuji, charged the Governors to place Igbo interests above their individual gains.

ENUGU—No fewer than 27 **E** suspected kidnappers, including members of the Auto Pilot, also known as Unknown Gunmen, a breakaway faction of the proscribed Indigenous People of Biafra (IPOB) loyal to the Finland-based Simon Ekpa, were neutralised yesterday by security forces.

According to a police detective, they were gunned down in shootouts with security operatives at various locations across the state in the past two weeks.

This was as residents of the state appealed to the governor to invoke the provisions of the state's criminal code and demolish all the property used by kidnappers and other criminal elements as stash houses, saying it would serve as a deterrent to criminals.

Road, yesterday, a Police Superintendent, Onochie Ezeh, who led a joint security operation to rescue some kidnap victims, said the operation led to the killing of a sevenman-gang of kidnappers at Ogbeke Nike where the kidnappers used a large poultry farm to hide their hostages.

He explained that yesterday's successful operation was part of the sustained operations in the state to flush out criminals operating from other neighbouring states.

He said: "We have been on the trail of these kidnappers for more than three months now. They had been operating within this axis where they kidnapped their victims and kept them at a large poultry farm at Ogbeke Nike until ransoms were paid.



In this interview with Vanguard's Law and Human Rights, a rights activist and member of the inner bar, Mr. Adekunle Adegoke, SAN, spoke on topical issues in the country, including a recent court order obtained by a Chinese firm in Paris to confiscate three of Nigeria's presidential jets, the twin policy of Tinubu administration on fuel subsidy and forex exchange, overcrowded prisons nationwide with over 57,000 awaiting-trial-inmates and how the newly appointed Chief Justice of Nigeria, CJN, restore can publicconfidence in the judiciary. Excerpt:

Chinese firm, Zhongshan Fucheng Industrial Investment Company Limited, recently obtained an order in Paris to confiscate three of Nigeria's presidential jets over termination of contractual agreement between it and Ogun State. What is your take on this?

In the law of contract, there is what is called 'the sanctity of contract' and once an agreement is entered into, it must be carried out by the parties. In the Latin term, we say pacta sunt servanda. The agreement was between Ogun State Government and the Chinese entity based on a bilateral investment treaty between Nigeria and China. Nigeria's argument was said to be based on the theory of sovereign immunity by which a foreign government cannot be made subject to the jurisdiction of another foreign court or arbitral panel. This argument was rejected while the judgment and a subsequent appeal went against Nigeria.

I believe that we need to be careful about agreements we enter into with foreign investors. It is important that sub-national entities in Nigeria need to review all the foreign investment agreements they have entered into so that Nigeria is not made a laughing stock in the comity of nations. When agreements are breached, tendency is that Nigeria will be made liable as most jurisdictions all over the world have adopted the of restrictive doctrine immunity by which foreign

sovereigns entering into commercial transactions are now liable under such contracts and the defence of absolute sovereign immunity does not avail anymore when it comes to commercial transactions.

The twin policy of Tinubu administration on fuel subsidy and forex exchange remain controversial. What is your advice for the government and the people? The government needs to review its policies urgently. These two policies of subsidy removal and floating of the naira have impacted negatively on the common man and the tendency is for the people to be complaining. While the government may argue that we have made a lot of financial gains since the introduction of the two policies, it is high time the government reinvested the moneys made to create jobs and achieve food security. It is important that the value of naira must be improved otherwise, the nation will continue to bleed. There is nowhere the IMF policies have been adopted without the people suffering. Genuine and respected experts in economics like Professor Jeffrey Sachs who have served as consultants to the World Bank in the past have consistently warned that these policies cannot benefit any third world nation as they are designed to inflict pain on the people. They are designed to make the government unpopular so that the third world nations can be subjugated and controlled. No matter how well-intentioned the government might be when it introduced the policies, the effect are not making the common man to laugh. I implore the government to review these policies urgently.

trial. Does this worry you? And what is the way out? It is definitely worrisome to have a staggering number of this nature in our correctional centres awaiting trial. It is a subversion of justice for people to await trial for years while their innocence is still protected by the Constitution. Attorneys-General of the various states have a lot to do in this regard. The Directors of Public Prosecution of the various states have a lot to do in this regard. Many of such awaiting-trial inmates are in prison as a result of DPP's advice that has not come out to determine whether there is a prima facie case for them to answer. Every Attorney-General must ensure that no file lasts more than a week with his DPP when it comes to rendering DPP's advice. This will enable the system to know if there is any basis for prosecution or not.

What can you say about her, her suitability for the joband your expectations from her in the next four years?

Justice Kudirat Kekere-Ekun is one of the finest legal minds that Nigeria has ever produced. His Lordship has a great pedigree, having risen through the ranks from being a Magistrate to becoming a High Court Judge in Lagos State, to the Court of Appeal and finally, to the Supreme Court.

Justice Kekere-Ekun is one of those Justices you can say is not corrupt and has worn her gown with impeccable gait. In terms of capacity, His Lordship is an embodiment of brilliance and discipline. Judgments of His Lordship have stood the test of correctness and wit, that in many cases, they are difficult to fault. Such a judicial officer deserves to head the highest institution like the Supreme Court of Nigeria and the judicial sector in its entirety. I believe His Lordship's tenure is going to be a blessing to both the judiciary and the entire nation. In terms of expectation, there is a lot of work to be done. the Nigerian judiciary has a low rating before an average man on the street as a result of the bad character of a few judges who have tarnished the image of the judiciary. The new CJN must be firm in discipline as His Lordship heads the National Judicial Council whose job is to discipline erring judges. His Lordship must ensure that the Council applies strict disciplinary sanctions including prosecution of erring judges where their transgressions amount to criminal acts. This is aside from removal from office.

When it comes to appointment of judges, His Lordship needs to ensure that merit and integrity become the watchword at all times. A lot of criticisms have been levied judicial against some appointments in the past and we need to critically look at this. In many cases, persons of low integrity have been appointed onto the bench or elevated to higher courts. These individuals were not sufficiently filtered by subjecting their appointments to review by the general members of the public as it is done when lawyers are being elevated to the rank of Senior Advocate of Nigeria. It is these unfit elements that have consistently tarnished the image of the judiciary as they carry on their business without respect for the law or the ethics of the profession. Members of the public who have related with these individuals must be afforded the opportunity to comment on their suitability before they are appointed as judges. A corrupt individual who is not given the licence to operate as a judge will definitely abuse the office to gain personal profit. This is a violation of judicial ethics.

where an incompetent person or a mediocre is appointed to as a compensation for past favours or benefit of parental relationships. While we have many judges who are competent, brilliant and honest, we have many who have been conferred the status of judgeship whose competence is highly questionable.

The new CJN will need to up the ante in this regard so that members of the public can vest their trust in the judiciary as the last hope of the common man.

It is expected that with the increase in judicial officers' remuneration by 300 per cent, our judges will be better economically and the tendency to be tempted by filthy lucre will reduce. This is a legitimate expectation in any reasonable society and our judges must live up to this. The new CJN has a lot to do to ensure that bad eggs within the judiciary are removed as they are the ones destroying the good works of the majority.

In addition to the above is the need to ensure that judgments of courts are enforced. It has become the trade-in-stock of many governmental institutions to refuse to obey court order.

FG increases int'l passport fees

BUJA—THE Federal Government, yesterday, announced a hike in the cost of obtaining Nigeria's international passport. Spokesman of the Nigeria Immigration Service NIS, DCI Kenneth Udo, in a statement, said the move is "part of efforts to maintain the quality and integrity of the Nigerian Standard Passport."

According to him, the new charges take effect from 1st September, 2024.

The statement reads: "Based on the review, 32-page Passport booklet with 5 year validity, previously charged at N35,000, will now be N50,000 only; while 64-page Passport booklet, with 10 year validity, N70,000, will be N100,000 only.

"However, the fees remain unchanged in Diaspora. While the Nigeria Immigration Service regrets any inconvenience this increase might cause prospective applicants; it assures Nigerians of unwavering commitment to transparency and quality service delivery at all times."

He allegedly started letting the premises to other tenants giving them the impression that it was his personal property and making more than three times more than his rental obligations to the actual owner.

The owner was said to have got judgment against him to the tune of almost N100 Million and commenced contempt proceedings against him at the Edo State High Court sitting in Benin City and he allegedly called the bluff of the court.

In the Suit B/184/2009, Uwaibi sued for contempt and in his ruling, Justice M. N. Asemota held that "I have considered the application for bench warrant to be issued against Mr Charles Amadasun, the Judgment Debtor sought to be committed to prison

sought to be committed to pnson for contempt who has been personally served the required Forms 48 and 49 as well as the motion for committed and has refused to attend court.

"I have also read the affidavit in support in support of the application brought experte. I find merit in the application and it is granted as prayer.


"A bench warrant is hereby issued for the arrest of Mr Charles Amadasun to compel him to physically attend the court in respect of contempt proceeding against him.

liko Dangote, the richest man In Africa, is a product of the Nigerian state. By deliberate policy choices, the state made Dangote Nigeria's foremost oligarch with presidents on speed dial. However, recent rifts between Dangote's oil refinery and the Nigerian National Petroleum Company, NNPC, as well as the Nigerian Midstream and Downstream Petroleum Regulatory Authority, NMDPRA, not to mention the raid on his business headquarters by the Economic and Financial Crimes Commission, EFCC, suggest that all is not well with the long-running relationship between Dangote and the state. Yet, having turned Dangote into a commercial Leviathan, the state must now wisely recalibrate and manage the relationship.

To be clear, Dangote was not born poor. He was born into wealth and became a millionaire very early in life. However, his transition from a millionaire to Africa's richest man would not have happened without a leg-up from the state, without special favours and preferential treatment from the Nigerian state. To this credit, Dangote himself admits this. Before we come to the refinery saga, let's tell the fascinating story, as Dangote himself narrated it.

In 2018, Dangote granted an interview with the *Financial Times* in which he laid bare how he hit the jackpot and got his break. Dangote had part-funded General Olusegun Obasanjo's campaign for the

presidency in 1999. And when Obasanjo became president, he decided to return the favour. One day, Obasanjo called Dangote and said: "Can we meet today?" Dangote went to meet Obasanjo who asked him how Nigeria could become selfsufficient in cement production. Well, Dangote told him that only if imports of cement were banned would it be worthwhile to produce it

Government should privatise the stateowned refineries, which would foster competition in the domestic market for refined petroleum; it's irrational to tie the supply of refined petroleum products to one privately-owned refinery

in Nigeria. Pronto, with a presidential diktat and the simple squiggle of his pen, Obasanjo banned the importation of cement and handed a monopoly license to one man. As the FT put it, Dangote "has never looked back", and cement became the crown jewel of his empire. Of course, it was an utterly misguided

Nigeria made Dangote a colossus, it must now handle him wisely

and shortsighted decision, a point later acknowledged by the Jonathan administration in the Nigeria Industrial Revolution Plan, NIRP, published in 2014. The NIRP said that "the Nigerian cement industry is heavily concentrated," adding that "strong regulation is needed to ensure the industry adequately promotes competition." The NIRP went on to say that "Nigerian cement prices are among the highest globally" despite the products being of "low finished standards". It was

a damning indictment of Obasanjo's politically motivated decision. Here's a country with an estimated housing shortage of 20m units, the main cause being the high costs of building materials, particularly cement.

Throughout history, cement has improved people's health and wellbeing. In many countries, paving dirt floors with cement and replacing dirt tracks with paved roads reduced parasitic infections and boosted living standards. What about shelter, one of humanity's primary needs? Few things matter more than having a decent roof over one's head. The new Labour government in the UK promised to build 1.5million homes, and Kamala Harris, the US Democratic presidential candidate, promised to build three million homes, if elected. That's because housing can grow an economy and improve people's

lives. But at its heart is cement! In his fascinating new book titled, *Material World: A Substantial Story* of our Past and Future, the economist Ed Conway said: "The reason cement has changed the world is not merely because it has magical qualities but because it is cheap, and it is everywhere." Sadly, that's not so in Nigeria. There is hardly anyone on a middle-income in Nigeria today who can build a house. Nigeria is not a property-owning democracy; it is not a propertyowning economy. Despite the promise in the NIRP to regulate and make the cement industry competitive, it is still dominated by a cartel, by politically connected oligopolists, shielded by import bans.

Which brings us to the Dangote Refinery. The \$20bn refinery was hailed as a "game changer", a private initiative that will meet Nigeria's refined petroleum needs, producing 650,000 barrels of refined fuel a day. But the refinery's entire business model is built around special favours by the state. For instance, it was largely funded with concessionary loans from the CBN, while NNPC made a downpayment of \$2.7bn for a 20 per cent stake in the refinery, although it later whittled it down to 7.2 per cent. More importantly, the refinery depends on NNPC selling it crude on preferential terms and won't survive unless the government stops importing refined products, thereby giving it a monopoly in the market. Elsewhere, citizens would ask why a government that cannot revive four moribund state-owned refineries, despite spending billions of dollars so-called turnaround on maintenance, and that refuses to privatise the refineries, would put its political and financial weights behind one privately-owned refinery. Rationally, the government should privatise the state-owned refineries, which would foster competition in the domestic market for refined petroleum. It's irrational to tie the supply of refined petroleum products in Nigeria to one privatelyowned refinery. It's utterly absurd.

Think about it: Farouk Ahmed, chief executive of NMDPRA, said that Dangote's refined products are "inferior" to imported ones. He also said that Dangote wanted the government to stop importing refined products to give his refinery a monopolistic advantage. These claims by the oil sector's statutory regulator should be investigated. Instead, there's a cacophony of criticisms by those who want to politicise the issue, while Tinubu's administration undermines the NNPC and the NMDPRA by ordering them to bend over backwards for the Dangote Refinery and give it a lifeline.

Let me be clear, this is not an anti-Dangote intervention. Far from it. Rather, it's a piece in support of a free and competitive market, where there are many buyers and sellers and no barriers to entry or exit. But Dangote's instincts are protectionist. In the *FT* interview, he said the government should introduce "draconian policy" to ban food imports "just like they did with cement". But that's bad for the Nigerian economy, and bad for the Nigerian consumer.

Adam Smith said in The Wealth of Nations: "Consumption is the sole end and purpose of all production; and the interest of the producer ought to be attended to only so far as it may be necessary for promoting that of the consumer." Put simply, if cement is of low quality and expensive, if refined petroleum is of low quality and expensive, the state must not elevate the interests of producers above those of consumers and the wider economy. That's why Nigeria must banish all forms of protectionism, monopoly and oligopoly. They are enemies of society!

fter the fiasco of Nigeria's Aparticipation in the 2024 Olympic games, most Nigerians have read a statement issued by Minister of Sports the Development, John Owan Enoh. In that statement, the Minister first tendered an apology for his team's ability to return to Nigeria with any medal and thereafter listed a number of complaints about sports administration in Nigeria. The synopsis of his complaints was that one year to the Olympics, Nigeria was not prepared to take part in the games, and this was basically because international sports bodies forbid government oversight functions in sports administration.

Many Nigerians who are deeply insulted by the whining and wringing of hands and buckpassing by the Minister have been calling for his outright sack. At some point, some have said that as one who had failed to deliver on an assignment given to him by over 200 million Nigerians, the honourable thing that the minister should do before tendering his apology would have been to resign that position. We were of this position and this is why: First, if the minister had less than one year to prepare for a competition that other nations were spending four years to execute, and together with humongous resources, why didn't he say so before the games? Second, knowing that Nigeria was not physically, mentally and psychologically prepared to participate in the games, he raised a budget of N12 billion

with which he executed what has now turned out to be the greatest fiasco in sports administration in Nigeria. Why would someone who knows that his country is unprepared for a global competition raise a budget of N12 billion to go compete against other nations that have prepared for four years or more for that same competition? Why raise our hopes that we would replicate the Atlanta 1996 kind of results that Nigeria became famous for, knowing full well that we were nowhere near that kind of level? In the light of strong economic and social problems, hardship and pervasive hunger in the land for which Nigerians were on the streets for ten days, and some killed, why would anyone be spending a whopping sum of N12 billion on a global

The question supporters of the minister have asked is this: Knowing the level of unpreparedness of Nigeria arising from the way the sports system is said to work, what could the minister have done differently to spare Nigerians already traumatized by hunger

In the light of the above, let us quietly go back to our drawing board and rethink matters; for this same scenario had taken place before. In 2009, during the presidency of Umaru Yar'Adua, Mr Rotimi Amaechi, then governor of Rivers State, headed the presidential task force on the Super Eagles. After a thorough investigation of the issues bedeviling the state of sports unpreparedness in Nigeria, the Amaechi committee found out that Nigeria was unprepared for the competition. Amaechi, therefore, recommended that government should place a hold on all of Nigeria's international football engagements. We will not be talking about the hullabaloo and balderdash that that suggestion elicited. We will not be talking about it because it was ordinarily an ego trip for Nigeria, that a football

If you read the so-called apology from the Minister, you would find out that there are real, very real, issues with sports administration in Nigeria. One of them is that the buck does not stop at the Minister's table. Like a lame duck, he does not have the power to sack any member of the sports federations. The rules in global sports are such that not even the president of Nigeria can sack any member of the Sports Federation except in compliance with FIFA rules I have been told.

In the light of the above, I strongly recommend Nigeria adopt the position of the Rotimi Amaechi presidential committee of 2019. Let us quietly go back to our drawing board and rethink matters. For the Sports Minister to now be pointing fingers at the system AFTER the fiasco ordinarily indicates a level of weakness unbecoming of someone with such high and excellent credentials. I believe that instead of sacking a man who met a system for which he has no control, let Mr Tinubu withdraw Nigeria from ALL international competitions so as to put our house in order first before we ever venture out again to be made a laughingstock in the comity of nations.

protests this huge shame and embarrassment? Part of my response was a recollection that competition of a certain magnitude would be taking place on African soil, and Nigeria, the supposed giant of Africa, was not going to be part of it.

I thought that the Minister of Sports Development, an accomplished farmer and philanthropist, would be toeing that same path as Amaechi. But he didn't. Instead, he drew up a N12 billion budget to take care of a team that began to be ready to compete only one year before the Olympics. He whipped up strong sentiment that Nigeria was going to replicate the Atlanta 1996 scenario where the country stunned the world in spite of our characteristic

Joe Ajaero: NLC presidency under Tinubu's watch

FIVE days after Comrade Joe Ajaero, former General Secretary of the Nigerian Union of Electricity Employees, NUEE, and Deputy National President of the Nigeria Labour Congress, NLC, made history as the first NLC President to be elected unopposed at the 13th National Delegates Conference in Abuja, on February 8, 2023, I sat down with him in Lagos for an exclusive interview.

Still basking in the euphoria of his victory, he was hopeful and bullish as he discussed the labour movement, what Nigerians should expect of his presidency and the impending 2023 elections. He was analytical and measured.

Declaring that the NLC under his watch will live up to expectations, Ajaero quipped: "I am assuring longsuffering Nigerian workers that I will be their voice. We will cry their cry. We will carry their burden. We will identify with them. If there is any way we have lost touch with the people, we are reconnecting with them. We expect that they will reciprocate. It is not always that we will be on the streets but if there is need for that, we will be on the streets and we are ready to pay the price, no matter how high, to make sure that Nigeria gets better."

On the impending elections, Ajaero sounded a note of warning: "NLC will work with whoever emerges President in a free and fair poll in the interest of Nigerian workers. But the NLC, under our watch, will not keep quiet in the face of any electoral malpractice. We will not keep quiet in the face of people winning elections and they are not declared winners. We will not keep quiet while rigging becomes the order of the day. The NLC will show more than a passing interest. We want to know how the elections are conducted, how things are done and we want to ensure that things are done well."

Despite the assurances, I knew that the tenor of Ajaero's presidency will be significantly impacted by the outcome of presidential election, convinced that any of the four frontline candidates – Bola Tinubu (APC), Atiku Abubakar (PDP), Peter Obi (LP) and Musa Kwankwaso (NNPP) – who wins the election will naturally show more than a passing interest in the affairs of organised labour. But I was convinced that none of them, except Tinubu, will attempt an outright hostile takeover of the labour movement.

Under the watch of Obi, Atiku and even Kwakwanso, NLC will have its usual run-ins with the government which will typically flex muscles but ultimately sit down with the labour leadership for discussions but a Tinubu presidency will be a totally different ball game. Tinubu is one politician with fascist reflexes and takes no prisoners.

The issue of petrol subsidy has always been a volatile matter that galvanises organised labour into action. So, ordinarily, when Tinubu in his inaugural speech thundered that "subsidy is gone," and the Nigerian National Petroleum Company Limited, NNPCL, subsequently jacked up the pump price of petrol, Nigerian workers would have poured out onto the streets.

out onto the streets. Of course, the NLC leadership threatened strike. But the government swiftly swung into action, maximally deploying the devious instrument of ethnic baiting. Joe Ajaero, they lied, is an Obi and possibly Independent People of Biafra, IPOB, sympathiser who wants to call out Nigerian workers in his attempt to subvert the fledgling administration of Tinubu, a Yoruba. Suddenly, a proposed NLC action became an Igbo agenda. It worked. Even before the strike started, almost all the South-West state chapters pulled out. Ajaero, sensing a breakup of the NLC under his watch beat a tactical retreat. The proposed industrial action was called off.

At about 3.30 pm when worried colleagues finally made contacts with him, Ajaero had been severely brutalised and thoroughly humiliated. He was partially blinded and could hardly stand on his feet. The savagery was unconscionable. No other NLC president had been subjected to such demeaning ordeal, not even under military regimes. Till date, the police are yet to make

any arrests, not to talk of bringing the pernicious characters who carried out the assault to book.

Then, on Monday, August 19, the Nigeria Police Force bared its fangs accusing Ajaero of committing heinous crimes that include terrorism financing, treasonable felony, subversion and cybercrime. In a letter signed by Adamu Muazu, Assistant Commissioner of Police, Ajaero was ordered to appear before the Intelligence Response Team for interrogation on Tuesday, August 20, at 10 am even as they threatened to activate a warrant of arrest if he fails to honour the invitation. These are crimes that attract severe punishment on conviction. The least, cybercrime, attracts punishment ranging from three to seven years imprisonment or fine options ranging from N5 million to N10 million; subversion attracts a fine of N5 million or seven years imprisonment; while as terrorism financing is a crime, punishable on conviction, with imprisonment for a term of not less than 20 years. Treason is punishable by death and treasonable felonies are punishable by imprisonment for life. I doubt if there is any Nigerian that genuinely

Minister of Education, Mamman Tahir, while monitoring the Unified Tertiary Matriculation Examination, UTME, last April in Abuja, announced that 18 years would henceforth be the minimum age for the admission of students into tertiary institutions in Nigeria. Most students who sat for the university enrolment examinations were between 16 and 17.

He blamed parents for "pressuring" their children and wards into embracing educational pursuits which they are too young to understand. He also defended his position, arguing that it is in line with our 6-3-3-4 educational policy.

On the face of it, the Minister is right. Eighteen years is the age of maturity or adulthood under our Constitution, and the university environment and academic content are tailor-made for matured minds. Under ideal circumstances, toddlers should be given adequate opportunities to develop sys-

tematically from the home up to the age of five or above before being sent to school. In the past, children were allowed to spend their formative years under parental and communal guidance for proper grounding before being exposed to Western education.

Even after their School Certificates in their late teens and twenties, they were required to attend Lower and Upper Six to obtain their "A" Level Certificates which qualified them for entry into the universities.


The Joint Admission and Matriculation Board, JAMB, was later introduced to afford secondary school leavers the opportunity to earn direct entry into the tertiary levels. Today, the university preparatory certificate ("A" Level) is no longer fashionable or even available.

The structure and culture of education have changed in line with contemporary circumstances. The failure of the public educational system due to the neglect of teachers' welfare and their training programmes has encouraged the upsurge of private investment in schools. Because of the profit motive of private educators, "schooling" has become available even to the suckling.

From very early infancy, children are sent to day care, creche and kindergarten before they commence primary schooling. Many working parents find this arrangement convenient, otherwise they would be forced to choose between work and staying at home to raise their infants. This is the main reason we have very young teenagers registering for the UTME.

Besides, many young parents see it as an advantage to quickly complete the education of their children before old age catches up with them. Asking children who are mentally qualified to sit for their UTME to wait till they are 18 sounds awkward, disruptive and out of tune with current realities. Can the Minister of Education enforce this "directive" without also "legislating" on the minimum age for primary school enrolment? What will teenagers who have obtained their School Certificates at 15 or 16 be doing before they are old enough to sit for the UTME?

The National Council on Education, NCE, should sit over this matter and advise the Minister accordingly.



Making a case for *Tradocracy*

THE Tradocracy Bill 2024 (Tradocratic Sys tem of Government) which I wrote was recently submitted to the National Assembly for consideration. The purpose of the bill is for this system of government to be operated in Nigeria alongside democracy.

in Nigeria alongside democracy. Tradocracy shall operate and be structured into three arms of government, namely: Executive, Researchure and Legislature. There shall be a Sovereign Electoral Commission and Department of Morality. The Researchure arm makes *Tradocracy* different from democracy and other forms of government.

The Researchure shall be the assembly of representatives of professions available in the country and shall be next in power to the Executive arm. Its primary function shall be the harmonisation and improvement of professions and research development in the areas of training and speciality.

There shall be House of Researchure and head of House of Researchure referred to as Oniha. Oniha and Deputy Oniha shall be elected by members. There shall be four Researchurers (representatives) from each state of the federation, representing different professions at national level, state and local government. The Researchurer shall be elected through political process. Federal researchurers shall be sent to federal agencies for research, evaluation and monitoring of work process in establishments according to his or her training. State and local government researchurers shall follow the same pattern. Researchurers shall spend three weeks in his or her place of primary assignment for research development of products and ideas, and one week in the House of Researchure for deliberation and re-evaluation of work pattern and work process and research methods of the establishment he or she is sent to, including approval of product or idea obtained

through research.

There shall be the Executive arm of government comprising of ministries. The President and Commander-in-Chief of the Armed Forces shall be the head of the Executive arm, head of government and head of state of Nigeria. There shall be no Vice President.

Tradocracy shall operate and be structured into three arms of government, namely: Executive, Researchure and Legislature; there shall be a Sovereign Electoral Commission and Department of Morality; the ReThere shall be Supreme Court, Appeal Court, High Court, Tribunal, Industrial Court, Customary Court, Sharia Court and Home Cell Court (family unit court).

The family unit court shall be under the Local Government Council. All courts shall be under the supervision of the Chief Justice of the Federation who shall appoint judges. The state courts and local government courts shall be autonomous from federal court control.

The Chief Justice of the Federation shall become the Interim President in the event of death or incapacitation of the President for six months. The Interim President shall hand over power to the Oniha of federal House of Researchure as President and Commanderin-Chief of the Arm Forces for the remaining term of the former President.

The courts and their staff members, including the legal professionals, shall be under the con-Chief Justice of the There shall be direct budgetary allocation from the presidency to judicial departments of the Ministry of Justice. The Chief Justice is not answerable to Attorney-General and the Parliament. The Chief Justice of the Federation, as the head of the judicial department or Ministry of Justice, shall swear-in the elected President and the elected Onogie and national leader. There shall be region and zone which shall be semi-autonomous from the Federal Government and shall be headed by the governor. WHEREAS the Department of Morality shall promote the constitution through the media, seminars, workshops etc. The department shall promote moral pathways for the people and the government. The evaluation of performance rating of presidents, commander-in-chief of armed forces, governors-general, governors and chairmen of local government councils shall be carried out by the Department of Morality every five years for the purpose of continuation or discontinuation in office.

The head of the Department of Morality shall be addressed as governors of the Department of Morality, and he or she shall sign all electoral bills into law. The Oniha shall appoint governor of the Department of Morality. The civil service commission shall be referred to as civil worker's commission.

The ministry of creative ability and special talent shall be constituted and mandated to organise seminars for people with creative ability for them to be awarded certificates and special awards, including fellowship awards. The certificates shall be regarded as innovation degrees; Masters of Creative Ability "McA" and Doctor of Knowledge, "KnD". The Special award shall be Guru.

The McA shall be equivalent to university master's degree, while the KnD shall be equivalent to university Doctor of Philosophy, PhD. The Guru shall be equivalent to university professor. Innovation degree certificates and awards shall be accepted as requirements for job and political position. Academic degree and academic certificate shall also be requirement for job and political position. In summary, there shall be three arms of government: The Researchure, Executive and Legislative. There shall be a Sovereign Electoral Commission, Department of Morality, Civil Workers' Commission, Ministry of Creative Ability and Special Talent, Regions and Zones, States and Local Government Councils. The full details of the Tradocracy Bill 2024 shall be published in due course.

There shall be federal Onogie, or national leader, the second in command next to the president.

The parliament shall make laws for the country, and there shall be an upper house of the legislature referred to as House of Peace or Senate, and a lower house of legislature referred to as House of Progress. If the House of Peace is in operation (existence), there shall be no Senate; if the Senate is in operation, there shall be no House of Peace.

The President shall appoint the Chief Justice of the Federation based on the recommendation of the Judicial Council ratified by the upper arm of the legislature.

Petrol scarcity worsens as independent marketers load at N780/litre

HE prolonged petrol scarcity worsened in Lagos, Ogun and other states, yesterday, as independent marketers started lifting the product from private depots at N780 per litre, from N595 per litre, indicating an increase of 31 per cent.

The marketers believe the hike in price reflects the current demand and supply of the product in the domestic market.

Public Relations Officer of IPMAN, Chief Chinedu Ukadike, who confirmed this in an interview with Vanguard, also expressed optimism that the bad situation could improve in the coming days.

Chief Ukadike noted that more trucks have left the depots in the past few days, adding that though independent marketers are still sourcing the product at a higher rate, more marketers are able to

led to long queues at filling stations across the country with several marketers jerking up their pump prices. Checks around Abuja yesterday showed that while queues have eased slightly at the stations around the central area, the supply situation remains tense in other parts of the Federal Capital Territory.

Pump prices also remained high, ranging from N685/litre at outlets operated by major marketers to N950/litre at stations managed by independent marketers.

He said: "So we sell as we can buy and put up markups and margins to be able to make little profit. The transportation cost is a lot higher now. The product we normally bring in at N800,000 now costs N3.5 million because of the high cost of diesel and maintenance cost of the trucks.

He disclosed that IPMAN is still waiting to meet with the management of the Dangote Refinery ahead of the expected release of petrol from the refinery, stressing that independent marketers are determined to remove middlemen from their dealings with the refin-"We are still anticipating that Dangote will invite us as of the major one stakeholders in the downstream of the oil and gas distribution chain. We will be one of their major off-takers. We are serious about the issue of third parties and that this is what IPMAN is trying to erase. Third parties' involvement increases cost of

the product and we doni $\bar{}t$ want that to happen," he added.

Scarcity worsens in Lagos, Ogun, others

Checks indicated that the situation in Lagos, Ogun and other states that had recorded improvement in the past few days, yesterday, worsened as long fuel queues reappeared in many parts of the states.

There were several long queues at some filling stations, especially the outlets belonging to the NNPC and major oil marketers, which

Transporters lament, jerk up fares by over 200%

Further checks indicated that there was a significant increase in transport fares and motorists passed the cost of the high price to commuters in Lagos, Ogun and other states.

It now costs about N6,000 to travel from Ikorodu to Victoria Island, Lagos, a trip that used to cost less than N2,000 before the shortage. Mr. Emmanuel Okonkwo, a Sienna bus driver who plies Lagos to Owerri said: "Naturally, the fuel scarcity is affecting our business negatively. Nowadays, there is no fixed fare for trips again, you fix what you like and the way it suits you to enable you remain in business. The worst aspect of it is that people are no longer traveling like before, hardly could one get full load in Toyota Sienna bus. If you are lucky to get full load, you should thank your star.

"In most cases you get four to five passengers and after expenses that you are left with nothing to go home with. We are not finding it easy at all, because it takes a long time to get full load, departure and arrival time also have been affected. Drivers get to their destinations late as a result of queuing for fuel on the roađ. "In most cases they have to sleep in any town before proceeding the next day due to fear of insecurity. In fact things are no longer the same.'

cause they queue all day to get fuel and at the end not having passengers on ground like before. He said that outside Lagos, fuel is sold at between N900 to N1,000, and this affects our profit.

He said: "We are working for nothing under the present fuel scarcity situation. The dilemma is that we can't increase fares because passengers cannot afford the high fare.

"The danger is that, we will be out of business if the fuel price continues the way it is. The vehicle maintenance is getting higher by the day and the option is to stop putting the vehicles on the road.

"Presently drivers spend a full day to search for fuel which they purchase at very high price. Our business is heading towards extinction. We are not even talking about extortion by local government officials and law enforcement agents on the road that collect toll fares from the transporters. It is very tough for us. Government should hear our cry and stream and Downstream Petroleum Regulatory Authority, NMDPRĂ, were not physically present at filling stations to monitor activities, thus culminating in irregularities, including pump manipulation.

Dapo Segun, attributed the shortage to rains, lightning and thunderstorms.

Speaking during a press conference at the NNPC Tow-ers, he said: "We apologise to Nigerians for the fuel queues. Many of the challenges we're facing are outside our control, but we're doing our best to address them.

"The recent rains have made the Escravos channel difficult to navigate due to siltation, which has significantly hindered our ability to transport petroleum products, espe-cially PMS, across the country.

He said lightning and thun-derstorms culminated in suspension of fuel discharges, adding that the situation is worsened by the poor states of roads in the country

However, President of the Petroleum and Natural Gas Senior Staff Association of Nigeria, PENGASSAN, Engr. Festus Osifo, who is also President of the Trade Union Congress TUC, attributed Nigeria's current economic hardship to government policies like floating of the currency. Engr. He said: "A country that cannot meet its energy needs or guarantee energy availability for its citizens is on the path of becoming a failed state.

"As an association, we have mounted the rostrum over time, both on the streets and in the boardroom, to champion this cause, and we will not relent until victory is certain.

"As we gather here, let us not lose sight of the broader state of our nation. Nigeria stands at the crossroads, and our actions and decisions here in the next few days will provide a framework for a policy thrust for government towards shaping the economic outlook of our country.

"It is incumbent upon us to drive positive change, foster economic growth, and ensure our people's prosperity. Re-cent policy directions by the government have placed untold hardship on Nigerians. Chief among them is flotation cum devaluation of the Naira, which saw our currency sliding from 450 Naira officially in May 2023 to the current exchange rate of about 1,600 Naira. "This is the reason why the landing price of PMS today is over 1,000 Naira (reintroduction of subsidy), the reason why AGO is selling for over 1,300 Naira, and the reason why all imported commodities are over the roof today. The over-arching impact of this on Nigerians can only be imagined rather than experienced."



According to him, "NNPC has started releasing products to independent marketers. The queues you are seeing now are ghost queues. They appear in the morning but disappear in the afternoon or evening. It will continue like that until supply stabilizes in the coming days and becomes sufficient enough.

"You must also remember that we are in the rainy season and it takes some time for trucks to come up north. In a few days, I believe the situation will ease."




The acts and actions of Olorogun Felix Edore Kupa and the other two former presidents are said to be inimical to the constitution and code of conduct of the organization.



"We have learnt that even the need to do it in a hurry."

Speaking further, the minister said: "President Bola Tinubu has been very reluctant to reflect on the past and blame anybody, but the net effect is that despite efforts by previous administrations, especially in the last 25 years, we are not where we want to be.

"So, what do we do? It's not because of anyone's failing, but that is our reality. We have yet to achieve the income per capita that we require, and it's not for lack of trying; it's not for lack of successes. With the transformation in the telecommunication sector, at some point, we even reversed our gross domestic product, GDP.

Our population has grown

about 230 million, almost double. Still, our oil production, for example, 2.2 million barrels in 1999, is now rather than 4 million, according to the doubling of our population, which is still under 1.5 million, reflecting cumulative years of underinvestment in the sector.

"So, our reality is that we are not where we want to be, and our constitution needs to be more transparent about what we should do. Chapter 2 of our Constitution, the Fundamental Objectives and Directive Principles of State Policy, clearly discusses the country's political objectives. It is also very clear

about the economic objectives-what kind of economy we want to run.

"Chapter two of the Constitution spells out citizens' duties. The chapter opens by saying that all persons in authority, legislative, executive, and judicial, at all levels of government, have the primary mandate to ensure the achievement of those fundamental objectives in Chapter 2.

"So, the constitution-maybe we can interrogate it and make it better-provides a starting point. Agenda 2050 reflects those objectives. We want a nation that includes all. We want a higher per capita by

the year 2050. We want to ensure that we invest not less than \$100 billion annually.

"But if our experience in the last 25 years should serve us as a quide, we sometimes know how difficult it is because you have to make choices that are both pleasant and unpleasant to be able to mobilise capital, private and borrowed, to support our aspiration.

"If we are to provide for what we can pay, this is what it costs. And it's in terms of money way above what was available to us. So, I know this is an opening remark. We are not where we want to be. That's why after 25 vears of constitutional democracy, we are a federal democracy, which requires minimum cooperation among all the tiers of government.

'Some achievements in the last 25 years reflect the ability or the post-cooperation sometimes among the tiers of government.

"But we are not lamenting. We are willing to take the bull by the horns. We have a president today who, as God will have it, has actively participated in the last 25 years that are under review. Among his achievements was that he ran a state with the largest economy in the country.

TELECOM operators in L Nigeria, telcos yesterday heaved a sigh of relief as the federal government finally designates telecom infrastructure as Critical National Infrastructure, CNI.

Minister of Communications, Innovation and Digital Economy, Dr Bosun Tijani, dropped the hint in a thank-you message to President Bola Ahmed Tinubu for releasing the official gazette: "Designation and Protection of Critical National Information Infrastructure Order, 2024"

What this means is that it is now an offence to willfully damage telco facilities such as towers and base stations, switch stations, transmission equipment, submarine and fibre optic cables, data centres, satellite infrastructure, e-government platforms and databases, among others. These facilities are part of Critical National Infrastructure (CNI) because of the important role they play, in ensur-

will help reduce issues such as dropped calls, poor internet service, and generally improve quality of telecom services in the country. The minister also believed that the new development will add to the protection of investments in the ICT sector as it will strengthen the operational capabilities of the telcos' infrastructure and networks.

He said: "The security and protection of these Critical National Information Infrastructure (CNII) is a priority for this administration and will help improve the quality of telecoms services, which has very often been affected by disruption and intentional damage"

Expressing happiness with the new development, Chairman of the Association of Licensed Telecom Operators of Nigeria, ALTON Engr Gbenga Adebayo, said: "On behalf of all our members (the telcos), we express gratitude to Mr President for

but we are happy, and the industry will be good with it. This will reduce incidencies of arbitrary and forceful access to our facilities by unauthorized government personnel, vandals and overzealous drivers of Internally Generated Revenue, IGR in various states of the federal. We thank the President, the Minister and the Executive Vice Chairman of NCC and the media among all stakeholders. I think congratulations is in order to all who have fought this battle on our side since 2004" he added.

Also, President of the National Association of Telecoms Subscribers. The closest realization to the demand was in 2020, when President Muhammadu Buhari, approved and also directed that necessary physical protective measures be put in place to safeguard telecommunications infrastructure deployed across the country.

The Naira yesterday depreciated to N1, 615per dollar in the parallel market from N1,610 per dollar on Tuesday. However, the Naira appreciated to N1,543.84 per dollar in the Nigerian Autonomous Foreign Exchange Market, NAFEM. Data from FMDQ showed that the indicative exchange rate for NAFEM fell to N1,543.84 per dollar from N1,592.06 per dollar on Tuesday, indicating N48.22 appreciation for the naira.

The volume of dollars traded (turnover) in NAFEM rose by 12.8 percent to \$171.79 million from \$152.26 million traded on Tuesday. Consequently, the margin between the parallel market and NAFEM rate widened to N71.16 per dollar from N17.94 per dollar on Tuesday.
