

# Zamfara, Kaduna, Katsina lead in ransom payment to kidnappers - Report

### •SBM Intelligence says over N1bn paid in one year

ver N1.048bn have been paid as ransom to kidnappers between July 2023 and June 2024 in Nigeria, with states like Zamfara, Kaduna, and Katsina leading in its payment, a report by SBM Intelligence has said.

According to SBM Intelligence, an Africafocused market/security intel gathering and strategic consulting firm, the ransom demanded was N10.99bn.

The worsening security situation in Nigeria was further exposed in the report by SBM Intelligence, a market intelligence and security analysis firm, revealing that over 7,000 Nigerians were abducted across the country in the last year, with over N1bn paid as ransom.

The report highlighted the deepening security crisis, particularly in Zamfara,

Kaduna, and Katsina states, which have seen the highest numbers of kidnapping incidents and victims.

According to the report, 7,568 people were kidnapped in 1,130 incidents between July 2023 and June 2024.

"Nigeria's security crisis has become increasingly complex, with armed groups and non-state actors exploiting the state's weakened influence," SBM Intelligence noted in its analysis.

It identified various factors fuelling the crisis, including the resurgence of Boko Haram in the North-east, armed gangs in the North-central and North-west, secessionist violence in the South-east, and gang-related issues in the South-west.

It also revealed the rising lethality of kidnapping incidents, with 1,056 people killed during the 1,130 reported incidents. On average, one person is killed during each attempted abduction.

The report further stated that women were more frequently targeted than men in the recorded abductions.

Economic challenges in Nigeria are driving more people into kidnapping as a means of survival, according to the report. "As the country's economic challenges deepen and more individuals fall below the poverty line, more people have taken to kidnapping for ransom for survival," the report stated.

It urged the government to take urgent action to disrupt the financial flows sustaining these criminal activities.

Zamfara, Kaduna, and Katsina were identified as the most affected states, with Zamfara recording 132 kidnapping incidents involving 1,639 victims, Kaduna reporting 113 incidents with 1,113 victims, and Katsina with 119 incidents and 887 victims.

The three states also recorded the highest number of civilian deaths due to kidnappings.

The report highlighted the prevalence of mass abductions, with over 3,000 people kidnapped in 135 incidents from January to June 2024. The northern regions of the country were most affected by mass abductions, particularly in Zamfara, Kaduna, and Katsina.

In response to the growing kidnapping crisis, President Bola Tinubu has stated that the federal government will not pay ransom to kidnappers.

In March, Minister of Information and National Orientation Mohammed Idris reiterated the president's stance, emphasizing that no ransom would be paid to criminal elements. However, despite the government's position, many Nigerians continue to pay ransom to secure the release of kidnapped relatives.



he Senate has postponed its investigation into the alleged sabotage in the petroleum industry.

The Red Chamber cited the need to engage in more comprehensive consultations with stakeholders whose input and participation will add value to the conclusion of the investigative hearing.

The Senate Leader, Opeyemi Bamidele, the Chairman of the Senate Ad-hoc Committee to Investigate Alleged Economic Sabotage in the Nigerian Petroleum Industry, gave the reasons in a statement yesterday.

Bamidele also cited legislative exigencies aimed at further deepening due diligence in conducting the investigative hearing as another reason for postponing it.

The Senate set up the ad-hoc committee to investigate billions spent maintaining the nation's refineries.

It was also mandated to spotlight regulatory agencies regarding payment to transporters and unravel the alleged importation of hazardous petroleum products and dumping of substandard diesel into the country.

According to the statement, the ad-hoc committee had concluded its pre-investigation undertakings. It held an interactive session with the heads of ministries, departments, and agencies (MDAs) and some private interests in the downstream and midstream

petroleum sector.

After the exhaustive engagement with select MDAs and private oil firms, the ad-hoc committee subsequently scheduled its investigative hearing for Tuesday, 10th to Thursday, 12th September 2024

However, in his statement, Bamidele explained that the ad-hoc committee decided to postpone the investigative hearing after due

consultation with all its members and key actors in the petroleum industry.

He further noted that the ad hoc committee would communicate a new date for conducting the investigative hearing to all the stakeholders in due course.

Explaining the compelling reasons for the postponement. Bamidele noted that the decision was made in the best interest of the federation and its teeming population.

He further explained that the postponement became imperative considering the compelling need "to consult more widely with expanded stakeholders within and without the petroleum industry and legislative exigencies to deepen further due diligence in the conduct of the investigative hearing. "

He added that the prevailing realities in the country that demanded urgent interventions from nearly all the public and private sectors. Stakeholders across the 36 states and the Federal Capital Territory informed the resolution for the postponement.

Bamidele said, "While we deeply regret any inconvenience this decision may have caused all the stakeholders collectively or individually, it was taken purely and solely in the national interest."

He explained that each of these decisions was taken to enable the ad hoc committee to take a holistic approach to the public hearing and find lasting solutions to the challenges confronting the petroleum sector of the economy.

Bamidele, therefore, assured all the stakeholders that a new date for the public hearing would be communicated to them soon

### Gbajabiamila urges youths to support solutions to national problems

SERAP regretted that increasing petrol prices at a time when millions of Nigerians continue to face worsening economic conditions was entirely inconsistent with your government's constitutional and international obligations to ensure the minimum living conditions compatible with human dignity.

The group also stated, "The arbitrary increase has placed a disproportionate burden on the marginalised and most vulnerable sectors of society, particularly those disadvantaged by poverty.

their living conditions and individuals' physical, emotional, and individual development, intensifying and worsening socioeconomic conditions in the country.

"The increase constitutes a serious human rights problem because of the intensity with which it undermines the enjoyment and exercise by Nigerians of their human rights and renders their civic participation illusory.

"The fundamental right to life includes not only the right of every Nigerian not to be deprived of their life arbitrarily but also the right that they will not be prevented from antee a dignified existence.

"The growing poverty and inequality in the country has continued to adversely affect the right of Nigerians to participatory democracy and impede their ability to participate in their government.

"Persistent increases in petrol prices keep people in poverty, which in turn perpetuates discriminatory attitudes and practices against them. Your government is legally obligated to mobilise the maximum available resources to ensure people's socioeconomic rights and protect the most vulnerable and disadvantaged Nigerians."

Sulaiman said, "Since it was domiciled in the institute by the former Speaker of the 9th House of Representatives and the Chief of Staff to the President, Femi Gbajabiamila (CFR), the programme has continued to live up to its mandate of serving as a platform for enriching and nurturing the next generation of public sector leaders.'

Former First Lady of the Republic of Liberia and Secretary-General of the African First Ladies Peace Mission, Dr Jewel Howard-Taylor, who was Special Guest of Honour, urged the management of NILDS to extend the mentorship program to other West African countries.

As President Bola Tinubu's administration moves to contain the politics and economics of palliative administration in the country, officials need to make it easier to achieve good results.

The plank of the new problem arises from the difficulties encountered in making the rice component of the ambitious palliative control programme designed to contain the pangs of excruciating hunger in the land available to the citizenry at the 'advertised' price.

The Federal Government enacted the palliative measures to alleviate the burden and cushion the effects of the hardship on Nigerians after the removal of fuel subsidies and other economic policies to regulate the financial sector, particularly 'tax manipulation' and import duty regulation.

Recently, the Federal Government promised to create centres in 36 states of the Federation and the Federal Capital Territory (FCT) to sell 50kg (one bag) of rice at N40,000 to Nigerians.

Already, there are insinuations that these rice are either unavailable anywhere or the management is being wracked by corruption, among other issues.

2027, while other officials in charge of distribution are reportedly diverting them to their families and relations.

Apart from the contentious issue of availability and corruption, other problems relate to whether the government is even suitable to adopt the palliative distribution module as its strategy to contain hardship in the country.

In this spirit, ThisNigeria went to town to sample the scenarios and opinions of politicians, lawyers, analysts, farmers, economists, academics, and youths, who were nudged to bare their minds on the country's contentious issue of palliative administration.

An FCT resident and civil servant, Usman Kartum, criticized the government's use of palliatives and stipends to solve the hardship.

He described the approach as insulting to Nigerians' sensibilities because, according to him, it is not a long-term solution.

"In my own opinion, it's no, no, no. Fighting hunger and hardship by throwing palliatives

at Nigerians is insulting. Throwing grains and money at problems created by the people throwing the palliatives can never be the solution to the hardship and hunger in the country. It can't even be a temporary, long-term solution," Kartum said.

He said, "We know that our borders were closed because the government had 'invested' much in agriculture and didn't want the grains to be smuggled away. Even so, we have not seen the grains."

He also expressed disgust that the 50kg bags of rice promised by the federal government to be sold at N40k at specific centres across the country had yet to be released.

Kartum said, "Even if this is the way to go, how many Nigerians can access the so-called subsidised rice? How long will this continue? Would the government always be able to provide subsidized bags of rice because people must continue to feed?

"For me, anything that has to do with the government giving products to citizens is the highest form of insult, except if the products are farm produce or equipment for agriculture and educational materials."

Human and civil society rights activist, Sam Ogbeifun, also criticised the Federal Government for using palliative measures to alleviate hardship.

Rather than alleviating the problem, he said, "The present palliative distribution is a wrong step in the wrong direction. How can you create and solve a problem through an ad hoc policy that will not work?

"So, to be giving somebody palliative is an insult. That is meant for IDPs and refugees. You can only provide palliatives for people who are displaced. It's an insult to the nation.

Another legal practitioner, Emmanuel Ekwe, expressed dismay that the measures were cosmetic and the best money to proffer solutions to hardship.

A senior lawyer, Issa Manzuma, said when an economy finds itself in an inflationary trend, the government would always be compelled to devise a welfare package.

According to him, palliatives were justified in Section 14 of the 1999 constitution, which states that the government's primary responsibility is Nigeria's welfare and security.

A university lecturer and economic expert, Prof Peter Siyan, said the government should use palliatives as a short-term or temporary measure to assuage hardship.

"The use of palliative measures by the federal government of Nigeria to alleviate the burden of food scarcity can only provide temporary relief, but cannot serve as a long-term solution to the underlying structural issues causing food scarcity and economic problems," he said.

### Clark condemns Atiku's 'hypocrisy' over Yar'Adua family condolence visit

Elder statesman Chief Edwin Clark has expressed both sorrow and frustration following the death of Hajia Rabi Yar'Adua, mother of the late President Umaru Yar'Adua, who passed away at the age of 102.

In a statement of Tribute, Clark praised Hajia Yar'Adua for her wisdom and strength, having raised prominent figures such as Major General Shehu Musa Yar'Adua and Umaru Musa Yar'Adua. presidential election to Umaru Musa Yar'Adua, he continued to pursue court actions rather than accept the outcome out of respect for the family.

Clark expressed his disappointment, noting that despite his open letter to Atiku in 2007 urging him to "eschew all bitterness," the former vice president pressed on with his legal challenges, showing what Clark described as a lack of respect for his mentor's family.

Clark urged Nigerian political leaders to act with integrity and place the country's interests above personal ambitions.

He emphasised the need for politics to be conducted with morality and good conscience, particularly as Nigerians struggle with various societal issues.

While paying tribute to the Yar'Adua family, Clark also took the opportunity to criticize former Vice President Atiku Abubakar, accusing him of hypocrisy in his recent condolence visit to the family.

Clark recalled how Atiku had a long-standing relationship with the Yar'Aduas. Still, after losing the 2007 He berated Atiku for now leading a delegation to mourn Hajia Yar'Adua, claiming it was driven by political motivations rather than genuine sympathy.

"It is difficult for me to know where Atiku Abubakar stands in this matter," Clark said, questioning the former vice president's sincerity. He also accused other political figures of using the occasion to plot political gains rather than offering genuine condolences. On a lighter note, Clark also celebrated Nigeria's Super Eagles victory over Benin Republic, crediting the win with helping improve his health.

He highlighted solidarity as an example of national unity, regardless of regional or state differences, which he believes is the direction the country should move toward.

Clark's admonition reminded me of the enduring complexities in Nigerian politics, where personal relationships and political ambitions frequently collide. The Lead Director of the Centre for Social Justice (CSJ), Eze Onyekpere, said, "It is not a right to sit down and feed somebody with palliatives. According to the dictionary, palliative is not a cure; it is like a doctor has finished checking on a patient and says, you have a particular ailment.

"Then the doctor gives you a pain reliever to seduce or reduce the pains before surgery is carried out when the need arises. So, what Nigerians need are not palliatives but a cure."

# FOCAC: Wike signs MoU with two Chinese coys for light, water supply

inister of Federal Capital Territory, Nyesom Wike, has signed two Memoranda of Understanding (MoU) with two Chinese companies regarding solar lights and water supply.

The Minister attended the Forum on China-Africa Cooperation (FOCAC) in Beijing with President Bola Ahmed Tinubu.

In a statement by Anthony Ogunleye, Director of Press, Office of the FCT Minister, MoUs were signed on Saturday with the China Civil Engineering Construction Corporation, CCECC, and the China Geo-Engineering Corporation Overseas Construction (CGCOC) Group for lighting up the FCT, using solar power, and ensuring rural water supply.

While signing the documents during the FOCAC Summit, Wike said the selected projects would be completed across the FCT in time to celebrate its 50th anniversary of creation.

To explain the project, Wike also assured that "CCECC will handle the whole area of Maitama, the whole area of Asokoro, Wuse, Central Business Area, the Airport Road, down to Bill Clinton Drive, while CG-COC will handle the districts of Mabushi, Katampe, and Garki."

On the provision of water, Wike said, "And then again, we have gone further. You know the Greater Abuja Water Works, which is being handled by CGCOC and has been awarded for years ... has reached 75 percent completion. We believe that by the grace of God, by this December, or thereabouts, they would have completed it."

Regarding the need to ensure equal water supply in the satellite areas of the FCT, the Minister said, "The President said, look, you can't only provide for the city; you have to talk about the rural areas. So, we are keeping up with the idea that there is a need for a satellite town water supply in Gwagwalada, Kwali, and Kuje. We have signed the MOU with CGCOC so they can complete this assignment."

The Minister stressed that the projects, which would further ensure the FCT's development, were pushed by Mr. President at the FOCAC summit as part of his agenda to bring hope back to FCT residents.

Speaking on lighting up the city, he said, "One key project that is very dear to us and one of the reasons why we are here today is to light up Abuja because Abuja will be fifty years old by next year, so it should be a jubilee year for us. And we want Abuja to be like other cities, like what we see in Beijing. We have gone round and we have seen light everywhere, and that is how we want Abuja to be."

He also appreciated CGCOC's efforts to ensure the commercial operation of the Abuja Metro line became possible during President Tinubu's first-anniversary celebration.

The Minister said the completion of the project was a testament to the President's Renewed Hope Agenda, adding that the rail is operational due to the efforts of CCECC

While expressing appreciation to the President for granting the FCTA approval to embark on these significant projects for the FCT, the Minister urged the CGCOC to ensure quick delivery of the project and ensure that water supply in the satellite towns becomes a reality.

In their separate responses, the President of CCECC, Mr. Chen Sichang, and the Chairman of CGCOC, Mr. Lan Meizhong, both expressed appreciation for the confidence reposed in them to execute the projects while assuring the Minister of quality and timely delivery of the projects.

The signing of the MOUs is one of the fallouts of the just concluded summit on the Forum for China and Africa Cooperation held in Beijing, China.

President Bola Ahmed Tinubu visited CCECC during the summit and explored areas of cooperation with Nigeria.



### Households in FCT show resilience amid economic hardship **By Lucy Ogalue**

any households in the Federal Capital Territory (FCT) are adopting various measures to break even and survive the country's economic hardship.

The residents told the News Agency of Nigeria (NAN) that the economic hardship caused them to adjust their spending habits, explore new income streams, and develop innovative strategies to survive.

NAN reports that the country's economy has been challenging due to rising inflation, fluctuating fuel prices, and the depreciation of the Naira, among other challenges.

Many families are now compelled to prioritise essential needs such as food, healthcare, and education while reducing non-essential expenses.

A mother of three, Ebere Chinaza, said luxuries like dining out, vacations, and even some household items had taken a backseat as families focused on necessities.

"I have a permanent list of things I buy every month with N20,000 to N30,000, but now, I cannot buy all those items with even N60,000. We plan our meals carefully, and there is no room for waste. Sometimes, I even give my kids meals they do not like because that is what I can afford.

" It is regrettable because our income is not increasing, whereas the cost of living has steadily been rising," Chinaza said.

She prayed for the government and relevant authorities to quickly intervene and take measures to reduce the prices of food items for the good of the poor masses.

Also, Mrs Nguaverse Gondo, a civil servant, said with the job market becoming increasingly competitive, many Nigerians are exploring alternative income streams to supplement their earnings.

According to Gondo, side hustles, online businesses, and freelancing have become common ways for individuals to generate additional income.

Similarly, Mr Collins Paul, another civil servant, said "The prices of goods have increased, and we are now being forced to prioritise our basic needs.

# Restore subsidy, address corruption in NNPCL to solve 60% of our problems – Pat Utomi

A professor of political economy and management expert, Pat Utomi, speaks on the economic situation in the country, particularly the current fuel crisis. The former presidential aspirant under the platform of the African Democratic Movement in 2015 and staunch supporter of the 'Obidient' Movement' under the auspices of the Labour Party in the 2023 general elections said if he had the opportunity to become the president of Nigeria, he would return the fuel subsidy removed by the present administration and rescue the country from the economic hardship that the citizenry had been plunged into



### Did you see the recent outrageous fuel price increase announced last week by the NNPCL, which has fuelled fury and pain among the Nigerian populace?

This issue is more complex than seeing or not seeing it coming. When you get to this kind of situation that we have gotten into, you need a lot of planning. Earlier, we didn't do the right planning before the fuel crisis. We did not clarify our strategies. Consequently, we have run into serious problems.

First and foremost, the typecasting of what subsidy is all about has put us in a bend. I would probably have begun by trying to clean up the mess in the industry, the NNPCL. The NNPCL is one of the world's opaque and most unreliable organizations. I have been writing and talking about it for a whole generation. A good part of what we call subsidy was graft. There is what we call smuggling; if you look at how the numbers oscillate, how much we consume and then what we consume just before COVID-19, the numbers multiplied significantly when movements dropped under COVID-19. Then you will tell anybody serious that it is not because petroleum was consumed. There are statistics from governments in Pakistan, California, and Nigeria, where everybody has a car, regarding the ratio of what we consume. In Nigeria, we have plenty of vehicles. Note also that very few of the poor population have cars. I look at the units of petrol that they say we consume. Before we punish citizens by passing on inefficiency to them in private, we must clear up the corruption in the system; that alone will bring down the thing dramatically. You have to choose strategic use of resources.

consumption for pleasure and stuff like that, when people don't have to think about how they use their resources, you are not doing what is best for the system. We are stuck here because we should have dealt with the heart of the matter first.

### What should have been done?

First, if you had cleaned up the NNPCL and reduced the system's so-called corruption, more than 60 per cent of the problem would have been solved.

#### Is it too late to do that? Where would you start if you were given that job to do?

Nigerian border I can do it if I am given the job. I have been saying it for years. If you go to the World Bank and the IMF, they will throw policies at you with templates- no problem. It is a good understanding of economics. However, every situation is different. Let us go back to Asia during the financial crisis in 1997. One of the things I am hearing now is that Washington's tax-to-GDP ratio is terrible. They need to increase taxes dramatically. The average person in the Western world who pays those taxes has no other commitment besides themselves. The average Nigerian middle class is a social net that the country doesn't have. They pay school fees for x number of people, and the extended family depends on them. If your book doesn't come in taxes, then the person does not understand economics. How do you programme them and take them into account in computing? How do you change taxes and all of that? This is the kind of conversation you must put on the table. If you take the numbers that they throw at you from the NNPCL and they say, therefore, jack up prices, you will just be bothering overburdened people. When investments are not taking place, you need to free up money for savings and investments. People cannot save and invest; they are in a vicious circle going downward. We need a serious reflection on where we are, the processes, and what we must do first. There is a sequencing problem, but we are not managing it properly. That is why it is so hard on people.

speaking about this matter for the first time. The Vice President summoned the ministers, the NSA, the GM of NNPCL, and others to explain the issue. What is your take on this?

We really need to discuss the matter seriously and engage on it. Security is a critical issue. All the stories about the petrol on the Nigerian border are quite disturbing. With simple technology, you could see every car that uses Nigerian borders, not to mention petrol tankers. So, when they tell you this is how much petrol is consumed in Nigeria and this is how much is smuggled, it is a major security issue.

### Is there complicity?

If we want to deal with that, let's deal with it. We need to deal with security issues and the corruptions in the NNPCL to say to consumers, look, this thing is about output. Output doesn't justify anything for playing our role. We could introduce different kinds of public transportation and quality people with other forms of transportation. In 1984, I visited Zimbabwe for the first time. I had a classmate in the US. He was the Executive Director of Zipam, who was in public administration. We returned from the US and bought a lovely house, but he could not buy a car because the house was a priority then. But he later purchased a 1956 Morris Minor. During the day, on the weekdays, he would take a bus to work. On Sunday, he brought his Morris Minor and his family to church. If we have this kind of quality public transportation, fuelling it at this kind of level and subsidizing that kind of fuelling for the sake of the party, you would surely pay a different price for petrol. Let us not punish ourselves and shut out productivity possibilities from the resources that need to go to specific areas. That is what we are doing, and if it does not work, we need to talk and sort out this problem once and for all.

### Is removing subsidy a good idea?

Removing the subsidy was not a good idea. Sometimes, you need to drive production and quality of life at a certain level, so you commit to some level of subsidy. We know that agriculture is massively subsidized in America and Europe. But this is a subsidy that drives production and puts more money in the hands of people who produce, enabling the system to keep running. But when you massively subsidize

## Tragedy: Petrol tanker explosion kills 48 in Niger

Niger State has been left in a state of mourning after 48 people lost their lives following a petrol tanker explosion that occurred along Bida-Agaie-Lapai- road.

Director-General, Niger Emergency Management Agency (NEMA), Abdullah- Baba-Arah, who confirmed this in a statement in Minna yesterday, said the agency received a report of a deadly tanker explosion that occurred on Sunday at about 12:30 am along Bida-Agaie-Lapai highway. According to him, the scene of the disaster is two kilometres away from Dendo community in Agaie Local government Area.

He said the incident occurred when a petrol tanker loaded with petrol (PMS) collided with a trailer truck loaded with travelers and cattle from Wudil in Kano State en-route Lagos.

Baba-Arah said two other vehicles, a crane truck and a pickup van were also involved in the multiple incident.

He disclosed that over 30 people have been confirmed dead, with over 50 cattle burnt alive.

The director-general said the agency's 'Rapid Respond Team (RRT) and other 'Local Emergency Management Committees (LGEMCs)' were still at the scene of the incident.

He said that they were conducting search and rescue operations as more corpses were still trapped inside the illfated trucks. (NAN)

## Police probe death of 20-year old man in Lagos

He also said that the gunmen allegedly shot him many times on the head, stomach and leg till he died.

"After their evil act, they abandoned the body and took to their heels and escaped.

"Immediately after the police received the information, a team of anti-crime went to the scene and met one Vivian of the same address, who happened to be

the mother of the deceased. "She identified him as her son who lived with her at the same address.

"Photograph of the deceased was taken, the body was evacuated and deposited

at Mainland General Hospital Mortuary, Yaba for autopsy, " he said.

Hundeyin said that investigation was in progress while efforts were on to arrest the fleeing suspects.

# MOSOP warned against NNPC, Sahara Energy joint venture in Ogoni oil resumption

A South-south region group, the Movement for the Survival of the Ogoni People (MOSOP) has warned against any backdoor joint venture partnership between the Nigerian National Petroleum Company (NNPC) and Sahara Energy, saying it would not be acceptable to the Ogoni people.

It stated that any attempt to "foist Sahara Energy on the Ogoni people may lead to a major upheaval which will dampen MOSOP's current efforts at achieving a mutually beneficial settlement of the conflicts".

Its President, Fegalo Nsuke who made the position known at the end of a meeting with the leadership of the Council of Ogoni Leaders of Thought (COLT) at the weekend in Bori, Khana local government area of Rivers State warned against any manoeuvres to foist Sahara Energy on the Ogoni people and throw them into crisis.

"MOSOP rejects any backdoor move to transform the FTSA between Sahara Energy and the West African Gas Limited (WAGL, an affiliate of the NNPCL) into a Joint Venture operatorship. The Ogoni people have maintained that the financial and technical services agreement, FTSA, between Sahara and NNPC is not acceptable to us, and we will strongly resist any move by the NNPC to force Sahara Energy on us by any means whatsoever," Nsuke said.

He added: "We have laid down our conditions for a peaceful resolution of the Ogoni issue. The government should look into those demands and we are ready to make the necessary compromises on mutually beneficial terms"

He called on the government to immediately halt Sahara Energy's moves to enter into a joint venture agreement with the NNPC over OML 11 without the input and consideration of the position of MOSOP and the Ogoni people, noting that Sahara's penchant to force itself on Ogoni was a threat to the peace of the Ogoni and the Niger Delta region.

He said: "The position of MOSOP is critical in discussions on oil production in Ogoni because we stopped Shell's operations in the first place. Ogoni made enormous sacrifices to get Shell out of the fields. If the NNPC attempts to force Sahara Energy on us without consideration for our demands, it may lead to another phase of crisis.

"We will therefore strongly advise against any attempt to kill our people through some backdoor moves to force Sahara Energy on us without consideration for our position on the issue." He added: "We urge the Nigerian government to give peace a chance and accept discussions on the recommendations we have made in the interest of peace in our land. We do not want anything to take away our peace and the NNPC should spare us that trouble."

"We have proposed a pathway to address the Ogoni problem, and that option should be given a chance. Our proposal calls for the operationalization of the Ogoni Development Authority (the ODA)" he said.

Sahara Energy had, during the regime of President Muhammadu Buhari, entered an FTSA with WAGL in a deal that was not transparent and did not pass through due process. MOSOP rejected the move. Sahara later attempted to acquire OML 11 through the National Assembly and was blocked.

# SEC warn against infractions in capital market

A mid serious concerns, the Securities and Exchange Commission (SEC) has vowed to deploy the full weight of the law against individuals and entities that engages in activities contrary to laid down regulations in the capital market.

SEC Director General, Dr. Emomotimi Agama who stated this in an interview in Abuja weekend, said the Commission remain committed to protect investors including those in the crypto space even as he enjoined participants in the market to play by the rules.

Agama said, "We are certainly going to commence enforcement actions on anyone who wants to operate in this market and does not have the intention of being regulated, this also applies to those in the crypto space. We are sending this signal to all those that want to play by the books that they are welcome to our space. But for those that do not want to play by the books, of course we definitely will not allow them operate within our space".

The DG disclosed that the Commission has decided to take the recent step of issuing Approval-in-Principle to two crypto exchanges because it observed that Nigerian youths were becoming increasingly interested in the digital space.

He explained that base on the development, it was important to provide regulation, clarity and indeed the protection of investors which is its primary responsi-

### bility.

"All this we seek to do without hindering innovation because part of our primary responsibility as the SEC is market development and we are aware that Mr. President is very interested in youths and the activities of youths. Clearly, the majority of persons involved in this space are the youths. Therefore, it is no gainsaying that providing a regulated space for these individuals is a primary responsibility of the SEC. So we had to provide a guide, clarity and the knowledge it requires to put all of these things in place and that is why we have done what we did.

"It is important to understand that being the apex regulator of the capital market, we follow international guidelines and one of which is about disclosure. Full disclosure and making sure that they meet the Anti-Money Laundering and Combating the Financing of Terrorism reports, making sure that disclosures are made to investors and also education is important as well as a guided regulatory space" he stated

## NGX: Domestic transactions reach N2.49trn in seven month

The Nigerian Exchange Limited recorded a substantial rise in domestic transactions for the first seven months of 2024, totaling N2.498trn.

This figure significantly outpaced the N598bn in foreign transactions over the same period.

The information was disclosed in the NGX's July 2024 Domestic and Foreign Portfolio Investment report.

transactions on the NGX saw a significant 38.66 per cent increase, rising from N354.55bn (approximately \$241.06m) in June 2024 to N491.61bn (approximately \$305.02m) in July 2024.

However, a year-on-year comparison showed that the total transaction value in July 2024 represented a 30.07 per cent decline compared to the N702.98bn recorded in July 2023.

For July 2024, domestic investors ac-

According to the report, retail investors outperformed institutional investors by 26 per cent.

A comparison of domestic transactions in July and prior month (June 2024) revealed that retail transactions increased significantly by 138.48 per cent from N114.02bn in June 2024 to N271.92bn in July 2024.

Also, the institutional composition of the domestic market increased by 2.42 per cent from N158.34bn in June 2024 to N162.17bn in July 2024.







# Imperatives of non-oil export contributions to Nigeria's economic growth

Ver time, Nigeria's non-oil exports have exhibited massive potential for economic growth and development, given the robust foreign exchange earnings they have generated for the national treasury in years past.

Although expectations from the sector's contributions remain daunting, the impact reveals a readiness for economic diversification, signaling hope for increased revenues if proper attention is given by all concerned.

For example, figures obtained from the National Bureau of Statistics (NBS) show that in real terms, the non-oil sector contributed 94.52 per cent to the country's Gross Domestic Products (GDP) in the third quarter of 2023, higher than the share recorded in the third quarter of 2022 and lower than the second quarter of 2023 record of 94.66 per cent.

Similarly, figures recently released by the Nigerian Export Promotion Council [NEPC] indicate that Nigeria generated \$2.7bn from the non-oil sector in the first half of 2024, an increase of 6.26 per cent compared to the \$2.539bn recorded in the same period of 2023.

Also, a release by the Pre-shipment Inspection Agents (PLAs) clearly showed that of 15 products exported in the period under review, cocoa beans were the most exported commodity, with 23.18 per cent in percentage value, followed by urea-fertiliser, which was 13.78 percent, and sesame seeds, with 11.04 per cent of the total exported non-oil products.

The PLAs said a total of 211 products, ranging from agricultural commodities to extractive industries, were exported in the first half of 2024, indicating that Nigerian products are gradually diversifying from traditional raw agricultural exports to semiprocessed manufacturing products.

On job creation, NBS said the non-oil export sector has positively impacted unemployment reduction. Direct employment within the non-oil export companies alone is estimated at 200,000. In contrast, indirect employment in the agricultural industry, which gains from the market linkages provided by the exporting companies, is estimated at over 10 million.

Speaking at a forum in Abuja, the NEPC Executive Director, Nonye Ayeni, attributed the increase in the value of exported products in the first half of 2024 to a strategic achievement of the council's "Operation Double Your Exports." These results came to fruition through partnerships, advocacy, capacity building, and export intervention programmes, among other things.

Ayeni said it is pertinent to note that so many exportable products and their derivatives are progressively gaining prominence as demands for them are also gradually gaining prominence.

product exports.

"Thirty-two banks contributed to the non-oil export for the first half of 2024. Zenith Bank Plc led with 43.09 per cent of total exports for non-oil while First Bank Nigeria Plc and Fidelity Bank took the 2nd and 3rd positions with 6.56 percent and 6.38 percent, respectively," she said.

The NBS said that a critical look at the contributions of agricultural products to the economy also shows that Nigeria's cocoa exports rose by 304 percent in the period under review due to higher demand and naira depreciation.

It added, "A close look at elected agricultural export products speaks volumes as to why the non-oil exports contributions to the national economy cannot be overemphasized."

According to NBS, the country's cocoa exports, which accounted for 42.4 percent of the N1.04trn agricultural exports for the period under review, surged to N438.7bn in the first half of 2024 from N108.6bn in the corresponding period of 2023.

It also said that Nigeria exported \$14.8m worth of raw cotton, making it the 42nd largest exporter of raw cotton in the world. At the same time, raw cotton was the 65th most exported product in Nigeria.

"The leading destination of raw cotton exports from Nigeria are India (\$5.1m), Pakistan (\$3.65m), Vietnam (\$3.6m), Bangladesh (\$1.77m), and China (\$135m).

Corroborating the NBS figures on agricultural contributions, the President of the Cocoa Farmers Association of Nigeria [CFAN], Adeola Adegoke, said, "Cocoa has become an alternative to oil exports, and the government needs to protect and promote its cultivation, especially given the current economic challenges facing the country."



Adegoke explained that though the Federal government has inaugurated the National Cocoa Management Committee [NCMC] to tackle some challenges facing cocoa production, poor post-harvest processing practices by farmers need special attention.

For his part, renowned economics professor Sheriffdeen Tella stated that contributions from agriculture, manufacturing, and other services in the nonoil sector remain the way to go in terms of policy initiatives and implementation rather than relying more on crude oil revenues.

Tella lamented over the poor handling of the sector by successive governments.

He stressed, "Every government has been giving the impression that it is promoting the non-oil sector to improve contributions to Gross Domestic Product [GDP] from the sector, but experiences have shown that it has little to do with the production aspect but all about revenues. That is why whenever revenue from oil improves, production in the non-oil sector is ignored."

Despite its lofty contributions to the national economy, the non-oil export sector, like any other, is faced with several challenges that, according to stakeholders, need to be resolved as soon as possible.

Adegoke said, "Nigeria's non-oil export sector lacks an articulated export policy and limited access to finance. Infrastructure deficits, regulatory bottlenecks, and insufficient laboratories, all of which

"These include but are not limited to fresh vegetables, citrus peel, and Sorghum. While their contributions are still in the process of attaining significant levels, their regular inclusion on the export table suggests a growing presence in the export landscape; there are also a lot of potentials in services that need to be explored and harnessed, especially for logistics and ICT among others," she said.

The NEPC boss explained that of the top 20 exporting companies in Nigeria, Indoram-Eleme Fertilizer and Chemical Limited took the lead with \$198.8m, while Starlink Global and Idea Limited recorded the second-highest value of \$184.7m for agricultural Cocoa has become an alternative to oil exports, and the government needs to protect and promote its cultivation, especially in the current economic challenges facing the country have led to constant product rejects at international markets, are some of the numerous challenges facing the sector."

"Nigeria has not done well in global non-oil export trade as it ranked 52nd among nations; the country has not also done well domestically in terms of the share of the non-oil exports with the people," she added.

However, given the potential inherent in the sector, it has become necessary for stakeholders to take the bull by the horns by finding solutions to all the teething problems that have held the sector down for long so that the nation's dreams of economic diversification from oil revenues will be realized as quickly as possible and in the country's interest.

# NNPC indebtedness to suppliers not good image for Nigeria –Economist

n Economist, Dr Chijioke Ekechukwu has said the Nigerian National Petroleum Company Limited (NNPC Ltd.) indebtedness to fuel suppliers was not good for the country's credit rating globally.

According to him, the chaos the debt may cause could be devastating to Nigeria's already fragile economy.

Ekechukwu, the Managing Director/ Chief Executive Officer, Dignity Finance and Investment Ltd. disclosed this in an interview yesterday in Abuja.

The NNPC Ltd. had recently acknowledged that its \$6 billion debt to petrol suppliers was a financial strain that has placed considerable pressure on the company and poses a threat to fuel supply sustainability.

Reacting to the development, Ekechukwu said for the credibility and credit rating of Nigeria in the global arena, the NNPC Ltd. should as a matter of urgency and necessity find a means of paying their creditors.

He said the NNPC Ltd. should not be seen to be defaulting in its obligations to contractors.

"The chaos that may be caused by NNPC Ltd. continuously owing these suppliers may be very devastating to our already fragile economy and state of affairs. It makes a mockery of the so-called profit declared.

"However, it can still have and still make a profit. Such liabilities should be considered before declaring profit," he said.

### Electricity consumers decry transfer to Band A, say supply inadequate

lectricity consumers in the Federal Capital Territory (FCT) have decried the transfer of their electricity tariff to Band A despite not having 20 hours power supply.

Some of the consumers, who reside in Kubwa, Lugbe, and environs spoke in Abuja yesterday.

According to them, they are shocked to see themselves in Band A without any notice from the Abuja Electricity Distribution Company (AEDC).

Band A customers are those who receive at least 20 hours of electricity supply daily and are expected to pay N209.5 Kilowatts (KWh) per hour.

Band A services when I hardly get a power said. supply for 10 hours a day?

"Why are some consumers in the same Kubwa still buying at the old rate? I don't understand AEDC anymore. The company should look into this issue seriously because it is not right to be collecting money for services not rendered," she said.

Mr Mathew Ojei, who also resides at Kubwa, said he experienced the same thing as he recharged N2,000 but was given just 8.2 units, adding that he was not on Band A and if AEDC was putting consumers in that area on Band Å, they should give them the services required. "I am not on Band A, why am I paying so much for electricity when I don't enjoy up to 20 hours a day power supply?" he asked.

Another resident, Mrs. Osas Iwinosa said she recharged  $\square 5,000$  and was given 22.2 units, adding that when she saw the units and inquired from her neighbours in the same compound if they were now on Band A, they said they were still buying the old rate.

Also, a consumer residing at Lugbe, Mrs Omolara Taiwo complained of the same movement to Band A, saying she did not understand why some people are on Band C and others in the same compound are forced to Band A.

She said AEDC should look into the issue, adding that it was not fair on those paying higher tariffs than others and having the same number of hours of power supply.

### Petroleum pricing, Dangote 'll not guarantee lower prices, -NNPCL

The Nigeria National Petroleum Company Ltd (NNPCL) at the weekend said there was no guarantee of lower prices as it set to begin lifting petrol from the Dangote refinery.

In a statement by its spokesman, Olufemi Soneye, the company said the pricing of petroleum products from any refinery, including the Dangote Refinery Ltd, would be determined by global market forces.

Soneye, who is NNPCL's Chief Corporate Communications Officer, said there was no guarantee of lower prices associated with domestic refining of the products in the country. "The pricing of petroleum products from any refinery, including the Dangote Refinery Ltd. (DRL), is determined by global market forces," he said.

His response came amid rumours that the company was attempting to monopolise the offtake of all products from the Dangote Refinery Ltd.

"The attention of the NNPC Ltd has been drawn to a press release by the Muslim Rights Concern, MURIC, which claims that the Dangote Refinery Limited (DRL) is being undermined by actions of the Nigerian National Petroleum Company Limited (NNPC Ltd).

"Specifically, MURIC asserts that recent changes to the pump price of Pre-mium Motor Spirit (PMS) will prevent the Dangote Refinery from offering lower prices and that NNPC Ltd. has become the sole off-taker of all products from the refinery," he stated.

Meanwhile, the NNPCL said Premium Motor Spirit or petrol from the Dangote Refinery would begin to flood the market from September 15, 2024.

Soneye, who quoted the NNPCL's Executive Vice President of Downstream, NNPC Ltd, Adedapo Segun, said the downstream sector had been fully deregulated, and the company would no longer fix prices.





hina has applauded Nigeria's leading role in the Economic Com-munity of West African States (ECOWAS), especially the country's efforts toward enthroning stability in the sub-region.

It affirmed that China and Nigeria would make joint efforts to fully support Nigeria's geographical and development advantage in West Africa.

The statement explained that such a diplomatic approach was to establish Africa's flagship projects on cross-national and cross-regional cooperation.

"China supports Nigeria to play a strong leading role in the region's affairs, including the fight against terrorism and managing differences.

"China appreciates the efforts of Nigeria in enhancing regional peace and solidarity and promoting regional integration, with a strong emphasis on respecting democracy, good governance, and the

#### rights of citizens.

"China supports the West African countries' efforts toward addressing their differences through friendly dialogue and consultations and to carry forward the regional integration.

It added that the two sides agreed to remain committed to safeguarding peace, security, and stability in the ECOWAS sub-region, including the Sahel and Gulf

### Algeria presidential election sees low turnout as Tebboune poised for victory

ess than half of Algeria's eligible voters cast a ballot in the coun-try's presidential poll, preliminary figures from electoral authorities showed early Sunday, despite incumbent Abdelmadjid Tebboune's hopes for a high turnout.

Tebboune, 78, is heavily favored to secure a second term, seeing off moderate Islamist Abdelaali Hassani, 57, and socialist candidate Youcef Aouchiche, 41.

His main challenge was to increase the voter participation level in Saturday's vote after a historic abstention rate of over 60 percent in 2019, the year he became president.

More than 24 million Algerians were registered to vote this year, with about a third under the age of 40.

Electoral board ANIE announced early yesterday an "average turnout" rate of 48 percent but did not provide the total number of people who cast a ballot.

ANIE said the figure was "provisional", adding that it would give an official turnout rate later yesterday along with the election's results.

The announcement came three hours behind schedule after the election board said at the weekend that it was extending voting by one hour, expecting more voters to show up.

"Voters wondered what was the point of voting when all predictions are in favor of the president," said analyst Hasni Abidi, calling the candidates' bids "mediocre".

He said Tebboune "barely did four rallies", while his challengers "weren't up to the task".

"Not voting does not mean political opposition," he added. "Rather, it means people did not see themselves as part of the electoral game."

Both of Tebboune's challengers had called for a large turnout Saturday morning.

"Today we start building our future by voting for our project and leaving boycott and despair behind us," Aouchiche said on national television after voting.

Ethiopia warns against invasion amid regional tensions

thiopia's Prime Minister has warned that anyone planning on invading his country should "think 10 times" before doing so because, he said, any attack would be repelled.

Abiy Ahmed did not direct his comments at any particular nation, but they come at a time of rising tensions with neighbouring Somalia and Egypt.

Somalia has described a maritime pact that Mr Abiy's government signed with the self-declared republic of Somaliland in January as an act of "aggression" and has responded by forging closer military ties with Egypt.

Somaliland broke away from Somalia more than 30 years ago, but Mogadishu regards it as part of its territory.

Egypt has been involved in a long-running

# Thousands in Israel turn out to demand hostage deal

ens of thousands of people demonstrated in Tel Aviv and other Israeli cities for an agreement to release around 100 hostages held by Palestinian Islamist Hamas at the weekend.

"We must not sacrifice any more lives; we must not sacrifice them [the remaining hostages]," said a relative of a hostage who died last week, at the Tel Aviv rally.

Carmel Gat, another woman, and four men were shot at close range last week, according to Israel's Health Ministry, after Israeli soldiers found their bodies last Sunday in a tunnel in Gaza.

"The six would be here with us today if IIsraeli Prime Minister Benjamin Netanyahu had said yes to a deal," Gat's relative called out to the crowd, sorrow and anger in her voice.

On October 7 last year, militants from Hamas and other extremist Palestinian organisations invaded southern Israel, killing more than 1,200 people and taking some 250 others as hostages into Gaza, an unprecedented massacre that

triggered the Gaza war. According to Israel, Hamas is still holding 101 people, although it is unclear how many of them are still alive.



Tens of thousands of people demonstrated in Tel Aviv

Indirect negotiations for their release, mediated by the US, Egypt, and Qatar, have been stalled for months.

Negotiators seek to bring about a deal that also ends the war and includes the withdrawal of the Israeli military from the Gaza Strip and the release of thousands of Palestinian prisoners from Israeli jails.

Critics accuse Netanyahu of obstructing the conclusion of an agreement by making excessive demands such as to permanently station the Israeli military at strategic points in the Gaza Strip.

Netanyahu heads a coalition with farright parties who oppose any concessions to Hamas and threaten otherwise to withdraw which would lead to a collapse of the government alliance.

There were further demonstrations in Jerusalem, Haifa, Beersheba, Nahariya, and Caesarea, according to media reports.

### BBC rejects claim it breached guidelines 1,500 times with Gaza coverage

The British Broadcasting Corporation (BBC) has strongly denied an accusation that it has breached its guidelines more than 1,500 times in its coverage of the Israel-Hamas war.

Claims of "worrying" anti-Israel bias had been made in a report led by lawyer Trevor Asserson.

The report alleged that some BBC correspondents had excused and downplayed Hamas' activities, while contributors used by the corporation were sympathetic to the group.

Mr. Asserson's team analysed coverage of the four-month aftermath after the October 7 massacre, which saw Hamas kill around 1,200 Israelis and take 250 hostages.

Researchers found that Israel was associated with the term "war crimes" four more times and "genocide" over 14 times more than Hamas in BBC coverage. The report concluded that there were 1,553 breaches of editorial guidelines.

"The findings reveal a deeply worrying its correspondents were achieving impattern of bias and multiple breaches by the BBC of its own editorial guidelines on impartiality, fairness, and establishing the truth," the report said.

A spokesperson for the BBC said the corporation would "carefully consider" the research but denied claims of bias and questioned the researchers' methodology.

The research, which involved lawyers and data scientists, used artificial intelligence (AI) tools to look at nine million words of the broadcaster's output.

A BBC spokesman said: "We have serious questions about the methodology of this report, particularly its heavy reliance on AI to analyse impartiality, and its interpretation of the BBC's editorial guidelines.

"We don't think coverage can be assessed solely by counting particular words divorced from context.

The broadcaster also said it believed



partiality "despite the highly complex, challenging, and polarising nature of the conflict".

The spokesman added: "We strongly reject the claims that our reporters 'celebrated acts of terror' and we strongly reject the attack on individual members of BBC staff, all of whom are working to the same editorial guidelines."

Mr. Asserson said the BBC had "showed a clear partiality towards one side", adding that it was "even more pronounced in the BBC's Arabic content".

The full report is set to be published today with the Campaign for Media Standards. The bulk of the research was carried out pro bono by Mr. Asserson's law firm, Asserson Law Offices, which has offices in the UK, the US, and Israel.

The National Jewish Assembly and the Campaign Against Antisemitism said there should be an independent review of the broadcaster's coverage of the conflict.

Gideon Falter, chief executive of the Campaign Against Antisemitism, said "the BBC's ideological bias is now shamefully clear".



### Venezuelan opposition leader flees to Spain for political asylum

ormer Venezuelan opposition presi-dential candidate Edmundo Gonzalez has fled into exile after being granted asylum in Spain. The move is a major blow to the United States-backed opposition.

Venezuelan Vice-President Delcy Rodriguez announced his departure late over the weekend

She said the government had decided to grant Mr Gonzalez safe passage out of the country, just days after ordering his arrest, to help restore Venezuela's "political peace and tranquillity."

Neither Mr Gonzalez nor opposition leader Maria Corina Machado have commented.

Spain's socialist government said the decision to abandon Venezuela was Mr Gonzalez's alone and he departed on a plane sent by the country's air force. "Spain is committed to the political rights and physical integrity of all Venezuelans," Foreign Minister Jose Manuel Albares said on Twitter.

Recent research of BBC coverage by academics Mike Berry of Cardiff University and Greg Philo of Glasgow University suggested that Israeli arguments were given more prominence than Palestinian ones.

Their study of four weeks of BBC One coverage in the first four weeks since the October 7 massacre found that "murder" or words associated with murder were used 52 times by the broadcaster's journalists to refer to Israeli deaths, but such words were not used at all in relation to Palestinian deaths.

Venezuelan Attorney General Tarek William Saab sought Mr Gonzalez's arrest after he failed to appear three times in connection with a criminal investigation into what the government considers an act of electoral sabotage.

Mr. Saab told reporters the voting records the opposition shared online were forged and an attempt to undermine the national electoral council.

he National Drug Law Enforcement Agency (NDLEA) yesterday said it has intercepted a consignment of cocaine and pharmaceutical opioids at three courier firms in Lagos. It also destroyed over 100,000 Kilogrammes of Cannabis Sativa, otherwise known as Indian Hemp, in Ekiti forest.

Its spokesperson, Femi Babafemi, who disclosed this in a statement yesterday in Abuja, said the drugs were concealed in ladies' sanitary pads and hair treatment cream containers.

He added that the consignments were heading to the United Kingdom, Ireland, and Cyprus respectively.

In one of the logistics companies, Babafemi said, not less than 30 parcels of cocaine weighing 1.1 kilogrammes were concealed in hair cream containers.

"They were recovered by NDLEA officers of the Directorate of Operations and General Investigation, (DOGI), during an examination of cargoes going to Ireland on Tuesday, September. 3

"Another consignment of 24 parcels of cocaine weighing 862 grams also hidden in hair cream containers meant for delivery in the United Kingdom was equally intercepted at the same company on Friday, September 5.

In the same vein, he said a total of 525 pills of tramadol 225mg and ecstasy (MDMA) concealed in ladies' sanitary pads going to Cyprus were seized at another courier firm in Lagos by the drug law operatives on Tuesday, September 3.

Meanwhile, a shipment of 200 ampoules of promethazine injection and pentazocine injection hidden in food items and herbs heading to London, UK, was also seized by operatives on Wednesday, September 4

"Operatives equally intercepted another consignment of tramadol 225mg buried in granulated melon that came from Cameroon and was going to South Africa on Friday 6th September," he said.

In another development, no fewer than 550.000 pills of tramadol were also intercepted at the Port Harcourt International Airport, (PHIA) Port Harcourt on Monday,

#### September 2.

According to Babafemi, the tramadol pills were seized during a joint examination of a cargo that came from Delhi, India, with men of the Nigerian Customs Service. "A suspect was already arrested in connection with the seizure," he said.

The Agency also said it destroyed over 100,000kg of cannabis spread across 51 hectares of farmland in Ekiti State.

Babafemi said the NDLEA operatives, supported by men of the Nigerian Army on September 3 and September 4 stormed three camps inside the Ise-Ekiti forest reserve, in the Ise/Orun Local Government Area of the state.

The affected areas, he said, included Aba Saalaja with 23 hectares; Aba Paanu with 12 hectares, and Aba Arogunmatidi with 16 hectares, all within the Ise-Ekiti forest reserve, adding that two suspects were arrested on the Toro-Jos Road, Kaduna, with 305kg cannabis (Indian hemp) concealed in a false compartment of a J5 boxer bus marked YLA 682 XM.

Another suspect, Babafemi said, was ar-

rested in possession of 18 kilogrammes of the same substance at Makarfi town. "Two other suspects others: were arrested on the Zaria- Kaduna highway in possession of 1300 tablets of Tramadol, all the same day," he said.

Also, in Jigawa State, Babafemi said a 30-year-old man was nabbed with 32.6kg of cannabis (Indian hemp) on September 5 at Koran Shehu, adding that operatives in Kogi on September 4 intercepted 77,300 pills of Tramadol, Diazepam and Exol-5 with 1,230 bottles of Codeine in a commercial bus driven by Attai Okolo, 68, along Aloma - Ejule road, Ofu Local Government Area of Kogi State.

"Another was nabbed on the Okene-Lokoja-Abuja expressway on Tuesday, September 3, with 42.400kg cannabis (Indian hemp) coming from Lagos en route Kano.

"NDLEA operatives in Borno arrested a 40-year-old man at Ramat area of Maiduguri on Thursday, Sept. 5 with 13,100 pills of Tramadol.

"Also, operatives in Kano on Sept. 4 nabbed a man with 25.8kg cannabis and 3,000 pills of Diazepam along Kano - Dau-

ra Road," he said.

The NDLEA spokesman said that no fewer than 87,790 pills of Tramadol were recovered from Musa Adamu, 30 when he was arrested in Zing, Taraba State.

Babafemi said a raid on the home of a drug kingpin, Mayowa Abayomi Awe (a.k.a Bishop) in Ilesa, Osun state on September 4 led to the seizure of 43grammes of crack cocaine, 23grams of Methamphetamine, 17.126kg cannabis and a locally made pistol.

### Man, 55, drowns in Hadejia River

The spokesperson, Nigeria Security and Civil Defence Corps (NSCDC), Jigawa Command, Mr Badaruddeen Tijjani, who confirmed the incident in a statement yesterday in Dutse, said the incident occurred over the weekend at about 9:45 a.m. when the deceased went swimming in the river.


"One Sulaiman Potiskum aged 55, lost his life in a river located at Gada, Bakin Kogi area of Hadejia. The tragic incident occurred when the deceased attempted to take his bath along the riverbank, but was overwhelmed by the wave," he said.

Tijjani said the Corps' search team and local divers rescued the man, adding that he was later confirmed dead by medical personnel at the Hadejia General Hospital, adding that the remains of the deceased had since been handed over to his family for burial.

Awoyinfa made this disclosure during the 10th Anniversary Lecture organised by the former staff of The Sun Newspaper and Concord media allies of the duo iconic legends in the media profession.

"This is a promise I have made, and nothing will alter it. The book I authored after Dimgba passed away bore his name as co-author. All other books I am working on will bear his name as co-author, except if such work is my biography or personal book, then his name will not be included," he disclosed.


The former defunct weekend Concord editor disclosed that life had remained unchanged since Dimgba's passing.

"Oh, life without Dimgba Igwe is solitude, full of pains and unending grief.."

"How are the mighty fallen! Tell it not in Gath, publish it not in the streets of Ashkelon, lest the daughters of Philistines rejoice, lest the daughters of the uncircumcised triumph," as he alluded to the Book of II Samuel chapter 1:19-21 to convey the message of the painful loss of his dear friend over these past 10 years.

Awoyinfa, who miraculously survived a life-threatening sickness, said God, in His infinite mercies, preserved his life, noting that he would have gone to meet his



friend in the great beyond.

The matriarch of the Igwe family, Mrs Obioma Dimgba, was full of thanks to the Almighty God, whom she claimed had been the family's pillar since her beloved husband's death.

She also commended Awoyinfa as a dependable ally who never abandoned her family, even after her husband's death.

One of the closest associates of the late Dimgba Igwe, Femi Adesina, the pioneer editor of The Sun Newspapers, referred to Igwe as a boss and a friend.

Continued from page 9 it? Are we between the hard places of the rock, the sea, and the devil? Where are we exactly?

We are in all of those. We made some very terrible mistakes. We've got to work and walk our way back. But how do we act when public officials are seen as plugging? We've got to show dramatically that the public sector and the leadership have erred in their flagrant abuse of the public treasury. Then people will say, all these people have shared these loads. Again, I will give examples of President Obasanjo coming down to Peugeot 504. Oil prices dropped in 1976 or thereabout. We cut our coats according to our clothes. Public officials live in homes paid for by the public and power 24/7 and fly new jets. We need to say no to this. We have to come together as a society and say our country has done things with the wrong policies. We have to rebuild. This is how we rebuild- this is how we can sacrifice. You go out there, get 1,000 new buses of different qualities, put them out there, and park your car. I have seen Nigeria go through phases. When I was growing up, there was a time when Lagos was so congested that people were not allowed to drive into Lagos Island. You parked your car at Orile-Iganmu or somewhere and entered the Island as big man. These are the kinds of things we need to do now. Collective shielding- coming from the top. First, it must be the top. Shed all



that we have repeatedly made. Look at the kind of National Assembly that we have. Look at the behaviours of the executive class. The political class needs to come out publicly and make a public confession before the country. In South-East Asia, people would come out and do a humiliating bow for what the public had suffered due to the irresponsibility of the political class in Nigeria.

#### Is this a joke?

It is not. Please don't joke about it because it is also a solution and because people feel disconnected from the political class. That is a major solution. Once people start feeling connected, we solve the problems. we produce that will help us rebuild? If it is something that will help us to produce and rebuild, then I would subsidize. If it made us consume frivolously, I would not do that, but I will give an example. There was a time when an American president used to run around in a Volkswagen Beetle. That was a show of commitment. Let our politicians not think that, oh, befitting. Befitting what? Public resources are limited and must be treated as something people have in short supply. They must be managed primarily and promptly by the political class.

If you bring back subsidy, will it reduce inflation or rewind prices of commodities that are skyrocketing?

out. Some call it professional risk, while others refer to it They said, right from the day he took up the appointment as job threat. However, the generally adopted title for such professional problems or obstacles that occur in the course of duty is, occupational hazard. These hazards are classified into categories that vary according to the nature of the job. It can be biological. It can be chemical. And sometimes, it is a physical hazard. No matter the nature or type, it always comes with a consequence, the consequence of setback.

Up until yesterday, Saturday, 07/09/2024, Ajuri Ngelale was the Special Adviser to President Bola Ahmed Tinubu, on Media and Publicity. But, effective from that yesterday, he announced that he was proceeding on "an indefinite leave of absence from office". Although Ajuri had solicited the cooperation of everyone, to accord him the respect of privacy, in order to permit him pay attention to pressing family health challenge, by virtue of the position he held, and the volume or magnitude of attention it carries, such privacy may not necessarily come, particularly from his colleagues in the media, one of whom is, yours truly. Being a journalist, and having served at the Presidency, the peak of political interest, it would be extremely naive of him, to forget the action of paparazzi, whose assignment, mostly freelance, is to aggressively pursue celebrities for the purpose of taking candid photographs. And regardless of the situation, or the delicate nature of Ajuri's problems, a paparazzi is primarily obligated to the calling of his assignment, which is sensationalization. Yes, theirs is to present information in a way that tries to make it as shocking, or exciting as possible. And they often do it with photographs.

Indeed, no sooner than Ajuri's appeal came out, and despite the time he spent explaining how he sent the memo of his resignation to the office of the Chief of Staff to the President, alongside his plea for privacy, some of his colleagues, commenced communicating with conflicting contents. Some said they have carried out some checks, and the checks have revealed the reverse of what Ajuri wants the public to swallow, as his reasons for exiting the Presidency.

on 31st July, 2023, his reign was faced by turbulent attacks from some members of the cabal that are very close to the President, President Bola Ahmed Tinubu. This means, contrary to his submission, Ngelale did not resign. He was fired. By definition, he was dismissed. He said he resigned, to earn the sympathy of the public, but some of his colleagues have put out a hostile story to rubbish him. That is a jeopardy, and it falls in line with the meaning of occupational hazard.

Indeed every profession has its job hazards, but I think, probably because I am more familiar with it, public relations advisers, pollsters, or media consultants, particularly those working with high profile politicians, suffer the hazard of humiliation most. This is because, while on the job, they are made to sometimes develop, deceptive, or misleading messages as damage control, which are referred to as, spin doctoring. Yes, there is always the need for expert professional advisers at the heart of government, because government functionaries need to hear an alternative opinion to that of the civil service, especially from highly experienced media handlers. But on a number of cases, such spin doctors end up with terribly bad names. They are called experts in wheeler-dealing, shoot-from-the-hip political spin doctors, that earn a living from the taxpayers money.

And when the bubble bursts, they are clandestinely fired, while another one gets hired. That's an occupational hazard, to which many have suffered such fate at the Nigeria's seat of power, the Aso rock villa.

I don't envy whoever is coming next, because the job does not have a bed of rosses. It always carries the keg of political problems, that have adverse consequences on the title holder. # Paralympic Games: Oluwafemiayo grabs last day gold for Nigeria with new world record

Nigeria ended the 2024 Paris Paralympics games on golden note as Folashade Oluwafemiayo won the gold medal in the +86kg Para Powerlifting division yesterday.

Oluwafemiayo, who won the gold medal with a World Record lift of 167 kg, a 2kg improvement on the previous World Record held by her, left no one in doubt when she cleanly lifted 157kg, in her first attempt, an effort which is 7kg more than her closest challenger, China's Xuemi who lifted 150kg.

Oluwafemiayo lifted 162kg on her second attempt to equal the Paralympics record

in the event set by compatriots, Josephine Orji's 162kg.

She went on to break the record with a lift of 166kg to win the gold before she attempted the new record of 167kg.

It was a good ending to Nigeria quest at the games, going in the final day on Sunday hopes were high on the possibility of winning two gold medals but Loveline Obiji was disqualified in the up to 86kg in the morning session but Oluwafemiayo feat makes up for the sad disqualification of Obiji.

After 11 days of top competition, Nigeria powerful contingents of 23 Athletics won a

total of seven medals comprising 2 gold, 3 silver and 2 bronze medals.

The event which started on August 28 2024 comes to an end today, Sunday 8 September 2024 with a closing ceremony in France.

# A garbage in, garbage about educational system

The easiest and most attractive national pastime remains buck passing especially with the bunch of leaders that we have, that can hardly peel a banana nor wash an already white handkerchief. Not many of us want to take responsibility for anything, from personal, to family or national life.

The blame is on the system. We do not need to create demons out of our leaders because they are already specimens of demons, so we hang our sins on them appropriately and inappropriately too. And unfortunately, their behaviour has made it easy for the critic to descend on them.

We at most, talk, write and discuss the Nigerian myth with a sense of fatalism. If everyone thought as much as I did about justice and fairness, life would be better. I am a critic, but I am also the critics' critic, the unrepentant believer that the best way to keep the government on its toes is to keep harping on their flaws so they can improve.

Often, I say I believe the things I write on, are important for our nation as they are for other nations, but when it appears to me, Nigerians especially those in authority do not react to these issues as people in other lands do, I repeat them in new essays to remind old readers and recruit new ones to participate in the continuing dialogue.

Sadly, this is Nigeria where nothing works and no one cares, when it works, it is because someone's interest is about to be served or being served not the people's interest. We talk about our institutions despairingly. Our leaders do not watch network news except when their faces would be there on occasion of their sons/ daughters' wedding or such. They do not need the newspapers anymore because it is full of their lies, or paid adverts exchanging banters together.

Government bashing remains a national past time and every drinking joint, and suya spot has a sitting parliament with an expert on every and any issue but we forget that no matter the input, if the politicians and actors in our national scene have questionable lives both on personal and domestic level, nothing will change, the best government policy cannot change the individual. It is because the policies are formulated on a bad foundation and by people with warped thinking.

sitional exams, and let me say whether it is 18years, 0r 5 years, a dullard or an intelligent kid, it is garbage in, garbage out.

That may sound cold, especially in the light of the exploits of Nigerian graduates in other climes, remember I said other climes, and the few who do well here in Nigeria. Like my friend Ndo puts it, the quality is scarily dropping.

Have you noticed the ever increasing cases of graduates and interview candidates having shallow knowledge of the subject matter, poor command of the use of English language, poor knowledge of the examination techniques, as well disregard for correct interpretation of questions before attempting them.

Or that many candidates lack requisite mathematical and manipulative skills for subjects involving calculations, while handwriting of some are illegible and their answers scripts are full of spelling errors. (Not that my maths is so good either)

Many candidates try to cut corners by engaging in various forms of examination malpractice in order to obtain marks.

A good many of us spat on the education we had yesterday, and of course what passes for education today. And there is, certainly, a stratum of our society that looks back, nostalgically, at the quality of yesterday's education". How many of us today can argue that this is not the truth, even the generation that had its education in 2000 now looks back with nostalgia.

By and large, however, most of us believed that there was very much missing in the content of our yesterday's education. What we have today, in spite of innovations and the bold attempts to re-orientate it, remains, as it was yesterday, orthodox, slow foot, myopic.

Our educational system today only sharpens the head to near pin end quality and this is even rare but it also makes the possessors limb atrophied by long disuse. Our education is money centered. It is an education which goads the possessor asking "what can my country do for me?" to elevate the less privileged that surge him round, the answer is no. Today what is the value of the education given to a young man who lives or is doing his mandatory service year in a guinea worm infested area and yet is incapable of causing a revolution in the lives of the villagers by transforming their drinking water into healthy supply?

Please, what is the use of education given in physics to a young girl when the lights go out, she does not know what to do to get light again. In Nigerian education, how many graduates can carry aloft an oasis of light, very few because the education is short on quality and is therefore poor.

While there is despair, there is hope and despair, a case of "we can" or "we can't". While we battle the scourge of local terrorism, bad leadership, kidnap, health, and countless issues, there is need to come up with some measures that could help both the students and schools to improve on their output, by extension resuscitate a nation's dying if not dead educational sector.

Our students need to develop a good understanding of questions and also learn the basic rudiments of the English language for better and clearer presentation of their answers. The sex for grade, bribe for certificate syndrome needs to be checked.

There is a need to ensure the appropriate textbooks in all subjects are procured and studied side by side with the examination syllabus, and should be completed before the commencement of examination. Libraries need to go info-tech, not littered with books of 1914. While practical on-hands learning away from just examination should be incorporated.

There is a need to provide basic infrastructure, and a conducive atmosphere in schools, only qualified and committed teachers who will teach their subjects effectively and guide students to become exemplary in their studies should be employed. Not like the teacher in Bauchi State (SUEB) that inherited his grandfather's grade II certificate and was teaching with it or University dons that have become experts in plagiarism, selling handouts pirated from other works.

We must move away from the examcentric, conversation curriculum that takes away critical thinking and qualitative reasoning and educate with intention for a future world. If these and even more rigorous steps are taken, we may be saved the irony of the clowns we are churning out these days—May Nigeria win
